CLOSED EXTENSIONS OF THE LAPLACE OPERATOR DETERMINED BY A GENERAL CLASS OF BOUNDARY CONDITIONS

W. G. BADE AND R. S. FREEMAN

1. Introduction. This paper is concerned with the spectral theory of closed operators in Hilbert space determined by the Laplace operator and certain general boundary conditions. The method is that of J. W. Calkin [5, 6, 7, 8]. In this series of papers Calkin developed a theory of abstract symmetric boundary conditions in Hilbert space, and indicated how these general results might be applied to the Laplace operator and slightly more general operators on certain regions in the plane conformally equivalent to the unit circle. The boundary conditions there are of the type $\partial u/\partial n = Lu$, where L is an arbitrary, bounded, self-adjoint operator in $L_2(\partial G)$. The potential theoretic details necessary to apply the general results were given in Calkin's thesis, but not published elsewhere. were subsequently also obtained by J. W. Smith [21] (for the case of the unit circle), who studied cases where the operator L was unbounded. R. S. Freeman [12] extended Calkin's results to a general class of plane domains and obtained a method for treating unbounded domains in E^m , $m \geq 2$, once the results were known for bounded domains. In this paper we treat the case of a bounded domain in E^m with $C^{1,1}$ boundary. addition, we extend the method to cover the case for which the operator L in the boundary condition is not necessarily self-adjoint. unbounded domains is treated in another paper [13].

Following Calkin's method, we show there exists an appropriate linear class of functions $\mathcal{D}_1(G) \subseteq L_2(G)$ such that the operator S in the Hilbert space $L_2(G) \bigoplus L_2(\partial G)$ with domain

$$\mathscr{D}(S) = \{[u, \widetilde{u}] | u \in \mathscr{D}_{\mathbf{I}}(G)\}$$

and

$$S[u, \widetilde{u}] = [-\Delta u, \widetilde{u}_n], \quad u \in \mathcal{D}_1(G),$$

is self-adjoint. Here \widetilde{u} and \widetilde{u}_n are the values of u and $\partial u/\partial n$ on ∂G . If L is an arbitrary (not necessarily self-adjoint) bounded operator in $L_2(\partial G)$, then the operator $T_L = -\Delta$ on the domain

$$\mathscr{D}(T_{L}) = \{u \in \mathscr{D}_{1}(G) | \widetilde{u}_{n} = L\widetilde{u} \}$$

is closed, and T_L^* is equal to T_{L*} . It is shown that the spectrum of T_L is discrete and is contained in a parabola with horizontal axis and opening to the right. One of our aims is a precise determination of $\mathcal{D}_1(G)$. It

consists of the class of functions in the domain of the maximal operator associated with $-\Delta$ such that u and $\partial u/\partial n$ have L_2 boundary values. In potential theoretic terms it is the set of all sums p+h, where p is the potential due to a charge g in G and h is a potential due to a surface charge f on ∂G , where g and f are, respectively, square integrable over G and ∂G (Theorem 3.4).

Section 2 contains geometric preliminaries and definitions. Section 3 develops the potential theory necessary to define the S operator in § 4. In § 5 certain bounded perturbations of S lead, via a projection argument, to the properties of the operator T_L . The possibility that L is not self-adjoint leads to new difficulties not treated by previous authors. It should be remarked that Ohdnoff [20] has independently introduced the S operator for general second-order elliptic operators, utilizing the method of Friedrichs. He does not obtain its domain explicitly.

It follows from general results of Browder [2] and others, that when ∂G is C^2 and L is multiplication by a smooth function, then $\mathscr{D}(T_L) \subseteq W^{2,2}(G)$. It would be interesting to know whether $\mathscr{D}(T_L) \subseteq W^{2,2}(G)$, whenever L is an operator in $L_2(\partial G)$ with the property that Lf is at least as smooth as f.

- 2. Preliminaries. Throughout the paper G will be a bounded, connected, open set in E^m whose boundary is a $C^{1,1}$ surface. The boundary need not be connected, but will necessarily consist of a finite number of components. Points of G will be denoted by x, y, etc., and points of ∂G by θ , ϕ . At $\theta \in \partial G$, n_{θ} will be the *exterior* unit normal. We summarize first certain properties of such surfaces that we will need. They may be found in the systematic exposition of Lucas [18]. See also [1].
- 2.1. Theorem. If S is a $C^{1,1}$ surface, there exists a positive constant r_0 called the "minimal radius" of S, such that
- (i) All segments of length r_0 centered at points of S and normal to S are mutually disjoint and exhaust a neighborhood of S.
- (ii) At each point θ of S, spheres (exterior and interior) of radius r_0 can be found tangent to S at θ which contain no points of S.
- (iii) The normals to S satisfy a Lipschitz condition with constant r_0^{-1} :

$$|n_{\theta}-n_{\phi}| \leq |\theta-\phi|/r_0$$
, $\theta, \phi, \in S$.

(iv) The set

$$S_{\rho} = \{\theta - \rho \ n_{\theta} | \theta \in S\}$$

is a $C^{1,1}$ surface for $\rho < r_0$ with minimal radius r_ρ satisfying $r_0 - |\rho| \le r_\rho \le r_0 + |\rho|$. Such surfaces will be called "parallel surfaces to S."

(v) The surface measures on S and S_p are mutually absolutely

continuous with uniformly bounded Radon-Nikodym derivatives for $|\rho| < r_0/2$.

Let $\theta \in S$ and \mathscr{T} be the tangent plane to S at θ . Choose Cartesian axes with $t = (\xi_1, \dots, \xi_{m-1}) \in \mathscr{T}$ and positive ξ_m axis along the inner normal to S at θ . Let $\lambda(t)$, $|t| < r_0$, be the function representing S locally near θ . We shall need the following facts.

2.2. Lemma. There exist constants k_1, k_2 , and ρ_0 independent of θ such that

Proof. Statement (a) follows from (ii) above, while (b) follows from (iii). To prove (c) we note

which yields the desired result with $\rho_0 = 4^{-1} (k_1 + k_2)^{-1}$.

Next we shall need certain classes of functions on G. In the notation of Browder [3], $W^{n,p}(G)$ is the class of all functions in $L^p(G)$, $1 \le p < \infty$, all of whose distribution derivatives of order $\le n$ are functions of $L^p(G)$. It is a Banach space under the norm which is the sum of the L_p norms of all derivatives of order $\le n$. We shall be concerned only with the cases n = 1 and 2.

Let u be a function defined on the intersection of G with a neighborhood of ∂G . Let $\rho < r_0$ and $u_{\rho}(\theta) = u(\theta - \rho n_{\theta})$, $\theta \in \partial G$. Thus u_{ρ} is the restriction of u to the parallel surface at a distance ρ along the normal. If $u_{\rho} \in L_{p}(\partial G)$ and $\widetilde{u} = \lim_{\rho \to 0} u_{\rho}$ exists in $L_{p}(\partial G)$, we say u has the $L_{p} - boundary \ value \ \widetilde{u}$. It is known that every function in $W^{1,p}(G)$ has an L^{p} boundary value. (See for example [19].)

The following class of functions will be of basic importance throughout the paper.

- 2.3. DEFINITION. We denote by $\mathcal{D}_1(G)$ the class of functions $u \in L_2(G)$ such that
 - (i) u belongs to $W^{2,2}(G_1)$ for each open set G_1 whose closure lies in G,
 - (ii) $\Delta u \in L_2(G)$,
 - (iii) u and $\partial u/\partial n$ have L_2 boundary values \widetilde{u} and \widetilde{u}_n on ∂G .

Clearly, $W^{2,2}(G) \subseteq \mathcal{O}_1(G) \subseteq W^{1,2}(G)$. The inclusions are proper (as one sees, for example, by considering the case of harmonic functions in the unit circle). Conditions (i) and (ii) are the conditions that u should lie in the domain of the "maximal operator" corresponding to the Laplacian on G—that is, the adjoint of the "minimal operator" which is the closure of the Laplacian on C^{∞} functions with compact support.

It follows easily from Theorem 2.1 (v) that Green's identities hold for functions in $\mathcal{D}_{i}(G)$:

3. Potential theory. In this section we prove that the inhomogeneous Neumann problem

$$-\Delta u = 0$$
 , $\partial u/\partial n = k$ on ∂G

has a solution in $\mathscr{D}_1(G)$ whenever $k \in L_2(\partial G)$ and $\int_{\partial G} k(\theta) d\theta = 0$. This fact will be needed in later sections. The solution u will be a single-layer potential

The argument that for such potentials both u and $\partial u/\partial n$ have boundary values works equally well in L_p , 1 , and we present it in that generality for convenience of reference for a later paper.

If u is a single-layer potential with charge f in $L_p(\partial G)$, then

Let T_{ρ} be the bounded linear mapping of $L_{\rho}(\partial G)$ into itself which carries f into the function $(T_{\rho}f)(\phi) = (\partial u/\partial n)(\phi_{\rho}), \ \phi \in \partial G$. It is well known that when f has a continuous derivative

uniformly on ∂G , where ω_{m-1} is the volume of the unit sphere in E^{m-1} . Thus to prove that $\partial u/\partial n$ has an L_p boundary value, it suffices to prove that the maps T_ρ are uniformly bounded in $L_p(\partial G)$. Then the integral in formula (*) will determine a bounded linear map, and (*) will hold for all f in $L_p(\partial G)$. To prove the maps T_ρ are uniformly bounded, it suffices (cf. [9], page 518) to prove the existence of constants M and ρ_0 such that

Then $||T_{\rho}|| \leq M$, $\rho < \rho_0$.

We first prove (i). Let θ be any fixed point of ∂G and \mathscr{T} be the tangent plane to ∂G at θ . Choose Cartesian axes for E^m with origin at θ , $t = (\xi_1, \dots, \xi_{m-1}) \in \mathscr{T}$ and positive ξ_m axis along the inner normal at θ . Let $\xi_m = \lambda(t)$, $|t| < r_0$, be the $C^{1,1}$ function representing ∂G locally near θ . Then we have

for all small ρ . Combining this fact with 2.2 (a) and (b), we see

for all ρ less than a suitable ρ_0 , where C_1 and C_2 are constants independent of ρ and θ . The integral (with respect to t) of the right side is bounded independent of ρ over $|t| < r_0/2$; so therefore

if $\rho < r_0/4$ and $|\phi - \theta| > r_0/4$, it follows that $|N_{\rho}(\phi, \theta)|$ is uniformly bounded independent of θ if $|\phi - \theta| > r_0/2$. Thus (i) follows. The proof of (ii) is simpler. If we now take the tangent plane at ϕ instead of θ , $|\phi_{\rho} - \theta| \cos{(\phi_{\rho} - \theta, n_{\phi})} = \lambda(t) - \rho$, $t = P\theta$, and similar estimates apply. Thus we have

3.1. Theorem. Let 1 , and <math>u be the single-layer potential in G with charge f, where $f \in L_p(\partial G)$. Then u and $\partial u/\partial n$ have L_p boundary values \widetilde{u} and \widetilde{u}_n given by the formulas

The maps $B: f \to \widetilde{u}$ and $T: f \to \widetilde{u}_n$ are bounded linear maps in $L_p(\partial G)$.

The fact that $\partial u/\partial n$ has a boundary value implies the same for u, as one sees by an elementary estimate from the formula

The formula for \tilde{u} follows from the fact it is valid for C^1 functions.

3.2. COROLLARY. If u is a single-layer potential with charge in $L_2(\partial G)$, then $u \in \mathcal{D}_1(G)$.

3.3. THEOREM. Let $k \in L_p(\partial G)$, $1 , and suppose <math>\int_{\partial G} k(\theta) d\theta = 0$. Then there exists a single-layer potential with charge in $L_p(\partial G)$ such that $\widetilde{u}_n = k$.

Proof. It suffices by Theorem 2.1, to find a function f in $L_p(\partial G)$ which satisfies the integral equation

The Fredholm theory is applicable to this equation since an appropriate iterate of the kernel K is bounded (cf. the discussion in [22], Chapter XI and [11], p. 542). Thus equation (*) has a solution f if and only if $\int_{\partial g} k(\theta) \overline{l(\theta)} d\theta = 0 \text{ for all solutions } l \text{ in } L_q(\partial G), \quad p^{-1} + q^{-1} = 1, \text{ of the adjoint homogeneous equation}$

$$l(\theta) = \int_{\partial \theta} K(\phi, \theta) l(\phi) d\phi$$
.

It is well known that the constant functions are the only continuous solutions of this equation. However, any solution l also satisfies the equation obtained by replacing K by any of its iterates. Since an appropriate iterate is bounded, l is continuous and hence constant. Thus equation (*) has a solution if and only if $\int_{\partial a} k(\theta) d\theta = 0$.

Returning now to the case p=2, we seek a potential theoretic characterization of $\mathcal{D}_1(G)$. If $g \in L_2(G)$, the function

will be called the *space potential* with charge g. Since G is a bounded domain, p belongs to $W^{2,2}(G)$, and $-\Delta p = m \omega_m g$ almost everywhere in G. These facts may be derived from [4], pp. 130, 134. There the point-wise existence of the first two derivatives is established almost everywhere. Since they are given by formulas that define bounded maps in $L_2(G)$, it follows that $u \in W^{2,2}(G)$.

3.4. THEOREM. A function u belongs to $\mathcal{D}_1(G)$ if and only if u =

p + h, where p is a space potential due to a charge in $L_2(G)$, and h is a single-layer potential with charge in $L_2(\partial G)$.

Proof. If u has this form, then, clearly, $u \in \mathcal{D}_1(G)$. To prove the converse, let u be given in $\mathcal{D}_1(G)$ and let p be the space potential whose charge is $-(m\omega_m)^{-1} \Delta u$. Then $\Delta p = \Delta u$, and therefore v = u - p is harmonic and belongs to $\mathcal{D}_1(G)$. By Green's second identity, $\int_{\partial G} \widetilde{v}(\theta) d\theta = 0$; thus by Theorem 3.3 there exists a single layer potential w such that $\widetilde{w}_n = \widetilde{v}_n$. But then Green's first identity implies w - v is constant. However, the function 1 in G is a single layer potential. Its charge is the (normalized) solution of the homogeneous equation

$$f(\phi) = \int_{\partial \sigma} K(\phi, \theta) f(\theta) d\theta$$
.

It follows from the Riesz theory that the set of solutions is one dimensional (since this was the case for the adjoint equation).

We next consider the inhomogeneous Neumann problem.

3.5. Theorem. Let $g\in L_2(G),\ l\in L_2(\partial G).$ The equations $-{\it \Delta} u=g,\ \ \widetilde{u}_n=l$

have a solution u in $\mathcal{D}_{1}(G)$ if and only if

(*)
$$\int_{\sigma} g(x)dx + \int_{\partial\sigma} l(\theta)d\theta = 0.$$

Proof. Suppose condition (*) holds. Let p be the space potential with charge $(m\omega_m)^{-1}g$. Then $p \in W^{2,2}(G)$ and $-\Delta p = g$. By Green's identity.

$$\int_{\partial \sigma} g(x) dx + \int_{\partial \sigma} \widetilde{p}_n(\theta) d\theta = 0.$$

Thus $\int_{\Im g} [\widetilde{p}_n(\theta) - l(\theta)] \ d\theta = 0$, and therefore by Theorem 3.3 there exists a harmonic function v in $\mathscr{D}_{\mathbf{i}}(G)$ such that $\widetilde{v}_n = \widetilde{p}_n - l$. The function u = p - v solves the problem. Conversely, if u is a solution, formula (*) results from applying Green's identity to u and 1.

3.6. Theorem. Let $g \in L_2(G)$. The equations

$$-\Delta u = g$$
 , $\widetilde{u}_n = 0$

have a solution u in $\mathscr{D}_1(G)$ if and only if $\int_{G} g \, dx = 0$. The operator T_N in $L_2(G)$ with domain $\mathscr{D}(T_N) = \{u \in \mathscr{D}_1(G) | \widetilde{u}_n = 0\}$ and $T_N u = -\Delta u$ is self-adjoint. Moreover $\mathscr{D}(T_N) = \mathscr{N}(T_N)^{\perp}$, the null manifold consisting of the constant functions.

Proof. The first statement follows from the previous theorem. To prove the second, we recall that the method of Friedrichs [14] yields a self-adjoint operator F_N in $L_2(G)$ corresponding to $-\Delta$ and the boundary condition $\partial u/\partial n=0$ in ∂G . Explicitly, consider the closed semi-bounded form

$$D(u, v) = \int_{\sigma} \sum_{i=1}^{m} \frac{\partial u}{\partial x_{i}} \frac{\partial \overline{v}}{\partial x_{i}} dx$$

on the dense subspace $W^{1,2}(G) \subseteq L_2(G)$. Then $u \in \mathcal{D}(F_N)$ if and only if there exists an element $g \in L_2(G)$ such that

$$D(u, v) = (g, v)$$
, all $v \in W^{1,2}(G)$,

and $F_N u = g$ for $u \in \mathcal{D}(F_N)$. The range of F_N is closed and is the orthogonal complement of its null manifold, which clearly consists of the constant functions. Thus $\mathcal{N}(T_N) = \mathcal{N}(F_N)$, $\mathcal{R}(T_N) = \mathcal{R}(F_N)$ and $T_N \subseteq F_N$. However, if $u \in \mathcal{D}(F_N)$, then $F_N u = T_N v$ for some $v \in \mathcal{D}(T_N)$; therefore $F_N(u-v) = 0$. Thus $u = v + \text{constant} \in \mathcal{D}(T_N)$, showing $F_N = T_N$.

REMARK. It is known [2], that when ∂G is of class C^2 , then $\mathcal{D}(F_N) \subseteq W^{2,2}(G)$.

- 4. The S operator. In this section, following Calkin [6], page 435, we introduce the operator S in $L_2(G) \bigoplus L_2(\partial G)$. In the next section, certain bounded perturbations of S lead, via a projection argument, to closed linear operators in $L_2(G)$ corresponding to restricting $-\Delta$ by boundary conditions.
- 4.1. DEFINITION. In the Hilbert space, $L_2(G) \bigoplus L_2(\partial G)$ define the operator S with domain

$$\mathscr{D}(S) = \{[u, \widetilde{u}] | u \in \mathscr{D}_{\mathbf{i}}(G)\}$$

 \mathbf{a} nd

$$S[u, \widetilde{u}] = [-\Delta u, \widetilde{u}_n], \quad [u, \widetilde{u}] \in \mathscr{D}(S).$$

As we shall see, the theory of the S operator is intimately connected to the inhomogeneous Neumann problem of Theorem 3.5.

4.2. Theorem. The operator S is densely defined, closed, self-adjoint, and has compact resolvent.

Proof. To see that $\mathscr{D}(S)$ is dense in $\mathscr{H} = L_2(G) \bigoplus L_2(\partial G)$, suppose

$$([u, \tilde{u}], [v, l]) = (u, v) + (\tilde{u}, l) = 0$$

for all $u \in \mathcal{D}_1(G)$. Then (taking u = 1) we see

$$\int_{\theta} v \, dx + \int_{\partial \theta} l \, d\theta = 0 ;$$

consequently there exists $g \in \mathcal{D}_1(G)$ such that $-\Delta g = v$, $\tilde{g}_n = l$. Thus, using Green's formula, we have

$$(-\Delta u, g) + (\widetilde{u}_n, \widetilde{g}) = (u, v) + (\widetilde{u}, l) = 0, \quad u \in \mathscr{D}_1(G).$$

If we consider only those u such that $\widetilde{u}_n=0$, we can show that $g\in \mathscr{R}(T_n)^+$. It follows from Theorem 3.6 that g is constant. Thus v and l are zero.

Since $\mathcal{D}(S)$ is dense, S^* exists, and Green's formula shows $S \subseteq S^*$. Suppose now that $[w,j] \in \mathcal{D}(S^*)$. There exists an element [v,l] in \mathcal{H} such that

$$(S[u, \widetilde{u}], [w, j]) = ([u, \widetilde{u}], [v, l]), \quad u \in \mathscr{D}_1(G);$$

i.e.,

$$(**) \qquad (-\Delta u, w) + (\widetilde{u}_n, j) = (u, v)] + (\widetilde{u}_n, l), \quad u \in \mathscr{D}_1(G).$$

Thus (taking u = 1) we have

$$\int_{\theta} v \, dx + \int_{\partial \theta} l \, d\theta = 0.$$

Consequently, by Theorem 3.5 we can find $z \in \mathcal{D}_1(G)$ such that $-\mathcal{L}_{\alpha}^{r} = v$, $\tilde{z}_n = l$. By Green, again, we have

$$(-\Delta u, z) + (\widetilde{u}_n, \widetilde{z}) = (u, -\Delta z) + (\widetilde{u}, \widetilde{z}_n)$$

= $(u, v) + (\widetilde{u}, l), \quad u \in \mathscr{D}_1(G),$

and so

$$(-\Delta u, z - w) + (\widetilde{u}_n, \widetilde{z} - j) = 0$$
, $u \in \mathscr{D}_1(G)$.

Restricting attention to those u with $\widetilde{u}_n = 0$ shows z - w is constant. Thus $w \in \mathcal{D}_1(G)$, $-\Delta w = v$, and $\widetilde{w}_n = l$. Putting these facts in (**) and applying Green again, we obtain

$$(\widetilde{u}_n, j - \widetilde{w}) = 0$$
, $u \in \mathscr{D}_1(G)$.

One sees easily from Theorem 3.5 that there are functions u in $\mathcal{D}_1(G)$ for which \widetilde{u}_n takes arbitrary values in $L_2(\partial G)$. Thus $\widetilde{w} = j$. Hence $[w, j] = [w, \widetilde{w}] \in \mathcal{D}(S)$ and $[v, l] = S[w, \widetilde{w}]$, proving S is self-adjoint.

If $\mathscr{I}(\lambda) \neq 0$ and $(\lambda I - S)[v^k, \tilde{v}^k]$, $k = 1, 2, \cdots$, is a bounded sequence in \mathscr{H} , the sequence $[v^k, \tilde{v}^k]$ is bounded, since $(\lambda I - S)^{-1}$ is bounded. Thus

$$D(v^k, v^k) = (-\Delta v^k, v^k) + (\widetilde{v}_n^k, \widetilde{v})$$

is bounded and the v^k are bounded in $W^{1,2}(G)$. Since the maps $v \to v$ and $v \to \tilde{v}$ of $W^{1,2}(G)$ into $L_2(G)$ and $L_2(\partial G)$ are compact (cf. [19], p. 208), we can extract a sub-sequence of the $[v^k, \tilde{v}^k]$ converging in \mathcal{H} , showing $(\lambda I - S)^{-1}$ is compact.

- 4.3. COROLLARY. The range of S is closed, $\mathscr{R}(S) = \mathscr{N}(S)^+$, and $\mathscr{N}(S)$ consists of the constants $[\alpha, \alpha]$ in $L_2(G) \bigoplus L_2(\partial G)$.
- 5. Boundary conditions for $-\Delta$. We now proceed to the main results of the paper.
- 5.1. DEFINITION. Let L be an arbitrary bounded operator in $L_2(\partial G)$. Define the operator T_L in $L_2(G)$ with domain

$$\mathscr{D}(T_{\mathtt{L}}) = \{u \,|\, u \in \mathscr{D}_{\mathtt{I}}(G), \, \widetilde{u}_{\mathtt{n}} - L \,\widetilde{u} = 0\}$$
,
$$T_{\mathtt{L}} \,u = - \varDelta u, \,\, u \in \mathscr{D}(T_{\mathtt{L}}).$$

It will be shown that T_L is a closed linear operator with compact resolvent, and $(T_L)^* = T_{L*}$. Thus T_L is self-adjoint if $L = L^*$. These results will be proved by perturbation of the operator S and a projection argument.

5.2. DEFINITION. Let L be a bounded operator in $L_2(\partial G)$, and λ a complex number. The operators \hat{L} and $P(\lambda)$ are defined in $L_2(G) \bigoplus L_2(\partial G)$ by the formulas

$$egin{aligned} \widehat{L}([f,\,k]) &= [0,\,Lk] \;, \quad [f,\,k] \in L_{\scriptscriptstyle 2}(G) igoplus L_{\scriptscriptstyle 2}(\partial G) \;. \ P(\lambda)\left([f,\,k]
ight) &= [\lambda f,\,0] \;, \quad [f,\,k] \in L_{\scriptscriptstyle 2}(G) igoplus L_{\scriptscriptstyle 2}(\partial G) \;. \end{aligned}$$

- 5.3. Lemma. $||\hat{L}|| = ||L||$, $||P(\lambda)|| = |\lambda|$, and $(\hat{L})^* = (L^*)^{\wedge}$, $P(\lambda)^* = P(\overline{\lambda})$. Note that the operator $S \hat{L} P(\lambda)$ carries $[u, \widetilde{u}]$ into $[-\Delta u \lambda u, \widetilde{u}_n L \widetilde{u}]$.
- 5.4. LEMMA. The operator $S \hat{L} P(\lambda)$ is closed, densely defined in $L_2(G) \bigoplus L_2(\partial G)$, and has compact resolvent. Thus, $\mathscr{R}(S \hat{L} P(\lambda)) = \mathscr{N}(S \hat{L}^* P(\overline{\lambda}))^+$.
- *Proof.* It is well known that a bounded perturbation of an unbounded self-adjoint operator with compact resolvent is a closed operator with compact resolvent (cf. [6], p. 435). The last statement then follows from the Riesz theory.

Now consider the case $\lambda = 0$. The general element of the graph $\mathcal{G}(S - \hat{L})$ in $L_2(G) \bigoplus L_2(\partial G) \bigoplus L_2(\partial G) \bigoplus L_2(\partial G)$ has the form

$$[u, \widetilde{u}, -\Delta u, \widetilde{u}_n - L\widetilde{u}], \quad u \in \mathscr{D}_1(G).$$

Moreover, $\mathscr{G}(S-\hat{L})$ is a closed linear manifold. We denote by \mathscr{K} the submanifold consisting of all those elements of $\mathscr{G}(S-\hat{L})$ for which $\widetilde{u}_n - L\widetilde{u} = 0$. Clearly, \mathscr{K} is also closed. The map $J \colon \mathscr{K} \to L_2(G) \bigoplus L_2(G)$ is defined by the equation

$$J[u, \widetilde{u} - \Delta u, 0] = [u, -\Delta u]$$
.

The following facts are immediate consequences of this definition.

- 5.5. LEMMA. The mapping J is a one-to-one linear mapping of K onto the graph $\mathcal{G}(T_L)$ of T_L in $L_2(G) \bigoplus L_2(G)$, and $||J|| \leq 1$.
- 5.6. LEMMA. The operator $T_{\rm L}$ is a closed linear operator in $L_2(G)$ with dense domain.

Proof. Since $C_0^{\infty}(G) \subseteq \mathcal{D}(T_L)$, the domain is dense. To prove T_L is closed it suffices to prove that J has a closed range in $L_2(G) \bigoplus L_2(G)$. For this it is enough to show that J maps bounded closed sets onto closed sets (cf. [9], page 489).

Let B be a bounded closed set in \mathcal{K} and $[u^k, \tilde{u}^k, -\Delta u^k, 0]$, $k = 1, 2, \dots$, be a sequence in B such that $[u^k, -\Delta u^k]$ converges in $L_2(G) \bigoplus L_2(G)$. By Green's identity we have

$$egin{align} D(u^k,\,u^k) &= (-arDelta\,u^k,\,u^k) - (\widetilde{u}^k_{\scriptscriptstyle n},\,\widetilde{u}^k) \ &= (-arDelta\,u^k,\,u^k) - (L\,\widetilde{u}^k,\,\widetilde{u}^k) \ &\le (1+||L||)\,M^2 \;, \end{gathered}$$

where M is a bound for B. It follows that $\{u^k\}$ is bounded in $W^{1,2}(G)$. A sub-sequence (which we may take to be $\{u^k\}$) converges weakly in $W^{1,2}(G)$, and therefore $\{\tilde{u}^k\}$ converges strongly in norm (cf. [19], page 208). Thus $[u^k, \tilde{u}^k, -\Delta u^k, 0]$ converges, and so J(B) is closed.

5.7. COROLLARY. There exists a constant K_L such that $||\widetilde{u}||^2 \leq K_L (||u||^2 + ||\Delta u||^2)^{1/2} , \quad u \in \mathscr{D}(T_L) .$

Proof. Since J is one-to-one and maps onto a closed manifold, its inverse is continuous.

It follows from Green's formula that $T_{L*} \subseteq T_L^*$. Our next objective is to prove the two operators are equal. This will be done by consideration of ranges and null manifolds.

5.8. Lemma. Let λ be any complex number. Then we have

(a)
$$\mathscr{R}(T_L - \lambda I) = \{g \in L_2(G) | [g, 0] \in \mathscr{R}(S - \hat{L} - P(\lambda)) \}$$

(b)
$$\mathcal{N}(T_{L} - \lambda I) = \{ u \in \mathcal{D}_{1}(G) | [u, \widetilde{u}] \in \mathcal{N}(S - \hat{L} - P(\lambda)) \}.$$

Proof. If $[g,0] \in \mathscr{R}(S-\hat{L}-P(\lambda))$, there exists $u \in \mathscr{D}_1(G)$ such that $-\Delta u - \lambda u = g$, $\widetilde{u}_n - L\widetilde{u} = 0$. Thus $g \in \mathscr{R}(T_L - \lambda I)$. Conversely, it is clear that if $g \in \mathscr{R}(T_L - \lambda I)$, then $[g,0] \in \mathscr{R}(S-\hat{L}-P(\lambda))$. The proof of (b) is equally direct.

5.9. Lemma. For each complex λ , we have

$$\mathscr{R}(T_{\scriptscriptstyle L}-\lambda I)=\mathscr{N}(T_{\scriptscriptstyle L*}-ar{\lambda}I)^{\scriptscriptstyle \perp}$$
 ;

therefore, in particular, $\mathscr{R}(T_{\mathtt{L}} - \lambda I)$ is closed.

Proof. We know $g \in \mathscr{R}(T_{\mathtt{L}} - \lambda I)$ if and only if $[g, 0] \in \mathscr{R}(S - \hat{L} - P(\lambda))$. By Lemma 5.4, however, the latter manifold is $\mathscr{N}(S - \hat{L}^* - P(\bar{\lambda}))^{\perp}$, and clearly

$$([g,0],[u,\widetilde{u}])=0$$
, $[u,\widetilde{u}]\in\mathscr{N}(S-\hat{L}^*-P(\overline{\lambda}))$

if and only if

$$(g,u)=0$$
 , $u\in \mathscr{N}(T_{L*}-ar{\lambda}I)$.

5.10. LEMMA.

$$(T_{L})^{*} = T_{L*}$$
.

Proof. Taking $\lambda = 0$ in the last lemma, we have $\mathscr{R}(T_L) = \mathscr{N}(T_{L*})^{\perp}$. But since $\mathscr{R}(T_L)$ is closed, $\mathscr{R}(T_L) = \mathscr{N}((T_L)^*)^{\perp}$. Since T_L and T_{L*} are closed, so are their null manifolds, and

(i)
$$\mathscr{N}(T_L^*) = \mathscr{N}(T_{L*}).$$

Because $\mathscr{R}(T_{\mathtt{L}})$ is closed, so is $\mathscr{R}(T_{\mathtt{L}}^*)$ (cf. [15]). Now $T_{\mathtt{L}}=T_{\mathtt{L}}^{**}$, showing

(ii)
$$\mathscr{R}(T_{\scriptscriptstyle L}{}^*) = \mathscr{N}(T_{\scriptscriptstyle L}{}^{**})^{\scriptscriptstyle \perp} = \mathscr{N}(T_{\scriptscriptstyle L})^{\scriptscriptstyle \perp} = \mathscr{R}(T_{\scriptscriptstyle L*})$$
.

From these facts we can show that $T_L^* \subseteq T_{L*}$, as follows: If $u \in \mathcal{D}(T_L^*)$, we can find y in $\mathcal{D}(T_{L*})$ by (ii) such that $T_{L*} y = T_L^* u$. Because $T_{L*} \subseteq T_L^*$, $T_L^*(y-u) = 0$, and therefore, by (i), $y-u \in \mathcal{D}(T_{L*})$. Thus $u \in \mathcal{D}(T_{L*})$, and the required inclusion follows directly,

It remains to prove T_L has compact resolvent. As we shall see, this is easy to prove if it can be shown that the resolvent set $\rho(T_L)$ of T_L is not empty. Again the problem can be thrown onto S.

5.11. Lemma. A complex number λ is in $\rho(T_L)$ if and only if 0 is in $\rho(S - \hat{L} - P(\lambda))$.

Proof. By Lemma 5.8 (b), λ is an eigenvalue of T_L if and only if 0 is an eigenvalue of $S - \hat{L} - P(\lambda)$. If 0 is in the spectrum of

 $S-\hat{L}-P(\lambda)$, it must be an eigenvalue by the Riesz theory. To conclude the proof we must show that if λ is in the spectrum of $T_{\rm L}$ and $(\lambda I - T_{\rm L})^{-1}$ exists, then zero is in the spectrum of $S-\hat{L}-P(\lambda)$. Clearly, $\mathscr{R}(T_{\rm L}-\lambda I)$ cannot be dense, because it is closed. But then $\bar{\lambda}$ is an eigenvalue of $T_{\rm L*}$. It follows that zero is an eigenvalue of $S-\hat{L}^*-P(\bar{\lambda})$, and hence of $S-\hat{L}-P(\lambda)$.

To determine values of λ such that $0 \in \rho(S - \hat{L} - P(\lambda))$ we shall need two lemmas. The first of these follows directly from the argument of Lax and Milgram [17], p. 169.

5.12. Lemma. Let V be a densely defined, closed, linear operator in Hilbert space such that $\mathcal{D}(V) = \mathcal{D}(V^*)$. Suppose there is a constant K > 0 for which we have

$$|(Vu, u)| \ge K||u||^2$$
, $u \in \mathscr{D}(V)$.

Then zero is in the resolvent set of V, and $||V^{-1}|| \leq K^{-1}$. The next lemma may be found in Ehrling [10], p. 270.

5.13. Lemma. There exist constants $M \ge 1$ and $t_0 \ge 1$ such that $||\widetilde{u}||^2 \le M t^{-1/2} (D(u,u) + t ||u||^2), \quad t \ge t_0, \quad u \in W^{1,2}(G).$

In applying these lemmas, we determine conditions on λ such that

(*)
$$|((S-P(\lambda))[u,\widetilde{u}],[u,\widetilde{u}])|>||L||\,||[u,\widetilde{u}]||^2$$
 , $u\in\mathscr{D}_1(G)$.

For such λ , we have $0 \in \rho(S - \hat{L} - P(\lambda))$, because $||(S - P(\lambda))^{-1}|| < ||L||^{-1}$ by Lemma 5.12, and

$$(S-\hat{L}-P(\lambda))^{-1}=[S-P(\lambda)]^{-1}\sum_{n=0}^{\infty}{(-1)^n\,[\hat{L}(S-P(\lambda))^{-1}]^n}$$
 ,

the series converging in the uniform operator topology. Let s be a parameter, 0 < s < 1. Writing $\lambda = \sigma + i\tau$, we have, by Green's identity and Lemma 5.13,

$$\begin{split} |((S-P(\lambda))[u,\widetilde{u}],[u,\widetilde{u}])| &= |D(u,u) - \lambda \, ||u||^2| \\ &\geq s \, D(u,u) + [(1-s)|\tau| - s\sigma] \, ||u||^2 \\ &= s \, \bigg[D(u,u) + \frac{[(1-s)|\tau| - s\sigma] ||u||^2}{2s} \bigg] \\ &+ \frac{[(1-s)|\tau| - s\sigma] ||u||^2}{2} \\ &\geq \frac{s^{1/2}[(1-s)|\tau| - s\sigma]^{1/2} \, ||[u,\widetilde{u}]||^2}{2M} \,, \end{split}$$

if $(1-s)|\tau|-s\sigma>2t_0$. Suppose, in addition, that

$$(**)$$
 $(1-s)|\tau|-s\sigma>Cs^{-1}$,

where C is the larger of $2 t_0$ and $4 M^2 ||L||^2$. Then (*) is satisfied, and therefore λ is in the resolvent set of T_L , by Lemma 5.11. Rewriting (**) in the form

$$| au| > rac{s\sigma}{1-s} + rac{C}{s(1-s)}$$
 ,

we see $\sigma(T_{\rm L})$ lies in each of the sectors

$$\mu = -Cs^{-\imath} + re^{i\phi}$$
 , $| an\phi| \leq rac{s}{1-s}$, $r \geq 0$.

For each fixed value of $\sigma > 0$, we may compute the minimum value of τ satisfying

$$\tau = \frac{s\sigma}{1-s} + \frac{C}{s(1-s)}$$

for 0 < s < 1. The result is a complicated expression which is $O(\sigma^{1/2})$ as $\sigma \to +\infty$. We summarize the situation in

5.14. THEOREM. Let L be a bounded operator in $L_2(\partial G)$. The operator T_L with domain

$$\mathscr{D}(T_i) = \{ u \in \mathscr{D}_1(G) | \widetilde{u}_n = L \widetilde{u} \}$$

and

$$T_{\scriptscriptstyle L} u = -\Delta u$$
 , $u \in \mathscr{D}(T_{\scriptscriptstyle L})$,

is a closed linear operator with compact resolvent, whose spectrum lies inside a parabola $\tau^2 = a\sigma + b$, a, b > 0. Moreover, $T_L^* = T_{L*}$.

All has been proved except the compactness of the resolvent. It is enough to prove it for one nonzero value of λ . If $\{(\lambda I - T_L)u^k\}$ is a bounded sequence, the sequences $\{u^k\}$ and $\{\Delta u^k\}$ are bounded (since $(\lambda I - T_L)^{-1}$ is bounded). Thus $\{\widetilde{u}_k\}$ is bounded, by Corollary 5.7. It follows from Green's identity that $\{u^k\}$ is bounded in $W^{1,2}(G)$, and therefore a sub-sequence of $\{u^k\}$ converges in $L_2(G)$ (cf. the proof of 4.2).
