LEMMA 1.3 (page 965 in proof) is not correct as it is stated, the hypothesis is too weak. The hypothesis should be stated as: "If $\theta_1, \dots, \theta_g$ are completely integrable distributions of dimensions r_1, \dots, r_g on M , such that the sums $\theta_i + \theta_j: x \rightarrow \theta_i(x) + \theta_j(x)$ are also completely integrable ($i, j = 1, \dots, g; i \neq j$), and such that

$$\theta_1(x) + \theta_2(x) + \dots + \theta_g(x) = T_x \text{ (direct sum)}$$

for each $x \in M$ " where the underline portion is what should be added to the old version.
