INVARIANT MEANS AND THE STONE-ČECH COMPACTIFICATION

CARROLL WILDE AND KLAUS WITZ

In the first part of this paper the Arens multiplication on a space of bounded functions is used to simplify and extend results by Day and Frey on amenability of subsemigroups and ideals of a semigroup. For example it is shown that if S is a left amenable cancellation semigroup then a subsemigroup A of S is left amenable if and only if each two right ideals of A intersect. The remainder and major portion of this paper is devoted to relations between left invariant means on $m(S)$ and left ideals of βS (=the Stone-Čech compactification of S). We find: If μ is a left invariant mean on $m(S)$ and if S has left cancellation then $\mathcal{S}(\mu)$, the support of μ considered as a Borel measure on $\beta(S)$, is a left ideal of $\beta(S)$. An application is that if S is a left amenable semigroup and I is a left ideal of βS , then $K(I)$, the w^* -closed convex hull of I , contains an extreme left invariant mean; if in addition S has cancellation then $K(I)$ contains a left invariant mean which is the w^* -limit of a net of unweighted finite averages.

2. Preliminaries. For standard notation and terminology we follow Day [2] in functional analysis and Kelley [6] in topology. Specific terms and notation in amenable semigroups follow Day [1].

Let S be any set, and let $m(S)$ be the Banach space of all bounded, real-valued functions on S , equipped with the supremum norm. A mean on $m(S)$ is a positive linear functional on $m(S)$ which has norm one; every mean μ satisfies $\mu(e) = 1$, where e is the function which is identically one on S . We denote by $M(=M(S))$ the set of all means on $m(S)$. Then M is a nonempty, convex subset of $m(S)^*$; it is also compact in the w^* -topology, the only topology we consider in $m(S)^*$.

For each $s \in S$, $q(s)$ denotes the evaluation functional at s :

$$qs(x) = x(s) \quad (x \in m(S)) .$$

We have $qs \in M$ ($s \in S$) and βS , the Stone-Čech compactification of the discrete space S , coincides with the (w^*) -closure of qS in $m(S)^*$, so that $\beta S \subseteq M$. The symbols $k(T)$, $K(T)$ will always indicate the convex hull, resp. the (w^*) -closed convex hull, of any subset T of $m(S)^*$; in particular, we write kA for $k(qA)$ and KA for $K(qA)$ when $A \subseteq S$. Then we have $M = KS = K(\beta S)$.

Now suppose S is a semigroup. Then each $s \in S$ determines two mappings, l_s and r_s , on $m(S)$ defined by $l_s x(t) = x(st)$ and $r_s x(t) = x(ts)$ ($t \in S$, $x \in m(S)$). A mean μ on $m(S)$ is left [right] invariant if

and only if

$$\mu(l_s x) = \mu(x) [\mu(r_s x) = \mu(x)]$$

for all $s \in S$ and $x \in m(S)$; μ is *invariant* if and only if it is both left and right invariant. A semigroup S is (left) [right] *amenable* if and only if there exists a (left) [right] invariant mean on $m(S)$. We denote by $L(=L(S))$ the set of all left invariant means on $m(S)$; then L is a (possibly empty) closed convex subset of M .

Following Day [1], we define the *Arens product*, $\mu \odot \nu$, of two functionals $\mu, \nu \in m(S)^*$ by $(\mu \odot \nu)x = \mu(y)$, where $y \in m(S)$ is defined by $y(s) = \nu(l_s x)(s \in S)$. Arens' multiplication makes $m(S)^*$ into a semigroup and has the following properties: For fixed $\nu \in M$ and $\theta \in k(S)$ the mappings $\mu \rightarrow \mu \odot \nu$ and $\mu \rightarrow \theta \odot \mu$ are linear and $(w^* - w^*)$ continuous on M (if $\theta \in M$ the mapping $\mu \rightarrow \theta \odot \mu$ may not be continuous), and the mapping q is an isomorphism of the semigroup S onto the semigroup qS [1]. It follows easily that βS is a semigroup under \odot , A^- is a subsemigroup of βS if A is a subsemigroup of S , and the closure of a (left) [right] ideal of S is a (left) [right] ideal of βS . Moreover M is a semigroup under \odot , KA is a subsemigroup of M if A is a subsemigroup of S , and if I is a (left) [right] ideal of S , then KI is a (left) [right] ideal of M . Finally if I is a left ideal of βS then KI is a left ideal of M . For if I is a left ideal of βS , then $\beta S \odot I \subseteq I$ and in particular, $qS \odot I \subseteq I$. Hence $kS \odot kI \subseteq kI$, therefore

$$kS \odot KI \subseteq KI,$$

and therefore $M \odot KI \subseteq KI$ by $(w^* - w^*)$ continuity of Arens' multiplication in the second, resp. first, variable.

The significance of the Arens multiplication for left invariance of means is this: For any semigroup S , $\mu \in L$ if and only if $\nu \odot \mu = \mu$ for all $\nu \in M$ [1, p. 530]. (This is clearly equivalent to the condition $qs \odot \mu = \mu (s \in S)$). In general, define the kernel of the semigroup M , $\text{Ker}(M)$, to be the smallest closed two-sided ideal of M . We always have $\text{Ker}(M) \neq \varnothing$ (by compactness of M), and $L \neq \varnothing$ if and only if $\text{Ker}(M)$ is the smallest closed right ideal of M , in which case $L = \text{Ker}(M)$ [10].

The ideas of the preceding two paragraphs are used repeatedly throughout this paper.

3. A theorem of Day and some applications. We first extend the theorem of Day mentioned in the introduction.

THEOREM 3.1. *If S is a semigroup and A is a subsemigroup of S , let $L_A = \{\mu \in M(S) : qs \odot \mu = \mu \text{ for all } s \in A\}$, and let $N_A = L_A \cap KA$.*

Then the following conditions are equivalent:

- (i) A is left amenable.
- (ii) There exists $\mu \in L_A$ such that $\mu(X_A) > 0$ (X_A is the characteristic function of A).
- (iii) $N_A \neq \varphi$.

Proof. (ii) \Rightarrow (i). This is Day's Theorem with the observation that his proof requires invariance of μ over A only.

(iii) \Rightarrow (ii). Since $\mu \in KA$, we have $\mu(X_A) = 1$.

(i) \Rightarrow (iii). Let ν be a left invariant mean on $m(A)$ and define $\mu = \Pi^* \nu$, where Π is the restriction map of $m(S)$ onto $m(A)$ defined by $\Pi x(t) = x(t)$ for $t \in A, x \in m(S)$ [see 1, p. 512]. It is easily checked that μ is a mean on $m(S)$. Now ΠX_A is the function identically one on A , so $\mu(X_A) = \nu(\Pi X_A) = 1$. Therefore $\mu \in KA$. For we can write

$$\mu = \lambda \mu_1 + (1 - \lambda) \mu_2,$$

where $0 \leq \lambda \leq 1$, $\mu_1 \in KA$, and $\mu_2 \in KA'$ ($A' = S \setminus A$). Evaluating both sides at X_A yields $\lambda = 1$, whence $\mu = \mu_1 \in KA$. It remains to show that $\mu \in L_A$. If $s \in A$ and $x \in m(S)$ then

$$(qs \odot \mu)x = qs(y),$$

where $y(t) = \mu(l_s x)$ and therefore

$$(qs \odot \mu)x = y(s) = \mu(l_s x) = \nu(\Pi(l_s x)) = \nu(\lambda_s(\Pi x)) = \nu(\Pi x) = \mu(x)$$

(here l_s is the left shift by s in $m(A)$).

Theorem 3.1 and the ideas involved in its proof combine with facts mentioned at the end of § 2 to give quite short proofs for some known results and to extend others. For example, the following corollary is due to E. Granirer (unpublished); his proof is independent of ours.

COROLLARY 3.2. Suppose G is any group and A is a subsemi-group of G which generates G . Then A is left amenable if and only if $KA \cap L(G) \neq \varphi$.

Proof. Only the forward implication is not apparent by Day's Theorem itself. By Theorem 3.1, there exists $\mu \in KA$ such that

$$qg \odot \mu = \mu$$

for all $g \in A$. Thus if $g \in A$, then

$$qg^{-1} \odot \mu = qg^{-1} \odot (qg \odot \mu) = (qg \odot qg^{-1}) \odot \mu = qu \odot \mu = \mu,$$

where u is the group identity. Since each $g \in G$ can be written as a

product of elements which are in A or A^{-1} , we are finished.

COROLLARY 3.3. (i) *If a semigroup S contains a left amenable left ideal I , then S is left amenable.*

(ii) *Conversely, if S is a left amenable semigroup, then each left or right ideal I of S is left amenable.*

Proof. Part (i) appears in Frey [4]; Frey also proves (ii) for right ideals but states that he was unable to obtain the result for left ideals. In our setting everything becomes quite simple. For (i), we note that since I is left amenable, there exists $\mu \in KI$ such that $qt \odot \mu = \mu$ for all $t \in I$ by Theorem 3.1. If $s \in S$, choose any $t \in I$; then $qs \odot \mu = qs \odot (qt \odot \mu) = qst \odot \mu = \mu$; hence $\mu \in L(S)$. For (ii), suppose S is left amenable and let I be a left [right] ideal of S . Then KI is a left [right] ideal of $M(S)$ and must intersect the two-sided ideal $L(S) = \text{Ker}(M)$. That is, there exists $\mu \in L$ such that $\mu(X_I) = 1$, and the result follows from Day's Theorem.

We now use Theorem 3.1 to sharpen another result of Frey, namely: In a left amenable, two-sided cancellation semigroup, every subsemigroup is left amenable if and only if every subsemigroup satisfies the condition that its family of all right ideals has the finite intersection property. We show (Theorem 3.5) that this last condition characterizes any left amenable subsemigroup.

LEMMA 3.4. *Let G be a group, and let A be a subsemigroup of G such that A generates G and the family of all right ideals of A has the finite intersection property. If $g \in G$, then $gA \cap A$ is a right ideal of A .*

Proof. We need only prove that $gA \cap A \neq \varnothing$ for an arbitrary $g \in G$. This is clear if $g \in A$ or $g^{-1} \in A$. If $g \in G$, we can write

$$g = g_1 g_2 \cdots g_n,$$

where $g_i \in A$ or A^{-1} for $1 \leq i \leq n$. Letting $h = g_1 g_2 \cdots g_n$, we have $gA \cap A = g_1 hA \cap A$, and by induction, $hA \cap A \neq \varnothing$. If $g_1 \in A$, then $g_1(hA \cap A) \neq \varnothing$, and

$$g_1(hA \cap A) = (g_1(hA \cap A)) \cap A \subseteq g_1 hA \cap A = gA \cap A,$$

so $gA \cap A \neq \varnothing$ in this case. If $g_1 \in A^{-1}$, then

$$(hA \cap A) \cap g_1^{-1}A \neq \varnothing$$

because it is the intersection of two right ideals of A . Hence

$$hA \cap g_1^{-1}A \neq \varnothing$$

and so $gA \cap A = g_i(hA \cap g_i^{-1}A) \neq \varphi$.

THEOREM 3.5. *Let S be a left amenable, two-sided cancellation semigroup. Then the following conditions on a subsemigroup A of S are equivalent:*

- (i) *A is left amenable.*
- (ii) *The family of all right ideals of A has the finite intersection property.*

Proof. Frey shows that condition (ii) is necessary for left amenability of *any* semigroup; we give a shorter proof. Let T be any left amenable semigroup and assume I and J are two disjoint right ideals of T . Then $KI \cap KJ = \varphi$ in $M(T)$; for if $\mu \in KI \cap KJ$, then $\mu(X_I) = \mu(X_J) = 1$, which would imply $\mu(e) \geq 2$. Hence $M(T)$ contains two disjoint closed right ideals, contradicting that $L(T) = \text{Ker}(M(T))$ is the smallest closed right ideal of $M(T)$. Taking $T = A$, we have (i) \Rightarrow (ii). To prove (ii) \Rightarrow (i), we use the following theorem of Ore [cf. 7, p. 392]: A two-sided cancellation semigroup T is embeddable in a group if, given $s, t \in T$, there exist $s', t' \in T$ such that $ss' = tt'$. This tells us that S is embeddable in a group G , and we can assume that S generates G . By Corollary 3.2, G is amenable. By Lemma 3.4, $\{gA \cap A : g \in G\}$ has the finite intersection property; hence so does $\{(gA \cap A)^- : g \in G\}$ in βG . Set $E = \bigcap \{(gA \cap A)^- : g \in G\}$. By compactness, $E \neq \varphi$, and clearly $E \subseteq A^-$ and $E = \bigcap \{(gA)^- : g \in G\}$. We shall show that E is a left ideal of βG . Let $h \in G$; since

$$q(hA)^- = qh \odot A^-,$$

we have $qh \odot E \subseteq \bigcap \{(hgA)^- : g \in G\}$. But

$$\bigcap \{(hgA)^- : g \in G\} = \bigcap \{(gA)^- : g \in G\} = E$$

because G is a group and so the intersections are over the same class of sets. Hence $qh \odot E \subseteq E$. It follows that $qG \odot E \subseteq E$ and

$$\beta G \odot E \subseteq E.$$

Thus A^- contains a left ideal of βG (namely E), and so $K(A^-) = KA$ contains a left ideal of $M(G)$ (namely KE). The proof of Corollary 3.3, part (ii), shows that A is left amenable.

We note the following immediate corollary to the proof of Theorem 3.5.

COROLLARY 3.6. *A left amenable, two-sided cancellation semigroup is embeddable in an amenable group.*

4. **Supports.** We identify $m(S)$ with $C(\beta S)$ as usual and regard M as a subset of $C(\beta S)^*$. Thus for each $\mu \in M$ there is a unique regular Borel measure $\bar{\mu}$ on βS which satisfies

$$\mu(x) = \int_{\beta S} \bar{x} d\bar{\mu} \quad x \in m(S)$$

(where \bar{x} is the unique continuous extension of x from S to βS), and $\bar{\mu}(\beta S) = 1$. Let $\delta(\mu)$ be the support of $\bar{\mu}$, i.e., the smallest closed subset F of βS such that $\mu(F) = 1$.

LEMMA 4.1. *If $\mu \in M$ then*

$$\delta(\mu) = \cap \{ \bar{A} : A \subseteq S \text{ and } \mu \in KA \}.$$

Proof. Denote the intersection on the right by F_0 . It is well known¹ that if F is a closed subset of βS and if $\mu \in M$ then

$$\bar{\mu}(F) = 1 \text{ (i.e., } \delta(\mu) \subset F) \text{ if and only if } \mu \in KF.$$

Hence $\delta(\mu) \subset F_0$, and since S is dense in βS , $F_0 \subset \delta(\mu)$.

Recall that a subset A of a compact convex subset K of a locally convex space is *extremal* in K if and only if A is compact, convex, and every open segment in K which contains a point of A lies wholly in A [2, p. 78].

LEMMA 4.2. (i) *If D is a closed subset of βS , then $D = \mathcal{S}(KD)$. If E is an extremal subset of M , then $E = K(\mathcal{S}(E))$.*

(ii) *The mapping $D \rightarrow KD$ is a one-to-one correspondence between the class of all closed subsets D of βS and the class of all extremal subsets of M .*

Proof. (i) By Lemma 4.1, $\mathcal{S}(KD) \subseteq D$, and a separation argument shows that the inclusion is not proper. Let E be an extremal subset of M . Then clearly $E \subseteq K(\mathcal{S}E)$ and by the Krein-Mil'man Theorem, E is the closed convex hull of its set of extreme points. Since E is an extremal set in M , each extreme point of E is an extreme point of M and hence in βS . Hence $E = KD$, where D is a subset of βS , and D can be assumed closed. Thus

$$K(\mathcal{S}E) \subseteq KD = E.$$

(ii) The mapping $D \rightarrow KD$ on the closed subsets D of βS is one-to-one, again by a separation argument. To see that KD is an extremal subset of M , let $\mu \in KD$ and suppose $\mu = \lambda\mu_1 + (1 - \lambda)\mu_2$ with

$0 < \lambda < 1$ and $\mu_1, \mu_2 \in M$. Fix $A \subseteq S$ such that $KA \supseteq KD$; then $\mu \in KA$, so that $\mu(X_A) = 1$. Since $\mu_1, \mu_2 \in M$, we have

$$\mu_1(X_A), \mu_2(X_A) \leq 1,$$

and if either is less than one, we would have

$$1 = \mu(X_A) = \lambda\mu_1(X_A) + (1 - \lambda)\mu_2(X_A) < \lambda \cdot 1 + (1 - \lambda) \cdot 1 = 1.$$

Hence $\mu_1(X_A) = \mu_2(X_A) = 1$, so that $\mu_1, \mu_2 \in KA$. Since $A \subseteq S$ was arbitrary subject only to the restriction $KA \supseteq KD$, we have

$$\begin{aligned} \mu_1, \mu_2 &\in \cap \{KA: A \subseteq S \text{ and } KA \supseteq KD\} \\ &= K(\cap \{A^-: A \subseteq S \text{ and } KA \supseteq KD\}) \\ &= K(\mathcal{S}(KD)) = KD. \end{aligned}$$

We now assume that S is a semigroup and apply the preceding results. Namely, we show that *for certain semigroups the supporting sets of invariant means are left ideals of βS . The general case is still open (see the comment after 5.1.)*

THEOREM 4.3. *Let S be a left amenable, two-sided cancellation semigroup. If $L_0 \subseteq L$, $L_0 \neq \varnothing$, then $\mathcal{S}(L_0)$ is a closed left ideal of βS .*

Proof. Suppose first that $S = G$, a group. Let $\omega \in \mathcal{S}(L_0)$ and let $g \in G$. Then $qg \odot \omega \in qg \odot (A^-) = (gA)^-$ for all $A \subseteq G$ such that $KA \supseteq L_0$. Thus $qg \odot \omega \in \cap \{(gA)^-: A \subseteq G \text{ and } KA \supseteq L_0\}$. Now $L_0 \subseteq KA$ if and only if $L_0 \subseteq K(hA)$ for each $h \in G$; for if $\mu \in L_0 \subseteq KA$, then $\mu = qh \odot \mu \in qh \odot KA = K(hA)$, and if $\mu \in XK(hA)$, then $\mu = qh \odot \nu$ with $\nu \in KA$, so that $\mu = qh^{-1} \odot \mu = qh^{-1} \odot (qh \odot \nu) = \nu \in KA$. Hence $\{A: A \subseteq G \text{ and } KA \supseteq L_0\} = \{gA: A \subseteq G \text{ and } KA \supseteq L_0\}$ so that

$$qg \odot \omega \in \mathcal{S}(L_0).$$

Then $qG \odot \omega \subseteq \mathcal{S}(L_0)$, $\beta G \odot \omega \subseteq \mathcal{S}(L_0)$, and $\beta G \odot \mathcal{S}(L_0) \subseteq \mathcal{S}(L_0)$. To remove the group restriction, we embed S in a group G such that S generates G . The mapping Π^* identifies βS with S^- in βG , and by Corollary 2.2, $\Pi^*(L_0)$ is a subset of the left invariant means on $m(G)$. Applying the result for groups, we get that (Π^*L_0) is a closed left ideal of S^- . Taking the inverse under Π^* yields the desired result.

In particular, if μ is a left invariant mean on $m(S)$, then $\mathcal{S}(\mu)$ is a left ideal of βS (provided cancellation is present).

THEOREM 4.4. *If S is a left amenable semigroup and I is a left ideal of βS , then KI contains an extreme point of L .*

Proof. Since I is a left ideal of βS , KI is a left ideal of M , so $KI \cap L \neq \varnothing$, and since KI is an extremal subset of M and L is compact and convex, we have that $KI \cap L$ is an extremal subset of L . Hence $KI \cap L$ contains an extreme point of L [2, p. 78].

In βS minimal left ideals exist, are closed, are pairwise disjoint, and are usually abundant. Then Theorem 4.4 and the facts noted in the proof of 4.1 imply that there are at least as many extreme points of L as there are minimal left ideals of βS . In the special case where $S = N$, the additive semigroup of positive integers, Raimi [9] recently showed that there are at least two extreme points of L in KI for each minimal left ideal I of βN . We remark that if I is a minimal left ideal of βS , then $I = \mathcal{S}(L_0)$ for each subset L_0 of $KI \cap L$.

We close this section with a corollary to Theorem 4.3.

COROLLARY 4.5. *If S is a left amenable, two-sided cancellation semigroup and A is a subsemigroup of S which is not left amenable, then $(A')^-$ contains a (minimal) left ideal of βS .*

Proof. By Day's Theorem, $\mu(X_A) = 0$ for all $\mu \in L$; thus $L \subseteq KA'$, and so $\mathcal{S}(L) \subseteq (A')^-$.

5. On a theorem of Mitchell. In his thesis [8, p. 39], T. Mitchell proved the following theorem:

(*) *Let S be a left amenable semigroup, and let $A \subseteq S$. Then there exists $\mu \in L$ such that $\mu(X_A) = 1$ (i.e., $\mu \in KA$) if and only if given any finite subset F of S , there exists $s \in S$ such that $Fs \subseteq A$.*

We give an easy and different proof of a related fact.

LEMMA 5.1. *If S is any semigroup, then the following conditions on $A \subseteq S$ are equivalent:*

- (i) A^- contains a (closed) left ideal of βS .
- (ii) For each finite subset F of S there exists $s \in S$ such that $Fs \subseteq A$.

Proof. (i) \Rightarrow (ii). Let $I \subseteq A^-$ be a left ideal of βS . Let $\omega \in I$ and take a net $\{s_n; n \in N\}$ such that $qs_n \rightarrow \omega$. If F is a finite subset of S , $F = \{t_1, t_2, \dots, t_k\}$, then $q(t_i s_n) = qt_i \odot qs_n \rightarrow qt_i \odot \omega \in I$ for $1 \leq i \leq k$; and since A^- is an open set containing I , there exists $n_0 \in N$ such that $n \geq n_0$ implies $qt_i \odot qs_n \in A^-$ for $1 \leq i \leq k$; in particular,

$$Fs_{n_0} \subseteq A.$$

(ii) \Rightarrow (i). Let \mathcal{F} be the family of all finite subsets of S directed upward by inclusion. Define a net over \mathcal{F} as follows: For each

$F \in \mathcal{F}$ choose an s_F such that $Fs_F \subseteq A$. By compactness, there is a subnet $\{s_n; n \in N\}$ of the net $\{s_F; F \in \mathcal{F}\}$ and $\omega \in \beta S$ such that $qs_n \rightarrow \omega$. Fix $s \in S$, and put $F_0 = \{s\}$. Then there exists $n_0 \in N$ such that $n \geq n_0$ implies that $s_n = s_F$ with $F \geq F_0$. Since

$$ss_n \in F_0s_n \subseteq Fs_n \subseteq A$$

for all $n \geq n_0$ and $qs \odot qs_n \rightarrow qs \odot \omega$, we have $qs \odot \omega \in A^-$. Since $s \in S$ was arbitrary, we have $qS \odot \omega \subseteq A^-$, and so $\beta S \odot \omega \subseteq A^-$. Since $\beta S \odot \omega$ is a closed left ideal of βS , the lemma is proved.

Let S be a left amenable semigroup, and let $A \subseteq S$. It follows as in Corollary 3.3 that if A^- contains a left ideal of βS , then

$$KA \cap L \neq \varnothing,$$

and in view of Lemma 5.1, this is one half of (*). Conversely, if $A \subseteq S$ and $KA \cap L \neq \varnothing$, then by (*) and Lemma 5.1, A^- must contain a left ideal of βS . Observe that we get the same conclusion independent of (*) from Theorem 4.3 in case two-sided cancellation holds in S , and this suggests that it may be possible to extend Theorem 4.3 to more general semigroups.

For our next and final result we need Frey's generalization [4] of Folner's Theorem [3]: A two-sided cancellation semigroup S is left amenable if and only if for each $\varepsilon \in (0, 1)$ and each finite subset F of S there exists a finite subset E of S such that $(|sE \cap E|/|E|) \geq 1 - \varepsilon$ for each $s \in F$ (here $|D|$ denotes the cardinality of $D \subseteq S$).

DEFINITION. Let S be a semigroup. An *arithmetic average* on S is a mean on $m(S)$ of the form $\mu_E = 1/|E| \sum_{s \in E} qs$, where E is a finite subset of S .

THEOREM 5.2. *Let S be a left amenable, two-sided cancellation semigroup and $L_0 \subseteq L$. Then there exists $\mu \in K(\mathcal{S}L_0) \cap L$ such that μ is the limit of a net of arithmetic averages on S .*

Proof. We remark that our proof assumes that S is infinite; the theorem is trivial otherwise. We consider three directed sets, $\mathcal{F}, \mathcal{J}, \mathcal{N}$: \mathcal{F} is the system of finite subsets of S directed upward by inclusion; \mathcal{J} is the real interval $(0, 1)$ directed upward by \leq ; \mathcal{N} is the system of all subsets A of S such that $KA \supseteq L_0$, directed downward by inclusion. Let $(\mathcal{F}, \mathcal{J}, \mathcal{N})$ be the product directed system and fix $n = (F, \varepsilon, A) \in (\mathcal{F}, \mathcal{J}, \mathcal{N})$. By the Frey-Folner theorem, there exists a finite subset $E_{F, \varepsilon}$ of S such that $(|sE_{F, \varepsilon} \cap E_{F, \varepsilon}|/|E_{F, \varepsilon}|) \geq 1 - \varepsilon$ for each $s \in F$. By Lemma 5.1, there exists $s_{F, \varepsilon, A} = s_n \in S$ such that $E_{F, \varepsilon}s_n \subseteq A$. Let $D_n = E_{F, \varepsilon}s_n$, and let μ_n be the arithmetic mean over D_n . Since $n \in N = (\mathcal{F}, \mathcal{J}, \mathcal{N})$ was arbitrary, $\{\mu_n; n \in N\}$ is a net

over N . By cancellation,

$$\begin{aligned} (|sD_n \cap D_n|/|D_n|) &= (|s(E_{F,\varepsilon}S_n) \cap (E_{F,\varepsilon}S_n)|/|E_{F,\varepsilon}S_n|) \\ &= (|sE_{F,\varepsilon} \cap E_{F,\varepsilon}|/|E_{F,\varepsilon}|) \geq 1 - \varepsilon \end{aligned}$$

for each $s \in F$. If $t \in S$ and $x \in m(S)$, then

$$\begin{aligned} |(qt \odot \mu_n)(x) - \mu_n(x)| &= ||D_n|^{-1} \sum_{s \in D_n} (x(ts) - x(s))| \\ &\leq |D_n|^{-1} \cdot \varepsilon \cdot 2 ||x|| \cdot |D_n| \rightarrow 0; \end{aligned}$$

hence $\{\mu_n\}$ converges to left invariance [1, p. 520]. Let μ be a cluster point of $\{\mu_n; n \in N\}$, so that $\mu \in L$ [1, p. 520]. Fix $A_0 \in \mathcal{A}$. If $A \geq A_0$ and $F \in \mathcal{F}$, $\varepsilon \in \mathcal{S}$ are arbitrary, then $D_n = E_{F,\varepsilon}S_n \subseteq A \subseteq A_0$, so that $\mu_n \in KA_0$. This implies that $\mu \in KA_0$; and since A_0 was arbitrary in \mathcal{A} , we have $\mu \in K(\mathcal{S}L_0)$.

In particular, if I is a minimal left ideal of βS , then KI contains at least one left invariant mean μ_I which is the (w^{*-}) limit of a net of arithmetic averages. Thus there are at least as many invariant means of this type as there are distinct minimal left ideals in βS (see the discussion after Theorem 4.6).
