DIHEDRAL GROUP ACTIONS ON HOMOTOPY COMPLEX PROJECTIVE THREE SPACES

Let D_{2m} be the dihedral group of order 2m. Given an odd prime m such that the projective class group of D_{2m} has 2-rank = 0, we construct smooth D_{2m} -actions on an infinite number of pairwise non-diffeomorphic (distinguished by Pontryagin class) manifolds each of which is homotopy equivalent to CP^3 . This is accomplished by applying equivariant surgery theory to normal maps created by an equivariant transversality argument.

1. Introduction. The question which we deal with here is: "Which finite groups can act on differentiably non-standard homotopy $\mathbb{C}P^3$'s?" We use equivariant surgery theory to construct dihedral group actions on an infinite number of differentiably distinct smooth manifolds which are homotopy equivalent to $\mathbb{C}P^3$.

According to [MY], there is a one-to-one correspondence between the integers and the set (actually, it is a group) of diffeomorphism classes of 6-dimensional, smooth, closed manifolds which are homotopy equivalent to $\mathbb{C}P^3$ (such manifolds shall hereafter be called homotopy $\mathbb{C}P^3$'s). For every integer k, there is a unique homotopy $\mathbb{C}P^3$, denoted X_k , with first Pontryagin class $P_1(X_k) = (4 + 24k)x^2$, where $x \in H^2(X_k)$ is a generator. Then, X_0 is the standard $\mathbb{C}P^3$. All actions shall be effective and smooth.

Some information is known about smooth finite group actions on homotopy $\mathbb{C}P^3$'s. For instance, infinitely many homotopy $\mathbb{C}P^3$'s admit a \mathbb{Z}_m -action for almost every prime number m. (For this, and other interesting results, we refer the reader to [**DM**].) On the other hand, in [**M1**], it is shown that if X_k admits a smooth, effective $\mathbb{Z}_m \times \mathbb{Z}_m \times \mathbb{Z}_m$ -action, for any odd prime m, then k = 0, i.e., $X_k = \mathbb{C}P^3$. (There is a more restricted version of this result for m = 2. For information about involutions on homotopy $\mathbb{C}P^3$'s, we refer the reader to [**DMS**].)

In this paper, we shall consider the case of dihedral group actions. To my knowledge, these are the first examples of non-abelian group actions on non-standard CP^3 . Specifically, our main result is:

THEOREM A. Let \mathbf{D}_{2m} be the dihedral group of order 2m, where m is an odd prime. If the projective class group $\widetilde{K}_0(\mathbf{Z}[\mathbf{D}_{2m}])$ has 2-rank = 0, then there are infinitely many integers k for which X_k admits a \mathbf{D}_{2m} -action. In particular, this holds for $m \leq 67$.

The main tool used to prove the above theorems is equivariant surgery theory (see [DP] and [PR]). The features of this theory which are relevant to our work shall be outlined in the next section. The third section provides the proof of Theorem A. At this point, I would like to thank Professor Heiner Dovermann for his help and encouragement. 2. Background. Let G be a finite group. Equivariant (G-) surgery is a process for constructing G-manifolds which are G-homotopy equivalent to a given G-manifold Y. (A homotopy $F: X \times I \to Y$ is a G-homotopy if $F(\cdot, t)$ is a G-map for all t.) Two major steps are involved in this process.

1. We build a G-normal map (X, f, b) with target manifold Y. This can be thought of as an approximation to a G-homotopy equivalence.

2. We must determine whether or not the obstructions to performing G-surgery to a G-homotopy equivalence vanish. The process of G-surgery converts X to a G-manifold X' and f to a G-map $f': X' \to Y$ which is a G-homotopy equivalence.

Before we elaborate on this, we need some definitions.

DEFINITION 2.1. A G-manifold is said to satisfy the gap hypothesis if given a nontrivial subgroup $H \subseteq G$ and a component F of X^H , we have $2 \dim F < \dim X$.

(Other definitions of the gap hypothesis are possible, however this is the one which suits our needs.)

Recall that a smooth G-vector bundle is a triple (E, p, B), where $p: E \to B$ is an ordinary smooth vector bundle such that E and B support smooth G-actions and the projection p is a G-map. We also require that given $g \in G$ and $b \in B$, the map restricted to fiber $g: E_b \to E_{g(b)}$ is linear.

At this point, for simplicity, instead of defining G-normal maps, we choose to define a special type of G-normal map, the notion of an adjusted G-normal map. (See [D1]. The notion of a G-normal map can be found, for example, in [H] or [PR].)

DEFINITION 2.2. An adjusted G-normal map with target Y is a triple (X, f, b), where

(1) X is a smooth, oriented, closed G-manifold which satisfies the gap hypothesis and is of dimension ≥ 5 . Y is a smooth, oriented, closed G-manifold which is simply connected and of the same dimension as X.

(2) $f: X \to Y$ is a smooth, degree 1 *G*-map which induces a *G*-homotopy equivalence between the singular sets X^s and Y^s . (Recall that $X^s = \{x \in X : G_x \neq 1\}$.)

(3) b is a stable G-vector bundle isomorphism between $TX \oplus f^*(\eta_-)$ and $f^*(TY \oplus \eta_+)$, for some pair of G-vector bundles η_{\pm} . That is, there exists a G-representation V such that b is a G-vector bundle isomorphism between $TX \oplus f^*(\eta_-) \oplus (X \times V)$ and $f^*(TY \oplus \eta_+) \oplus (X \times V)$.

We have a further important definition.

DEFINITION 2.3. Let η_+ and η_- be *G*-vector bundles over a *G*-manifold *Y*. Assume that given $H \subseteq G$ and $y \in Y^H$, we have $\dim(\eta_+|_y)^H = \dim(\eta_-|_y)^H$. Then $\omega: \eta_+ \to \eta_-$ is a *G*-fiber homotopy equivalence if it is a proper, fiber preserving *G*-map such that, given $H \subseteq G$ and $y \in Y^H$, the map $(\omega|_y)^H: (\eta_+|_y)^H \to (\eta_-|_y)^H$ has degree 1 when extended to one point compactifications.

Using ideas found in §11 of Chapter 3 in [**PR**], an adjusted G-normal map can be constructed from a G-fiber homotopy equivalence over Y provided that certain conditions are met. This shall be carried out in §3 of this paper.

Once our adjusted G-normal map is constructed, we proceed to step 2, which is to determine whether surgery to a G-homotopy equivalence is possible.

We first mention that an equivariant map $f: X \to Y$ is a *G*-homotopy equivalence if and only if $f^H: X^H \to Y^H$ is an ordinary homotopy equivalence for all $H \subseteq G$. (See [B].) Therefore, given our adjusted *G*-normal map (X, f, b), we must convert X to a *G*-manifold X_{η} and f to a *G*-map $F: X_{\eta} \to Y$ such that F^H is a homotopy equivalence for all $H \subseteq G$. There is a surgery obstruction to achieving this as indicated in the following proposition. At this point,

we make the assumption that the dimension of Y is even and that G contains no elements g of order 2 with $2(\dim(Y_{\alpha}^{H})^{g}+1) = \dim Y_{\alpha}^{H}$. This will ensure that the following obstruction is well-defined. Our constructions will fall within this constraint. For more on this point, see [Mo] and §3 of [D].

PROPOSITION 2.4. Let (X, f, b) be an adjusted G-normal map with target Y. There is an obstruction $\sigma_1(f, b)$ which vanishes if and only if (X, f, b) is G-normally cobordant to an adjusted G-normal map (X_{η}, F, B) , where $F: X_{\eta} \to Y$ is a G-homotopy equivalence.

That is, $\sigma_1(f, b)$ vanishes if and only if G-surgery can be used to convert X to X_η and f to a G-homotopy equivalence $F: X_\eta \to Y$. The proof of this proposition may be found in [D]. (See Corollary 1.1 on p. 853.) Related results involving G-normal maps are wellknown and can be found in [PR] and [DR2]. Also, see [BQ]. We note that this surgery is done relative to the singular set X^s . The obstruction $\sigma_1(f, b)$ is an element of the Wall group $L_n^h(\mathbb{Z}[G], w)$, where $n = \dim Y$ and $w: G \to \mathbb{Z}_2$ is the orientation homomorphism of the G-action on Y.

It is often easier to deal with $L_n^s(\mathbf{Z}[G], w)$, the surgery obstruction group for simple homotopy equivalences instead of $L_n^h(\mathbf{Z}[G], w)$. These two groups are related by the Rothenberg exact sequence [Sh]:

$$\cdots \to L_n^s(\mathbf{Z}[G], w) \to L_n^h(\mathbf{Z}[G], w) \xrightarrow{\alpha_G} H^n(\mathbf{Z}_2; \mathrm{Wh}(G)) \to \cdots,$$

where Wh(G) is the Whitehead group of G and α_G is the torsion homomorphism to be considered shortly. The Tate cohomology group $H^n(\mathbb{Z}_2; Wh(G))$ is defined as:

$$\{\delta \in \mathrm{Wh}(G) \colon \delta = (-1)^n \delta^*\} / \{\tau + (-1)^n \tau^* \colon \tau \in \mathrm{Wh}(G)\},\$$

where * denotes the conjugation involution based on the orientation homomorphism w.

Let's suppose that our adjusted G-normal map (X, f, b) with target Y has been constructed from a G-fiber homotopy equivalence $\omega: \eta_+ \to \eta_-$ over Y. In this situation, the work of Dovermann ([D]) and Dovermann-Rothenberg ([DR1]) can be applied to give us information on $\alpha_G(\sigma_1(f, b)) \in H^n(\mathbb{Z}_2; Wh(G))$. Given a G-fiber homotopy equivalence ω , its generalized Whitehead torsion $\tau(\omega)$ can be defined as an element of the generalized Whitehead group $\widetilde{Wh}(G) = \bigoplus_{(H) \subset G} Wh(N_G(H)/H)$, where (H) denotes the conjugacy class of H. Let T denote the conjugation on $\widetilde{Wh}(G)$ and $[\cdot]$ denote the cohomology class as indicated above.

LEMMA 2.5. Let (X, f, b) be an adjusted G-normal map constructed as above such that f^H is an $N_G(H)/H$ -diffeomorphism for each nontrivial subgroup H of G. Then $\alpha_G(\sigma_1(f, b)) = [T\tau(\omega)]$.

Proof. A formula for $\alpha_G(\sigma_1(f, b))$ can be given by combining Theorems A and B along with Proposition 6.6 of Dovermann's paper [**D**]. Noting that our assumption on f implies that $\tau(f^s) = 0$, the formula reduces to $\alpha_G(\sigma_1(f, b)) = [T\tau(\varphi)]$, where φ is a certain G-fiber homotopy equivalence associated with the adjusted G-normal map (X, f, b). As can be seen from §6 of [**D**], φ is closely related to our G-fiber homotopy equivalence ω . Indeed, by stabilizing with an appropriate complex G-bundle, we can arrive at the same G-fiber homotopy equivalence. Then, the addition formula of Dovermann-Rothenberg (Corollary 8.15 of [**DR1**]) implies that $\tau(\varphi) = \tau(\omega)$ which finishes our proof. (We mention that the results of [**D**] and [**DR1**] are written in terms of sphere bundles. The Whitney sum corresponds to fiberwise join. This is not a restriction for us. See §§1-13 of [**PR**].) \Box

LEMMA 2.6. Suppose that $\omega: \eta_+ \to \eta_-$ is a G-fiber homotopy equivalence over an even dimensional G-manifold Y. Let $\tilde{\omega} = \omega \oplus \omega: \eta_+ \oplus \eta_+ \to \eta_- \oplus \eta_-$. If the ordinary Whitehead group Wh(G) is torsion free and if $\tau(\tilde{\omega})$ has non-zero coordinate only in Wh(G), then $[T\tau(\tilde{\omega})] = 0$.

Proof. In [DR1], a formula for the generalized Whitehead torsion of a G-fiber homotopy equivalence is given. From Corollary 8.15 of that paper, it follows that with our set-up, $\tau(\tilde{\omega})$ is twice an element of $\widetilde{Wh}(G)$. Therefore, $T\tau(\tilde{\omega})$ is also a "multiple of 2". In general, this is not enough to show that $[T\tau(\tilde{\omega})]$ vanishes in

 $H^{n}(\mathbb{Z}_{2}; \operatorname{Wh}(G)) = \{\delta \in \operatorname{Wh}(G) \colon \delta = \delta^{*}\} / \{\tau + \tau^{*} \colon \tau \in \operatorname{Wh}(G)\}.$

(Note that we are assuming $n = \dim Y$ is even.)

However, with our additional assumption that Wh(G) is torsion free, the result follows.

Indeed, $T\tau(\tilde{\omega})$ lies in $\{\delta \in Wh(G): \delta = \delta^*\}$ and as explained above, $T\tau(\tilde{\omega}) = 2x$, for some $x \in Wh(G)$. We claim that we must have $x \in \{\delta \in Wh(G): \delta = \delta^*\}$. Suppose that $\alpha \in Wh(G) = \bigoplus \mathbb{Z}$ and let φ be any homomorphism from Wh(G) to itself (in particular, $\varphi =$ *). Since φ is a homomorphism and Wh(G) is torsion free, it follows easily that $\varphi(2\alpha) = 2\alpha \Rightarrow \varphi(\alpha) = \alpha$. Therefore, we have $T\tau(\tilde{\omega}) = 2x = x + x = x + x^*$ and hence $[T\tau(\tilde{\omega})] = 0$ in $H^n(\mathbb{Z}_2; Wh(G))$ as desired.

We note that we shall be working with the group \mathbf{D}_{2m} , where m is an odd prime. (The conjugation involution on $Wh(\mathbf{D}_{2m})$ will be defined in terms of the nontrivial orientation homomorphism w, i.e., elements of order 2 shall reverse orientation and be sent to -1.) It is shown in [O] that $SK_1(\mathbb{Z}[\mathbb{D}_{2m}])$, the torsion part of $Wh(\mathbb{D}_{2m})$, vanishes for all odd primes m. (Also see [Ma].) We also note that $\tau(\tilde{\omega})$ will have non-zero coordinate only in Wh(G) in our geometric set-up. (See Lemma 2.5.)

Our purpose for introducing the Rothenberg sequence is to show that $\sigma_1(f, b) \in L_n^h(\mathbb{Z}[G], w)$ comes from an element, $\sigma_1^s(f, b) \in$ $L_n^s(\mathbb{Z}[G], w)$, which will be shown to vanish, thereby guaranteeing that $\sigma_1(f, b) = 0$, and that surgery to a *G*-homotopy equivalence is possible. Clearly, $\sigma_1(f, b)$ will come from some $\sigma_1^s(f, b)$ if $\alpha_G(\sigma_1(f, b)) = 0$.

3. Proof of Theorem A. In this section, we shall give the proof of:

THEOREM A. Let \mathbf{D}_{2m} denote the dihedral group of order 2m, where m is an odd prime. If the projective class group $\widetilde{K}_0(\mathbf{Z}[\mathbf{D}_{2m}])$ has 2-rank = 0, then there are infinitely many k for which X_k admits a \mathbf{D}_{2m} -action. More precisely, given p and q, relatively prime integers each $\equiv 1 \mod m$, X_k admits a \mathbf{D}_{2m} -action, where $k = (p^2 - 1)(q^2 - 1)/3$.

Let us first make some remarks about $\widetilde{K}_0(\mathbf{Z}[\mathbf{D}_{2m}])$. It is known that $\widetilde{K}_0(\mathbf{Z}[\mathbf{D}_{2m}]) = \Gamma$, the class group of the maximal real subfield of $\mathbf{Q}(\xi)$, where $\xi = e^{2\pi i/m}$. (See [L].) As shall be indicated below, we are interested in knowing for which m, Γ has 2-rank = 0. This is not known in general, however it is known that the class number h^+ , which is the order of γ , vanishes for primes $m \leq 67$. (See p. 38 and §3 of the appendix in [Wa].)

Our proof will depend upon an appropriate choice of a model Yon which to base our surgery constructions. We will then construct a D_{2m} -fiber homotopy equivalence over Y, and from it, an adjusted D_{2m} -normal map. A key feature of our construction will be an additional amount of symmetry built into the normal map. Finally, we will show that our set-up is such that all obstructions to surgery vanish. By varying the parameters of our construction, we will obtain infinitely many X_k as claimed. Our model Y and D_{2m} -fiber homotopy equivalence will be constructed so as to satisfy an important technical condition stated below as Definition 3.1 which will allow us to build from them an adjusted D_{2m} -normal map.

First, we set up some notation. Let G be finite. Given any irreducible, real G-representation ψ , we define $m_{\psi}: RO(G) \to \mathbb{Z}$ by setting $m_{\psi}(V)$ equal to the multiplicity of ψ in the virtual representation V. (RO(G) denotes the real representation ring of G.) Let d_{ψ} denote the dimension of the real division algebra of **R**-linear G-endomorphisms of ψ , $\operatorname{Hom}_{\mathbf{R}}^{G}(\psi, \psi)$.

DEFINITION 3.1 (Transversality Condition). Let $\omega: \eta_+ \to \eta_-$ be a *G*-fiber homotopy equivalence over the smooth *G*-manifold *Y*. For each $H \in \text{Iso}(Y) = \{G_y: y \in Y\}$ and each component $Y_{\alpha}^H \subseteq Y^H$ the following holds. Let $y \in Y_{\alpha}^H$. For each real *H*-representation ψ with $m_{\psi}(\eta_-|_{\psi}) \neq 0$ we have

$$\dim Y_{\alpha}^{H} = m_{1_{\mathfrak{p}}}(TY|_{y}) \le d_{\psi}m_{\psi}(TY + \eta_{+} - \eta_{-}|_{y}) + d_{\psi} - 1.$$

If the transversality condition is met, there are no obstructions to moving ω by a proper G-homotopy to a smooth G-map h which is transverse to Y, the zero-section of η_- . We then set $X = h^{-1}(Y)$, $f = h|_X$, and b is constructed using the G-vector bundles η_{\pm} . More precisely, for $H \subseteq G$, we set $X^H = (f^H)^{-1}(Y^H)$. Note that if a path component X^H_{α} lies in $(f^H)^{-1}(Y^H_{\beta})$, for some component $Y^H_{\beta} \subseteq Y^H$, then dim $X^H_{\alpha} = \dim Y^H_{\beta}$. Since ω is a G-fiber homotopy equivalence, we can choose the orientation of X so that the G-map f will be of degree 1.

At this point, provided that a few other conditions are met, the triple (X, f, b) will be a *G*-normal map (adjusted or otherwise). However, we shall see that in our case a little additional work will render (X, f, b) into an adjusted \mathbf{D}_{2m} -normal map.

There is an interesting S^1 -map due to Ted Petrie (see [MeP], p. 74) which will be used in our constructions. Given a pair of relatively prime integers p and q, take integers a and b such that -ap+bq = 1 and let t^i denote the 1-dimensional complex S^1 -representation where $t \in S^1$ acts on C by $t \cdot z = t^i z$ (complex multiplication). Define $f: t^{-2p} + t^{-2q} = V_+ \rightarrow t^{-2} + t^{-2pq} = V_-$ by $f(z_0, z_1) = (\overline{z}_0^a z_1^b, z_0^q + z_1^p)$. It can be shown that f is a proper S^1 -map such that deg $f^+ = 1$, where f^+ is the extension of f to 1 point compactifications.

In our proof, knowledge of the structure of $L_6^s(\mathbf{Z}[\mathbf{D}_{2m}], \omega)$, where $\mathbf{D}_{2m} = \langle g, h | g^m = h^2 = 1$, $gh = hg^{-1} \rangle$, w(g) = 1, and w(h) = -1, will be essential.

LEMMA 3.2. Assume that *m* is such that $\widetilde{K}_0(\mathbb{Z}[\mathbb{D}_{2m}])$ has no 2-torsion. Then, $L_6^s(\mathbb{Z}[\mathbb{D}_{2m}], w)$ decomposes into a direct sum $L_6^s(\mathbb{Z}[\mathbb{Z}_2], ID) \oplus \widetilde{L}(\mathbb{D}_{2m})$, where $\widetilde{L}(\mathbb{D}_{2m})$ is torsion free and $ID: \mathbb{Z}_2 \to \mathbb{Z}_2$ denotes the identity map. In particular, as indicated above, this result holds for primes $m \leq 67$.

Proof. First, note that the retraction and inclusion $\mathbf{D}_{2m} \xrightarrow{r} \mathbf{Z}_2 \xrightarrow{i} \mathbf{D}_{2m}$ are compatible with the respective orientation homomorphisms; that is,

is a commutative diagram, where $r(g^i h^{\varepsilon}) = h^{\varepsilon}$ ($\varepsilon = 0, 1$). Using the functorial properties of $L^s(\cdot)$ (see [W2]), it follows that $L_6^s(\mathbb{Z}[\mathbb{Z}_2], \mathrm{ID})$ is a direct summand of $L_6^s(\mathbb{Z}[\mathbb{D}_{2m}], \omega)$. (Note that ID: $\mathbb{Z}_2 \to \mathbb{Z}_2$ is different from the trivial map 1: $\mathbb{Z}_2 \to \mathbb{Z}_2$.) Therefore, $L_6^s(\mathbb{Z}[\mathbb{Z}_2], \mathrm{ID})$ is obtained by restriction. Now, according to [W3], $\tilde{L}(\mathbb{D}_{2m})$ will be torsion free whenever the projective class group $\tilde{K}_0(\mathbb{Z}[\mathbb{D}_{2m}])$ has no 2-torsion. (Also see [W1], p. 71-74. Beware of the mistakes in [W3]. They are corrected in [W1]. In these references, the computations are of $L'(\cdot)$, the surgery obstruction group for weakly simple homotopy equivalences. However, since $Wh(\mathbb{Z}[\mathbb{Z}_2]) = 0$ and $Wh(\mathbb{Z}[\mathbb{D}_{2m}])$ is torsion free, it turns out that for these groups and our orientation homomorphisms, $L'(\cdot) = L^s(\cdot)$. This is discussed on pp. 77-78 of [W1].)

Lemma 3.2 shall be very useful to us in determining whether or not an obstruction in $L_6^s(\mathbb{Z}[\mathbb{D}_{2m}], w)$ vanishes because nontrivial elements of $\widetilde{L}(\mathbb{D}_{2m})$ can be detected by the multisignature (since it's torsion free), whereas those of $L_6^s(\mathbb{Z}[\mathbb{Z}_2], \mathbb{ID})$ are detected by the Kervaire-Arf invariant. Indeed, according to Theorem 4.14 of [W4], $L_6^s(\mathbb{Z}[\mathbb{Z}_2], \mathbb{ID})$ is isomorphic to \mathbb{Z}_2 via the Kervaire-Arf invariant. (\mathbb{IA} [W4], $\widetilde{\mathscr{S}}$ is L^h . However, since $Wh(\mathbb{Z}_2) = 0$, we have $L_6^h(\mathbb{Z}[\mathbb{Z}_2], \mathbb{ID})$ $= L_6^s(\mathbb{Z}[\mathbb{Z}_2], \mathbb{ID})$.) Now, suppose the obstruction in question is associated to a normal map constructed from twice a fiber homotopy equivalence. Then since the projection from $L_6'(\mathbb{Z}[\mathbb{D}_{2m}], \omega)$ onto $L'_6(\mathbb{Z}[\mathbb{Z}_2], \mathrm{ID})$ is obtained by restricting the group action it follows that the Kervaire-Arf invariant of the obstruction vanishes. This follows from the fact that the Kervaire-Arf invariant can be given in terms of the Kervaire-Sullivan classes via Sullivan's characteristic variety formula (as found, for instance, on p. 152 of [**BM**]). The primitivity of these classes implies that a normal map obtained from twice a fiber homotopy equivalence will have vanishing Kervaire-Arf invariant.

We are now ready to handle the proof of Theorem A.

Proof of Theorem A. Let \mathbf{D}_{2m} be the dihedral group of order 2m, for m an odd prime such that $\widetilde{K}_0(\mathbf{Z}[\mathbf{D}_{2m}]) = 0$ has no 2-torsion. We choose our model Y to be $\mathbb{C}P^3$ with the following \mathbf{D}_{2m} -action. If gis a chosen generator of $\mathbf{Z}_m \subset \mathbf{D}_{2m}$, and $z = [z_0: z_1: z_2: z_3] \in \mathbb{C}P^3 =$ $P(\mathbb{C}^4)$, then $g \cdot z = [\xi z_0: \xi z_1: \xi^{-1} z_2: \xi^{-1} z_3]$, where $\xi = e^{2\pi i/m}$. Also, we set $h \cdot z = [-\overline{z_1}: \overline{z_0}: -\overline{z_3}: \overline{z_2}]$. There are several things to notice about this action. First of all, we actually do have a \mathbf{D}_{2m} -action as $g^m \cdot z = z$, $h^2 \cdot z = [-z_0: -z_1: -z_2: -z_3] = [z_0: z_1: z_2: z_3] = z$, and $gh \cdot z = g \cdot [-\overline{z_1}: \overline{z_0}: -\overline{z_3}: \overline{z_2}] = [-\xi \overline{z_1}: \xi \overline{z_0}: -\xi^{-1} \overline{z_3}: \xi^{-1} \overline{z_2}] =$ $[-\xi^{-1} z_1: \xi^{-1} z_0: -\xi z_3: \xi z_2] = h[\xi^{-1} z_0: \xi^{-1} z_1: \xi z_2: \xi z_3] = hg^{-1} \cdot z$. It follows from an easy computation that h is a free, orientation reversing involution of $Y = \mathbb{C}P^3$. We also have that g^ih is free on Y for $i = 1, \ldots, m - 1$ and therefore that $Iso(Y) = \{1, \mathbf{Z}_m = \langle g \rangle\}$. Notice that $Y^{z_m} = Y_{01} \amalg Y_{23}$, where $Y_{01} = \{[z_0: z_1: 0: 0]: z_0, z_1 \in \mathbb{C}\} = \mathbb{C}P^1$, and Y_{23} is similarly defined. Now we can proceed to the construction of an appropriate \mathbf{D}_{2m} -fiber homotopy equivalence.

Let Σ denote the sphere $S^7 = S(\mathbb{C}^4)$ with the lifted maps g and h acting on it. Notice that these maps do not quite induce a \mathbb{D}_{2m} -action on Σ because $h^2(a_0, a_1, a_2, a_3) = (-a_0, -a_1, -a_2, -a_3)$, for $(a_0, a_1, a_2, a_3) \in \Sigma$. However, we do get a \mathbb{D}_{2m} -action on the V_{\pm} -bundles associated to the S^1 -principal bundle $\Sigma \to Y$, that is, on $\Sigma \times_{S^1} V_{\pm} = \eta_{\pm}$, where $V_+ = t^{-2p} + t^{-2q}$ and $V_- = t^{-2} + t^{-2pq}$ as above. (Recall that if X and Y are G-spaces, then the twisted product $X \times_G Y$ is the orbit space $(X \times Y)/G$, where $g(x, y) = (xg^{-1}, gy)$ for all $(x, y) \in X \times Y$ and all $g \in G$.) The \mathbb{D}_{2m} -action on $\Sigma \times_{S^1} V_{\pm}$ is given by g[a, v] = [ga, v], where [a, v] is the point in the orbit space corresponding to $(a, v) \in \Sigma \times V_{\pm}$. In particular, $h^2[a, v] = [h^2a, v] = [-a, v] = [a, (-1) \cdot v] = [a, v]$. (Indeed, say $v = (v_1, v_2) \in V_+$. Then, $(-1) \cdot v = ((-1)^{-2p}v_1, (-1)^{-2q}v_2) = (v_1, v_2) = v$.) In this way, η_{\pm} become \mathbb{D}_{2m} -vector bundles. We construct $\omega: \eta_+ \to \eta_-$ by taking $\mathrm{Id} \times f$, where $f: V_+ \to V_-$ is

Petrie's map introduced previously, and passing to S^1 -orbit spaces. Since deg $f^+ = 1$, we need only check the degree condition on ω for isotropy groups $H \neq 1$. Now, the only non-trivial element of Iso(Y) is \mathbb{Z}_m . So, we must show that, for all $y \in Y_{01} \cup Y_{23}$, $(\omega|_y)^{\mathbb{Z}_m}$ has degree 1 when extended to 1 point compactifications.

At this point, we make the assumption that the relatively prime integers p and q are each $\equiv 1 \mod m$. Let ρ denote the 1-dimensional complex \mathbb{Z}_m -representation which sends a generator to multiplication by $e^{2\pi i/m}$. Then, restricting the \mathbb{D}_{2m} -action on Y to \mathbb{Z}_m , we see that $\operatorname{res}_{\mathbb{Z}_m} Y = P(2\rho + 2\rho^{-1})$, where P(V) denotes the space of complex lines in the representation V. From this, it follows that for $y \in Y_{01}$, $\eta_+|_y = \rho^{-2q}$. Indeed, suppose $a \in \Sigma$ lies above y. Then $g[a, v] = [ga, v] = [\rho(g)a, v] = [a, \rho(g)v]$. Since p and q are each $\equiv 1 \mod m$, we can see that, as a \mathbb{Z}_m -representation, $\eta_+|_y = 2\rho^{-2}$. Similarly, we can compute that $\eta_-|_y = 2\rho^{-2}$, for any $y \in Y_{01}$, and that $\eta_{\pm}|_y = 2\rho^2$, for any $y \in Y_{23}$. This implies that $(\eta_{\pm})^{\mathbb{Z}_m} = Y_{01} \cup Y_{23}$ (as subsets of the zero section) and the required degree property easily follows. Therefore, ω is a \mathbb{D}_{2m} -fiber homotopy equivalence.

It will be useful to build a \mathbf{D}_{2m} -equivariant, free, orientation reversing involution into our fiber homotopy equivalence (and hence our normal map) to help with the signature obstruction which will arise later. Let $\varphi: Y \to Y$ be defined by $\varphi[z_0: z_1: z_2: z_3] = [-\overline{z_2}: -\overline{z_3}: \overline{z_0}: \overline{z_1}]$ and note that φ commutes with \mathbf{D}_{2m} . Notice that φ lifts to η_{\pm} in such a way that ω becomes a $\mathbf{D}_{2m} \times \mathbf{Z}_2$ -fiber homotopy equivalence. To see this, define $\varphi': \Sigma \to \Sigma$ to be the obvious \mathbf{D}_{2m} -map covering φ . Then $\widetilde{\varphi_{\pm}}: \eta_{\pm} \to \eta_{\pm}$ defined by $\widetilde{\varphi_{\pm}}[a, v] = [\varphi'(a), v]$ are involutions which cover φ and make η_{\pm} into $\mathbf{D}_{2m} \times \mathbf{Z}_2$ -vector bundles. It is easy to check that $\omega \circ \widetilde{\varphi_{\pm}} = \widetilde{\varphi_{-}} \circ \omega$ and therefore, that φ lifts to η_{\pm} in such a way that ω becomes a $\mathbf{D}_{2m} \times \mathbf{Z}_2$ -map. To see that ω is actually a $\mathbf{D}_{2m} \times \mathbf{Z}_2$ -fiber homotopy equivalence requires that the degree property be considered once again.

Things become a bit more complicated at this point since the addition of the involution φ into our action introduces new elements into $\operatorname{Iso}(Y)$. Let H_i be the group of order two generated by $\varphi g^j h$, for $j = 0, \ldots, m-1$. Then $\operatorname{Iso}(Y) = \{1, \mathbb{Z}_m, H_0, \ldots, H_{m-1}\}$ and $Y^{H_j} = CP^1 \amalg CP^1$ for all j. To see this note that $\varphi g^j h[z_0: z_1: z_2: z_3] = g^j \varphi h[z_0: z_1: z_2: z_3] = [\xi^j z_3: -\xi^j z_2: \xi^{-j} z_1: -\xi^{-j} z_0]$ and hence $Y^{H_j} = \{[z_0: i\xi^j z_1: z_1: i\xi^{-j} z_0]\} \amalg \{[z_0: -i\xi^j z_1: z_1: -i\xi^{-j} z_0]\}$, where $i = \sqrt{-1}$. Notice that $Y^{H_i} \cap Y^{H_j} = \emptyset$, for all i, j distinct. (One way to see this is: $z \in Y^{H_i} \cap Y^{H_j} \Rightarrow \varphi g^i h z = \varphi g^j h z \Rightarrow g^i h z = g^j h z \Rightarrow g^{j-i} z = z \Rightarrow z \in Y_{01} \amalg Y_{23}$. But these points are not fixed by H_i for any i.)

Now, take $y \in Y$ with isotropy group equal to $(\mathbf{D}_{2m} \times \mathbf{Z}_2)_y = H_i = \mathbf{Z}_2$, for some $i \in \{0, \ldots, m-1\}$. When the action on Y is restricted to H_i , it is \mathbf{Z}_2 -diffeomorphic to P(1+1+h+h), where h denotes the non-trivial 1-dimensional complex \mathbf{Z}_2 -representation. (Just write the linear action of H_i in terms of irreducible \mathbf{Z}_2 -representations.) Therefore, as H_i -representations, $\eta_{\pm}|_y$ will be equivalent to $2 \cdot 1_{H_i}$, where 1_{H_i} denotes the 1-dimensional complex trivial H_i -representation. (Note that, for instance, if $y \in P(h+h)$, $\eta_{\pm}|_y = 2h^{2p} + 2h^{-2q} = 2 \cdot 1_{H_i}$.) Using the fact that deg $f^+ = 1$, it is not hard to check that ω is indeed a $\mathbf{D}_{2m} \times \mathbf{Z}_2$ -fiber homotopy equivalence.

The $D_{2m} \times \mathbb{Z}_2$ -fiber homotopy equivalence which we shall work with is $\tilde{\omega} = \omega \oplus \oplus : \tilde{\eta_+} = \eta_+ \oplus \eta_+ \to \tilde{\eta_-} = \eta_- \oplus \eta_-$. We first verify that the transversality condition holds.

We need to show that given $y \in Y$ and an irreducible $(\mathbf{D}_{2m} \times \mathbf{Z}_2)_y$ -representation ψ with $m_{\psi}(\tilde{\eta}_-|_y) \neq 0$, we have

$$m_{1_{\mathbf{p}}}(TY|_{y}) \leq d_{\psi}m_{\psi}(TY + \widetilde{\eta_{+}} - \widetilde{\eta_{-}}|_{y}) + d_{\psi} - 1.$$

First, take $y \in Y$ with $(\mathbf{D}_{2m} \times \mathbf{Z}_2)_y = H_i = \mathbf{Z}_2$, for some $i \in \{1, \ldots, m-1\}$. Previous considerations show us that $(\widetilde{\eta_+} - \widetilde{\eta_-})|_y = 4 \cdot 1_{H_i} - 4 \cdot 1_{H_i} = 0$ in $RO(\mathbf{Z}_2)$. Also, for such y, $TY|_y = 1_{H_i} + 2h$. Since $d_h = 1$, we have $m_{1_{\mathbf{R}}}(TY|_y) = 2 \leq m_h(TY + \widetilde{\eta_+} - \widetilde{\eta_-}|_y) = 4$, as desired. (Recall that m_{ψ} counts multiplicity as real representations.) Similarly, the desired result holds for $\psi = 1_{H_i}$.

Next, take $y \in Y$ with $G_y = \mathbb{Z}_m$. The restricted \mathbb{Z}_m -action on Y is equivalent to $P(2\rho + 2\rho^{-1})$, where ρ is the standard \mathbb{Z}_m -representation as above. If $y \in Y_{01}$, then $TY|_y = 1 + 2\rho^{-2}$, while $\widetilde{\eta_+} - \widetilde{\eta_-}|_y = 4\rho^{-2} - 4\rho^{-2}$, by choice of p and q. If $y \in Y_{23}$, then $TY|_y = 2\rho^2 + 1$ and $\widetilde{\eta_+} - \widetilde{\eta_-}|_y = 4\rho^2 - 4\rho^2$. In either case, it is quite easy to verify the transversality condition. Of course, the stability condition holds when y has trivial isotropy group.

Now that the transversality condition has been verified, we can construct the smooth G-manifold X, the G-map $f: X \to Y$ of degree 1, and the stable G-vector bundle isomorphism b as indicated above.

Notice that $\operatorname{Iso}(\widetilde{\eta_+}) \subseteq \operatorname{Iso}(Y)$. Indeed, due to the nature of our action, if H is not in $\operatorname{Iso}(Y)$, then it acts without fixed points on Y and hence cannot be in $\operatorname{Iso}(\widetilde{\eta_+})$. This guarantees that $\operatorname{Iso}(X) = \operatorname{Iso}(Y)$. We also note that X satisfies the gap hypothesis since Y

clearly does. Finally, we mention that Y and all of its fixed point set components under the G-action are simply connected.

It follows from our construction that $X^{\mathbb{Z}_m}$ is $\mathbb{D}_{2m}/\mathbb{Z}_m$ -diffeomorphic to $Y^{\mathbb{Z}_m}$. This is a result of the fact that $1_{\mathbb{Z}_m}$ is not a sub-representation of $\widetilde{\eta_{\pm}}|_y$ for any $y \in Y^{\mathbb{Z}_m}$. Now, given $H_j \in \mathrm{Iso}(Y)$, write Y^{H_j} as $Y_0^{H_j} \amalg Y_1^{H_j}$. At this point, we do 0 and 1-dimensional equivariant surgeries on X, $X_0^{H_j} = (f^{H_j})^{-1}(Y_0^{H_j})$, and $X_1^{H_j} = (f^{H_j})^{-1}(Y_1^{H_j})$. This makes X a connected and simply connected $\mathbb{D}_{2m} \times \mathbb{Z}_2$ -manifold and provides $N_{\mathbb{D}_{2m} \times \mathbb{Z}_2}(H_j)/H_j = \langle g^{j}h \rangle \times \mathbb{Z}_2$ -homotopy equivalences between $X_i^{H_j}$ and $Y_i^{H_j}$, for i = 0, 1. (Indeed, since the $X_i^{H_j}$'s are simply connected, closed surfaces, they are 2-spheres i.e., $\mathbb{C}P^1$'s. The map $f|_{X_i^{H_j}}$ is a map degree 1 between spheres and is hence a homotopy equivalence. It is actually a $\langle g^j h \rangle \times \mathbb{Z}_2$ -homotopy equivalence since the action of this group is free.) At this stage, we forget about the $\mathbb{Z}_2 = \{1, \varphi\}$ -action, except to state that we now have an adjusted \mathbb{D}_{2m} normal map (X, f, b) with target Y such that the \mathbb{D}_{2m} -manifold X admits a \mathbb{D}_{2m} -equivariant, orientation reversing involution.

We now consider the surgery obstruction $\sigma_1(f, b) \in L_6^h(\mathbb{Z}[\mathbb{D}_{2m}], w)$. Since (X, f, b) is an adjusted \mathbb{D}_{2m} -normal map with f^s an equivariant diffeomorphism, we see that according to Lemmas 2.5 and 2.6, $\alpha_G(\sigma_1(f, b)) = 0$. Therefore, $\sigma_1(f, b)$ comes from an element $\sigma_1^s(f, b) \in L_6^s(\mathbb{Z}[\mathbb{D}_{2m}], w)$.

According to the paragraph after Lemma 3.2, the Kervaire-Arf invariant of $\sigma_1^s(f, b)$ vanishes as the \mathbf{D}_{2m} -fiber homotopy equivalence $\tilde{\omega}$ is twice a fiber homotopy equivalence by construction. Therefore, $\sigma_1^s(f, b)$ must lie in the free part of $L_6^s(\mathbf{Z}[\mathbf{D}_{2m}], w)$. (Also relevant is the formula due to Masuda [M2], which considers the Kervaire-Arf invariant for obstructions in $L(\mathbf{Z}[1], 1)$ obtained from certain fiber homotopy equivalences which are related to ours. We note that the inclusion $1 \to \mathbf{Z}_2$ induces an isomorphism $L(\mathbf{Z}[1], 1) \to L(\mathbf{Z}[\mathbf{Z}_2], \mathrm{ID})$. See p. 164 of [W2].)

Now, let $\Gamma = \{ all cyclic subgroups of <math>\mathbf{D}_{2m} \}$. According to the Dress Induction Theorem found in [Dr], $L^{s}(\cdot) \otimes \mathbf{Q}$ is Γ -computable which implies that

$$L_6^s(\mathbf{Z}[\mathbf{D}_{2m}], w) \otimes \mathbf{Q} \xrightarrow{\operatorname{Res}} \prod_{H \in \Gamma} L_6^s(\mathbf{Z}[H], w|_H) \otimes \mathbf{Q}$$

is an injection, where Res gives coordinate-wise restriction. Now, if H is of order 1 or 2, then $\operatorname{Res}_H(\sigma_1^s(f, b) \otimes \mathbf{Q}) = 0$ because $L_6^s(\mathbf{Z}[1], 1)$

and $L_6^s(\mathbb{Z}[\mathbb{Z}_2], \mathrm{ID})$ are each isomorphic to \mathbb{Z}_2 as mentioned above. That leaves us only with $\operatorname{Res}_{\mathbb{Z}_m}(\sigma_1^s(f, b) \otimes \mathbb{Q}) \in L_6^s(\mathbb{Z}[\mathbb{Z}_m], 1) \otimes \mathbb{Q}$ and this term can be shown to vanish. Indeed, let $\operatorname{Res}_{\mathbb{Z}_m}(\sigma_1^s(f, b)) \in L_6^s(\mathbb{Z}[\mathbb{Z}_m], 1)$ denote the obstruction obtained by restricting the \mathbb{D}_{2m} action to \mathbb{Z}_m . Since the restricted orientation homomorphism is trivial, Petrie's formula ([P1]) applies and tells us that

$$\operatorname{Sign}(\operatorname{Res}_{\mathbf{Z}_m}(\sigma_1^s(f, b))) = \operatorname{Sign}(\mathbf{Z}_m, X) - \operatorname{Sign}(\mathbf{Z}_m, Y).$$

Now, by construction, X admits a \mathbb{Z}_m -equivariant, orientation reversing involution and this guarantees that $\operatorname{Sign}(\mathbb{Z}_m, X) = 0$. (Indeed, whenever a G-manifold M admits G-equivariant, orientation reversing diffeomorphism, we have that $\operatorname{Sign}(G, M) = 0$.) Since $\operatorname{Sign}(\mathbb{Z}_m, Y)$ is obviously 0, we have that $\operatorname{Sign}(\operatorname{Res}_m(\sigma_1^s(f, b))) = 0$. But this implies that $\operatorname{Res}_{\mathbb{Z}_m}(\sigma_1^s(f, b) \otimes \mathbb{Q})$ vanishes because the torsion free part of $L_6^s(\mathbb{Z}[\mathbb{Z}_m], 1)$ is detected by the multisignature. Hence, by the injectivity of Res, we have that $\sigma_1^s(f, b) \otimes \mathbb{Q} = 0$. This means that $\sigma_1^s(f, b)$ lies in the torsion part of $L_6^s(\mathbb{Z}[\mathbb{D}_{2m}], w)$ and as we saw this implies that $\sigma_1^s(f, b) = 0$. Thus, $\sigma_1(f, b) = 0$ in $L_6^h(\mathbb{Z}[\mathbb{D}_{2m}], w)$ and we can use \mathbb{D}_{2m} -surgery to construct the triple $(X_{\tilde{\eta}}, F, B)$, where $F: X_{\tilde{\eta}} \to Y = \mathbb{C}P^3$ is a \mathbb{D}_{2m} -homotopy equivalence.

The stable G-vector bundle isomorphism B between $TX_{\tilde{\eta}}$ and $F^*(TY + \tilde{\eta_+} - \tilde{\eta_-})$ allows us to compute the Pontryagin class of the smooth manifold $X_{\tilde{\eta}}$. In particular, the first Pontryagin class is given by $p_1(X_{\tilde{\eta}}) = (4 + 8(p^2 - 1)(q^2 - 1))x^2$, where $x \in H^2(X_{\tilde{\eta}})$ is a generator. (See [H] §§6 and 7 for more details on this calculation.) So, $X_{\tilde{\eta}} = X_k$, where $k = (p^2 - 1)(q^2 - 1)/3$ and by varying p and q (within the constraints that p and q are relatively prime and each $\equiv 1 \mod m$) we can build \mathbf{D}_{2m} -actions for infinitely many k.
