ABELIAN GROUPS CHARACTERIZED BY THEIR INDEPENDENT SUBSETS

Wu-Chung Hsiang

1. Introduction. Recently, the theory of abelian groups has become an active field. This note is devoted to it. One of the important theorems, called "the theorem on the subgroups of a free abelian group U_n of finite rank n [2, p. 145] will be studied here. From now on the term "group" will be used instead of "abelian group", for simplicity. Since the notations, the definitions, and the terminologies vary for different authors, we refer to Kurosh [2] and Kaplansky [1] as standards. For example, for the definitions of the height of an element x in a primary group G (denoted by $h_G(x)$), of the lowest layer of a primary group we refer to [2], and the definitions, of Z(n), of $Z(p^{\infty})$ we refer to [1]. Moreover, the subgroups spanned by the subset $\{u_{\alpha}\}$ of a given group G is denoted by $(\{u_{\alpha}\})$, and in a primary group we write o(x) = n if the order of the element x is equal to p^n .

For convenience, the following terminology is adopted.

- I. A group G has property (A), if for any non-zero element x of G there exists a cyclic direct summand of G containing x.
- II. A group G has property (B), if G is a direct sum of cyclic groups, and for any subgroup H of G there exists a basis $\{h_{\alpha}\}$ of H and a basis $\{g_{\beta}\}$ of G such that for any $h_{\alpha} \in \{h_{\alpha}\}$ we can find a $g_{\alpha} \in \{g_{\beta}\}$ with the property $h_{\alpha} \in \{g_{\alpha}\}$.
- III. A group G has property (C), if for any independent subset $\{h_x\}$ of G there exists another independent subset $\{g_\alpha\}$ of G such that $h_\alpha \in (g_\alpha)$ and $(\{g_\alpha\})$ is a direct summand of G.

The purpose of this paper is to give an analysis of these classes of groups. In particular, we show that a free group U_n of finite rank $n \ge 2$ has properties (A) and (B) but not (C).

GENERAL LEMMA. A torsion group G has property (A), (B) or (C) respectively, if and only if each of its primary components has property (A), (B) or (C) respectively.

Proof. We decompose G into its primary components,

$$G = \sum_{p} \bigoplus G_{p}$$
.

We prove that G has property (C) if and only if each G_p has property (C). If for an independent subset $\{x_{\alpha}^{(p)}\} \subset G_p$, we can find an independent subset $\{g_{\alpha}\} \subset G$ such that $x_{\alpha}^{(p)} \in (g_{\alpha})$ for all α , and the subgroup

$$\sum_{\alpha} \bigoplus (g_{\alpha})$$

is a direct summand of G, then we can find a subset $\{g_{\alpha}^{(p)}\} \subset G_p$ such that $x_{\alpha}^{(p)} \in (g_{\alpha}^{(p)})$ and $\sum_{\alpha} \bigoplus (g_{\alpha}^{(p)})$ is a direct summand of G_p . To find the desired subset $\{g_{\alpha}^{(p)}\} \subset G_p$, we need only consider the p-components of g_{α} 's, since $x_{\alpha}^{(p)} \in (g_{\alpha})$ implies that $x_{\alpha}^{(p)}$ is contained in the p-component of (g_{α}) which is a cyclic subgroup of G_p generated by the p-component of g_{α} .

Conversely, if for every p-component $\{x_{\alpha}^{(p)}\} \subset G_p$ of an independent subset $\{x_{\alpha}\} \subset G$, we can find an independent subset $\{g_{\alpha}^{(p)}\}$ such that $x_{\alpha}^{(p)} \in (g_{\alpha}^{(p)})$ for all α 's and the subgroup $\sum_{\alpha} \bigoplus (g_{\alpha}^{(p)})$ is a direct summand of G_p , then there exists an independent subset $\{g_{\alpha}\} \subset G$ such that $x_{\alpha} \in (g_{\alpha})$ for all α 's and the subgroup $\sum_{\alpha} \bigoplus (g_{\alpha})$ is a direct summand of G. Since every x_{α} has only a finite number of p-components different from zero, we can set $g_{\alpha}^{(p)} = 0$ when $x_{\alpha}^{(p)} = 0$. To find the desired subset $\{g_{\alpha}\} \subset G$, we need only set

$$g_{\alpha} = \sum_{p} g_{\alpha}^{(p)}$$
.

The independence of $\{g_{\alpha}\}$ follows from the independence of $\{g_{\alpha}^{(p)}\}$ for all p, and $x_{\alpha} \in (g_{\alpha})$ follows from

$$(x_{\alpha}) = \sum_{p} \bigoplus (x_{\alpha}^{(p)}) \subset \sum_{p} \bigoplus (g_{\alpha}^{(p)}) = (g_{\alpha}).$$

The other two parts of the lemma are proved in an analagous manner.

2. Groups with property (A). To discuss groups with property (A), we need several lemmas.

LEMMA I. If G is a primary cyclic group of the type $Z(p^n)$, and x is a non-zero element of G, then

$$o(x) + h_G(x) = n.$$

This is clear.

LEMMA II. If G is a primary group of the type

$$Z(p^{h_1}) \bigoplus Z(p^{h_2}) \bigoplus H$$

where $3 \le h_1 + 2 \le h_2$, then it is not a group with property (A).

Proof. Let u_1 , u_2 be the generators of $Z(p^{h_1})$, $Z(p^{h_2})$ respectively. Therefore,

$$o(u_2) = h_2 \ge h_1 + 2 = o(u_1) + 2$$
.

To prove Lemma II, it is sufficient to show that there does not exist

any cyclic direct summand of G containing $p^{h_1-1}u_1+p^{h_1}u_2$. Suppose the contrary. Then, we can find a cyclic direct summand V=(v) containing $p^{h_1-1}u_1+p^{h_1}u_2$. Since $h_2-2\geq h_1$, it is clear that the lowest layers of V and of the cyclic group $(p^{h_1-1}u_1+p^{h_1}u_2)$ are both equal to $(p^{h_2-1}u_2)$, and $o(p^{h_1-1}u_1+p^{h_1}u_2)=h_2-h_1$. Let o(v)=k. Since (v) and (u_2) are direct summands of G,

$$h_G(p^{k-1}v) = h_V(p^{k-1}v) = k-1$$

and

$$h_G(p^{h_2-1}u_2)=h_V(p^{h_2-1}u_2)=h_2-1$$
.

But since the lowest layer of (v) is $(p^{k-1}v) = (p^{h_2-1}u_2)$, we have $k-1 = h_2 - 1$, and $o(v) = k = h_2$. Therefore, it follows from Lemma I that

$$h_{\nu}(p^{h_1-1}u_1+p^{h_1}u_2)=h_2-(h_2-h_1)=h_1$$
.

On the other hand, we have

$$h_{\mathcal{G}}(p^{h_1-1}u_1+p^{h_1}u_2)=\min(h_1-1,h_1)=h_1-1$$
.

This is a contradiction since V = (v), being a direct summand, is a pure subgroup of G, so that for $x \in V$, $h_V(x) = h_G(x)$.

LEMMA III. A primary group G has property (A) if and only if it is of the type

$$\sum_{\rho} \bigoplus Z_{\rho}(p^h) \bigoplus \sum_{\lambda} \bigoplus Z_{\lambda}(p^{h+1})$$
.

Proof. First, G must be a reduced group. If this is not the case, we can find a non-zero x of G which is of infinite height in G. It is clear that x cannot be contained in a cyclic direct summand (g) of G. Second, G must be of bounded order, therefore G is a direct sum of cyclic groups. Otherwise, by [1, Theorem 9] there exists a direct summand $(u_1) \oplus (u_2)$ of G of the type

$$Z(p^{h_1}) \bigoplus Z(p^{h_2}),$$
 $3 \leq h_1 + 2 \leq h_2.$

Then, by Lemma II, G is not a group with property (A). Moreover, the bounded group G must be of the type

$$\sum_{

.

Conversely, if G is of the type

$$\sum_{
ho} igoplus Z_{
ho}(p^h) igoplus \sum_{\lambda} igoplus Z_{\lambda}(p^{h+1})$$
 ,

we claim that it is a group with property (A). Let $\{u_{\rho}\}$ and $\{u_{\lambda}\}$ be

the generators of the cyclic subgroups of the type $Z_{\rho}(p^h)$ and $Z_{\lambda}(p^{h+1})$ respectively. Then, for any non-zero $x \in G$, we can express it as

$$\sum_{1}^{s} a_i p^{i_i} u_{
ho_i} + \sum_{s+1}^{t} b_j p^{i_j} u_{\lambda_j}$$

such that $(a_i, p) = (b_j, p) = 1$ and $0 \le l_i < h$, $0 \le l_j \le h$. It is obvious that

$$h_G(x) = \min (l_1, \dots, l_s, l_{s+1}, \dots, l_t)$$

 $o(x) = \max (h - l_1, \dots, h - l_s, h + 1 - l_{s+1}, \dots, h + 1 - l_t)$.

If o(x) is equal to a certain $h - l_i(1 \le i \le s)$, that is $h - l_i$, then the generator \tilde{x} of the lowest layer of (x) is of height h - 1 in G. Since

$$egin{align} h-l_1 &\geq h-l_i & (1 \leq i \leq s) \ h-l_1 &\geq h+1-l_i & (s+1 \leq j \leq t) \ , \end{array}$$

we have

$$egin{aligned} l_1 & \leq l_i & (1 \leq i \leq s) \ l_1 < l_1 & (s+1 \leq j \leq t) \ . \end{aligned}$$

Hence, the cyclic subgroup

$$\left(\sum_{1}^{s} a_{i} p^{l_{i}-l_{1}} u_{p_{i}} + \sum_{s+1}^{t} b_{j} p^{l_{j}-l_{1}} u_{\lambda_{j}}\right)$$

is pure, and by [1, Theorem 7] is a direct summand, which contains the element x. The cyclic subgroup is pure by [1, Lemma 7].

If o(x) is equal to a certain $h+1-l_j(s+1 \le j \le t)$, that is $h+1-l_{s+1}$, but not equal to any $h-l_i(1 \le i \le s)$, then the generator \tilde{x} of the lowest layer of (x) is of height h in G. We have

$$l_i > l_{s+1} - 1$$
 $(1 \le i \le s)$
 $l_j \ge l_{s+1}$ $(s+1 \le j \le t)$.

Consequently, by the same argument as we used above,

$$\left(\textstyle\sum\limits_{1}^{s}a_{i}p^{l_{i}-1_{s+1}}u_{\mathsf{p}_{i}}+\sum\limits_{s+1}^{t}b_{j}p^{l_{j}-l_{s+1}}u_{\lambda_{j}}\right)$$

is the desired direct summand containing x. This proves our lemma.

THEOREM A_1 . A group G with property (A) cannot be mixed, i.e., it is either torsion or torsion-free. Moreover, a torsion group G has property (A) if and only if G is of the type

$$\textstyle\sum_{\mathbf{p}} \bigoplus \left(\sum_{\alpha_{\mathbf{p}}} \bigoplus Z_{\alpha_{\mathbf{p}}}(p^{n_{\mathbf{p}}}) \oplus \sum_{\beta_{\mathbf{p}}} \bigoplus Z_{\beta_{\mathbf{p}}}(p^{n_{\mathbf{p}}+1})\right).$$

Proof. If G is a torsion group, the theorem follows from the General lemma, and Lemma III. Now, we are going to prove that G cannot be mixed. If G has property (A), then the torsion subgroup T(G) of G must be of the type

$$\sum_{p} igoplus \left(\sum_{lpha_{p}} igoplus Z_{lpha_{p}}(p^{lpha_{p}}) igoplus \sum_{eta_{p}} igoplus Z_{eta_{p}}(p^{lpha_{p+1}})
ight).$$

If this is not the case, T(G) does not have property (A), and there exists a non-zero element $x \in T(G)$ which is not contained in any cyclic direct summand (g) of T(G), and therefore, it cannot be contained in a cyclic direct summand of G. We shall prove that if $T(G) \neq 0$, then G = T(G). Suppose the contrary. There exists a non-zero $x \in G$, such that we can find an infinite cyclic direct summand (u_1) of G containing x. Select a non-zero primary component $T_{p_1}(G)$ of G, which is of the type

$${\textstyle\sum\limits_{\lambda_{p_{_{1}}}}} \bigoplus Z_{\lambda_{p_{_{1}}}}(p_{_{1}}{^{h_{p_{_{1}}}}}) \bigoplus {\textstyle\sum\limits_{\mu_{q_{_{1}}}}} \bigoplus Z_{\mu_{p_{_{1}}}}(p^{^{h_{p_{_{1}}}+1}}) \ .$$

We have

$$G = (u_1) \bigoplus T_{p_1}(G) \bigoplus G'$$
,

by [1 Theorem 7]. Consider the element $p_1^s u_1 + a_{p_1}$, where $s > h_{p_1} + 1 \ge 1$ and $h_{T_{p_1}}(G)(a_{p_1}) = 0$. Since G has property (A), there exists a cyclic direct summand (g) containing $p_1^s u_1 + a_{p_1}$. We have

$$g = l_{\scriptscriptstyle 1} u_{\scriptscriptstyle 1} + b_{\scriptscriptstyle p_{\scriptscriptstyle 1}} + g'$$
, where $g' \in G'$, $b_{\scriptscriptstyle p_{\scriptscriptstyle 1}} \in T_{\scriptscriptstyle p_{\scriptscriptstyle 1}}(G)$.

By the hypothesis, there exists an integer l such that

$$lg = ll_1u_1 + lb_{p1} + lg' = p_1^su_1 + a_{p_1}$$
.

Consequently, we have

$$l=p_{\scriptscriptstyle \rm I}^{\scriptscriptstyle c}$$
 , $l_{\scriptscriptstyle \rm I}=p_{\scriptscriptstyle \rm I}^{\scriptscriptstyle d}$, and $g'=0$, where $c+d=s$.

Thus

$$g = b_{p_1} + p_1^d u_1$$
, and $a_{p_1} = p_1^c b_{p_1}$.

Since $h_{T_{p_1}(G)}(a_{p_1})=0$, we must have also c=0, that is l=1 and $g=p_1^su_1+a_{p_1}$. Hence $(p_1^su_1+a_{p_1})$ is a direct summand of G. Since

$$(p_1^su_1+a_{p_1})\subset T_{p_1}(G)\oplus (u_1)$$
 ,

we have that $(p_1^s u_1 + a_{p_1})$ is also a cyclic direct summand of $T_{p_1}(G) \oplus (u_1)$. It is clear that

$$T_{p_1}(G) \bigoplus (u_1) = T_{p_1}(G) \bigoplus (p_1^s u_1 + a_{p_1})$$
.

Then

$$u_1 = f(p_1^s u_1 + a_{p_1}) + b_{p_1} = f p_1^s u_1 + f a_{p_1} + b_{p_1}$$

for a non-zero integer f, and an element $b_{p_1} \in T_{p_1}(G)$. It follows that $u_1 = fp_1^su_1$, which contradicts s > 1. Therefore the proof is complete.

THEOREM A₂. A free group G has property (A).

Proof. Since $G = \sum_{\nu} \bigoplus (u_{\nu})$, each $x \neq 0$ in G can be written $x = a_1 u_{\nu_1} + a_2 u_{\nu_2} + \cdots + a_n u_{\nu_n}$. Hence

$$G = \sum_{1}^{n} \bigoplus (u_{\nu_i}) \bigoplus_{\nu \neq \nu_1, \dots, \nu_m} \bigoplus (u_{\nu})$$
 ,

and it follows from the theorem on the subgroups of a free group of rank n [2, p. 145], that there exist a basis v_1, v_2, \dots, v_n of $\sum_{i=1}^{n} \bigoplus (u_{\nu_i})$ such that $x \in (v_1)$. But (v_1) is a direct summand of G, so that G has property (A).

REMARK. A torsion-free group with property (A) need not be a free group. The counter-example is the unrestricted direct sum of infinitely many infinite cyclic groups. This group has property (A) and is not free [2, p. 216].

EXAMPLE. Let G be the unrestricted direct sum of infinitely many infinite cyclic groups. Then G has property (A).

Proof. Let $g \in C$, $g = \sum_{i=1}^{\infty} k_i a_i$, where G is the unrestricted direct sum of infinite cyclic groups (a_i) . Let $m = (k_i, l = 1, 2, \cdots)$. Then g.c.d. there exists a finite subset of the k_i , say k_1, k_2, \cdots, k_n , such that g.c.d. $(k_1, k_2, \cdots, k_n) = m$. Then we have

$$g = \sum_{i=1}^{\infty} k_i a_i = \sum_{i=1}^{\infty} m l_i a_i = m \left\lceil \sum_{i=1}^{n} l_i a_i + \sum_{i=n+1}^{\infty} l_i a_i \right\rceil$$

where g.c.d. $(l_1, \dots, l_n) = 1$. Let

$$g_1 = \sum_{i=1}^n l_i a_i + \sum_{i=n+1}^\infty l_i a_i$$

and

$$H=\left\{h=\sum_{i=1}^{\infty}lpha_{i}a_{i}\in G|lpha_{i}=0,\ i=1,2,\cdot\cdot\cdot,n
ight\}$$
 .

Then G/H is isomorphic to $\sum_{1}^{n} \bigoplus (a)$, a free group of rank n. Now,

$$(H, g_1)/H = \left(\sum_{i=1}^n l_i a_i + H\right)$$

is a cyclic subgroup of G/H. By the theorem on subgroups of a free group of rank n, there exists a basis v_1, v_2, \dots, v_n of G/H such that

$$\sum_{i=1}^n l_i a_i + H \in (v_1) .$$

Thus

$$\sum\limits_{i=1}^{n}l_{i}a_{i}+H=ev_{1}=e\sum\limits_{i=1}^{n}eta_{i}a_{i}+H$$
 ,

so that $(e\beta_i-l_i)a_i=0$, $i=1,2,\cdots,n$. Hence $l_i=e\beta_i, i=1,2,\cdots,n$ and

g.c.d.
$$(l_1, l_2, \dots, l_n) = \text{g.c.d.}(e\beta_1, e\beta_2, \dots, e\beta_n) = e = 0$$
.

We have proved $\sum_{i=1}^{n} l_i a_i + H = v_1$, so that

$$G/H = \left(\sum_{i=1}^n l_i a_i + H\right) \oplus (v_2) \oplus \cdots \oplus (v_n) = (g_1 + H) \oplus G'/H$$
 .

Then $G = (g_1) \oplus G'$, and $g = mg_1 \in (g_1)$. The problem of characterization of torsion-free groups with property (A) is still open.

3. Groups with property (B). We prove first that for primary groups, properties (A) and (B) are equivalent.

LEMMA IV. A primary group G has property (B) if and only if it is of the type

$$\sum_{\lambda} \bigoplus Z_{\lambda}(p^{\lambda}) \bigoplus \sum_{\mu} \bigoplus Z_{\mu}(p^{\lambda+1})$$
.

Proof. The necessary condition follows from Lemma III since property (B) implies property (A). Conversely, suppose that $G \cong M \oplus N$ where

$$M\cong\sum\limits_{\lambda}\bigoplus Z_{\lambda}(p^{\hbar})$$
 and $N\cong\sum\limits_{\mu}\bigoplus Z_{\mu}(p^{\hbar+1})$.

Let H be a subgroup of G. Then, $^2(\overline{H} \cap \overline{M}) \subset \overline{H}$. Since both $\overline{H} \cap \overline{M}$ and \overline{H} are of bounded height in H, by [1, Lemma 11], applied to the primary group H, we have a basis $\{h_{\alpha_n}\} \cup \{h_{\alpha_n}\}$ of H such that

$$\overline{\sum_{\alpha_1} \bigoplus (h_{\alpha_1})} = (\overline{H} \cap \overline{M})$$

and

$$\overline{\sum_{lpha_1} \bigoplus (h_{lpha_1})} \oplus \overline{\sum_{lpha_2} \bigoplus (h_{lpha_2})} = \overline{H} \ .$$

² We denote the lowest layer of a primary group K by \overline{K} . Thus $\overline{K} = \{x \in K \mid px = 0\}$.

By Lemma III, every h_{α} is contained in a cyclic direct summand (g_{α}) of G. We are going to prove that $\{g_{\alpha}\} = \{g_{\alpha_1}\} \cup \{g_{\alpha_2}\}$ is a pure independent subset of G. The independence of $\{g_{\alpha}\}$ follows from the independence of $\{h_{\alpha_1}\} \cup \{h_{\alpha_2}\}$. We need only prove that

$$G_1 = \sum_{lpha} igoplus (g_{lpha}) = \sum_{lpha_1} igoplus (g_{lpha_1}) igoplus \sum_{lpha_2} igoplus (g_{lpha_2})$$

is pure in G. It is sufficient to prove that every $g_1 \in \overline{G}_1$ has the same height in G_1 as in G, by [1, Lemma 7]. The element $g_1(\neq 0) \in \overline{G}_1$ can be written as

$$g_1 = p^{h-1} \left[\sum_1^s l_i g_{a_{1_i}} \right] + p^h \left[\sum_{s+1}^t l_j g_{a_{2_j}} \right]$$

where $(l_i, p) = (l_j, p) = 1$.

If the first sum does not occur in the above expression for g_1 , $h_{G_1}(g_1) = h$, which is the maximal height of the element of order p in G, and we have $h_{G_1}(g_1) = h_{G}(g_1)$.

If the first sum does occur then $g_1 = g_1^{(M)} + g_1^{(N)}$ where $g_1^{(M)} (\neq 0) \in \overline{M}$ and $g_1^{(N)} \in \overline{N}$.

Since $G = M \oplus N$, it follows that

$$h_G(g_1) = \min(h_M(g_1^{(M)}), h_N(g_1^{(N)})) = h - 1$$

which is the minimal height of the element of order p in G_1 , hence $h_G(g_1) = h_{G_1}(g_1)$.

Therefore, $\{g_{\alpha}\}$ is a pure independent subset of G. By [1, Lemma 11] the set $\{g_{\alpha}\}$ can be enlarged to a basis $\{g_{\beta}\}$ of G, which is the desired one.

LEMMA V. A torsion free group G has property (B) if and only if it is a free group of finite rank.

Proof. If G is a free group of finite rank, by the theorem on the subgroups of a free group of finite rank, it has property (B).

It is well known that a group of order σ is isomorphic to a factor group of a free group of rank σ , and for any infinite cardinal ρ there exists a group of order ρ which is not a direct sum of cyclic groups. Since the group G with property (B) is a free group, we shall show that it must be of finite rank. Suppose to the contrary that G is of infinite rank. Then, select a subgroup V of G such that G/V is not a direct sum of cyclic groups. It is clear that G cannot have property (B) with respect to V.

THEOREM B. A group G has property (B) if and only if either

- (a) G is a free group of finite rank, or
- (b) G is of the type

$$\textstyle\sum_{\scriptscriptstyle p} \bigoplus \left(\sum_{\scriptscriptstyle \lambda_{\scriptscriptstyle p}} \bigoplus Z_{\scriptscriptstyle \lambda_{\scriptscriptstyle p}}(p^{\scriptscriptstyle h_{\scriptscriptstyle p}}) \bigoplus \sum_{\scriptscriptstyle \mu_{\scriptscriptstyle p}} \bigoplus Z_{\scriptscriptstyle \mu_{\scriptscriptstyle p}}(p^{\scriptscriptstyle h_{\scriptscriptstyle p}+1})\right).$$

Proof. The sufficiency follows from Lemma IV, Lemma V and the General lemma. Since (B) implies (A), G must be a torsion-free group or a group of the type (b) by Theorem A_1 . If G is torsion-free, by Lemma V, G must be a free group of finite rank. Therefore, the condition is also necessary.

4. Groups with property (C). We note first that (C) implies (A) and (B). It is immediate that (C) implies (A). Let G have property (C) and let $\{h_{\alpha}\}$ be a maximal independent set in G. Then there exists another independent subset $\{g_{\alpha}\}$ of G such that $h_{\alpha} \in (g_{\alpha})$, and $(\{g_{\alpha}\})$ is a direct summand of G. Since $\{h_{\alpha}\}$ is maximal, $G = (\{g_{\alpha}\})$, that is G is a direct sum of cyclic groups. If $\{h_{\alpha}\}$ is a basis of a subgroup H of G, then the independent set $\{g_{\alpha}\}$ such that $h_{\alpha} \in (g_{\alpha})$ is pure (since $(\{g_{\alpha}\})$) is a direct summand) and can be enlarged to a basis of G by [1, Lemma 11]. Hence (C) implies (B).

LEMMA VI. A primary group G has property (C) if and only if it is of the type

$$\sum_{\lambda} \bigoplus Z_{\lambda}(p^{h})$$
 .

Proof. Since (C) implies (A), the group G is of the type

$$\sum_{\lambda} \bigoplus Z_{\lambda}(p^h) \bigoplus \sum_{\mu} \bigoplus Z_{\mu}(p^{h+1})$$
.

If both sets of indices for λ , μ are non-empty, then there exists $(u_1) \oplus (u_2)$, a direct summand of G such that $o(u_1) = h \ge 1$ and $o(u_2) = h + 1$. Now, consider the independent subset $\{p^{h-1}u_1, p^{h-1}u_1 + p^hu_2\}$ of G. It is clear that

$$p^h u_2 \in (p^{h-1}u_1, p^{h-1}u_1 + p^h u_2)$$
.

If there exists a direct summand $V=(\tilde{u_1}) \oplus (\tilde{u_2})$ of G such that $p^{h-1}u_1 \in (\tilde{u_1}), \ p^{h-1}u_1 + p^hu_2 \in (\tilde{u_2}), \ \text{then}$

$$(p^{h-1}u_1)=\overline{(\widetilde{u}_1)}$$
, $(p^{h-1}u_1+p^hu_2)=\overline{(\widetilde{u}_2)}$.

Since $p^n u_2 \in V$, we must have

$$h_{\nu}(p^{h}u_{2}) = h = \min. \quad (h_{\nu}(p^{h-1}u_{1}), h_{\nu}(p^{h-1}u_{1} + p^{h}u_{2})) = h - 1$$

which is a contradiction, therefore the condition is necessary. Conversely, if G is of the type

$$\sum igoplus Z_{\lambda}(p^h)$$
 ,

then it follows from Lemma III, that any element h_{α} of an independent subset $\{h_{\alpha}\}$ of G can be contained in a cyclic direct summand of G, viz., (u_{α}) . Now, we are going to prove that $\{u_{\alpha}\}$ is a pure independent subset of G, hence by [1, Theorem 7], $U = \sum_{\alpha} \bigoplus (u_{\alpha})$ is a direct summand of G. The independence of $\{u_{\alpha}\}$ follows immediately from the independence of $\{h_{\alpha}\}$. Since every element x of order p in U has height h-1 in U which is the height of x in G, U is pure in G, by [1, Lemma 7]. Thus, G has property (C).

LEMMA VII. A torsion free group has property (C), if and only if G = I (the integers).

Proof. If G = I, it clearly has property (C). Conversely, we shall prove that G = I is also necessary. Suppose to the contrary that G is a free group of rank not less than 2. (Since (C) implies (B), G is a free group of finite rank.) Then, there exists a subgroup V of G such that

$$G/V \cong Z(p) \oplus Z(p^3)$$
.

Let u_1 and u_2 be the generators of Z(p) and $Z(p^3)$, respectively. Let H be the complete inverse image of (u_1+pu_2) with respect to the homomorphic mapping of G onto $Z(p) \oplus Z(p^3)$. Then, H is a free group of finite rank, therefore, a group with property (B). There exists a basis $\{v_\alpha\}$ of V and a basis $\{h_\beta\}$ of H such that for any v_α there is an $h_\alpha \in \{h_\beta\}$ with the property $v_\alpha \in (h_\alpha)$. If G is a group with the property (C), then there exists a basis $\{g_\gamma\}$, such that $h_\beta \in (g_\beta)$ for all β , where $\beta_\beta \in \{g_\gamma\}$. Hence $G/V = \sum_\alpha \oplus (g_\alpha)/(v_\alpha)$ and $H/V = \sum_\alpha \oplus (h_\alpha)/(v_\alpha)$ where $(h_\alpha)/(v_\alpha) \oplus (g_\alpha)/(v_\alpha)$. Since $H/V \cong (u_1+pu_2)$ is cyclic, $H/V = (h_\alpha)/(v_\alpha)$ consists of a single summand of order p^2 which is contained in a cyclic direct summand of $G/V \cong Z(p) \oplus Z(p^3)$ of order p^3 . Thus $u_1+pu_2=p\overline{u_2}$, where $(\overline{u_2})$ is a direct summand of G/V. This implies that $h_{G/V}(\overline{u_1}+p\overline{u_2})=1$, but on the other hand it is clear that $h_{G/V}(u_1+pu_2)=0$. This contradiction completes the proof.

THEOREM C. A group G has property (C), if and only if either

- (a) G = I, or
- (b) G is of the type

$$\sum_{p} \bigoplus \left(\sum_{\lambda_{p}} \bigoplus Z_{\lambda_{p}}(p^{h_{p}})\right)$$
.

Proof. Since (C) implies (A), the theorem follows from Theorem A_1 , Lemma VI, Lemma VII and the General lemma.

5. Conclusion. We have analyzed the groups characterized by

their independent subsets. The classical theorem on the subgroups of a free group U_n of finite rank is obviously a particular case of Theorem B; Theorem A, Theorem A₁ and Theorem C are its generalizations.
