GENERALIZED CONVEXITY CONES AND THEIR DUALS

DAN AMIR AND ZVI ZIEGLER

The structure of the intersections and unions of generalized convexity cones is analysed. The main results involve on the one hand denseness properties of sums of two distinct generalized convexity cones and on the other hand the availability of a decomposition for measures of the cones dual to intersections of generalized convexity cones. As an application an integration scheme which converges for all convex functions is found.

The generalized convexity cones, which were introduced by Karlin and Novikoff, find many applications in the systematic study of inequalities, in the theory of approximation and interpolation and in various branches of probability theory.

It is shown in §1 that the sums and differences of two generalized convexity cones are dense subsets of the Frechet space of continuous functions on the open interval (a, b).

Passing to the dual cones in § 2, we show that any measure belonging to the dual of the intersection of two (or, respectively, three) consecutive generalized convexity cones can be decomposed into the sum of two (respectively, three) measures belonging to the corresponding dual cones. For example, any measure belonging to the dual cone of the cone of convex and monotone functions can be decomposed into the sum of a measure belonging to the dual cone of the cone of convex functions and a measure belonging to the dual cone of the cone of monotone functions. It is also shown in this section that a decomposition of this type is not generally available for measures of the cone dual to the intersection of 4 consecutive generalized convexity cones.

In § 3 we demonstrate the availability of a decomposition of a particularly simple type for measures of compact support on (a, b) belonging to the cone dual to the intersection of two consecutive generalized convexity cones.

An application of the foregoing analysis, involving convergence properties of integration schemes, is given in § 4.

Preliminaries. Let $\{u_i(t)\}_{i=0}^N$ be an Extended Complete Tchebycheff (ECT) system on the interval [a, b] (for definitions of the pertinent concepts and for proofs of most of the statements in this section, the reader is referred to [3]).

For $0 \le n \le N$, we denote by $C(u_0, \dots, u_n)$ the convex cone of functions defined on (a, b) which are convex with respect to $\{u_i\}_0^n$. The notation $C(u_0, \dots, u_{-1})$ is used to denote the convex cone C^+ of nonnegative functions on (a, b).

It is shown in [3, pp. 378-379] that in studying generalized convexity cones one may assume, with no loss of generality, that $\{u_i(t)\}_{i=0}^N$ are of the form:

$$(0.1) \begin{cases} u_0(t) = w_0(t) \\ u_1(t) = w_0(t) \int_a^t w_1(x_1) dx_1 \\ \vdots & \vdots \\ u_N(t) = w_0(t) \int_a^t w_1(x_1) \int_a^{x_1} w_2(x_2) \cdots \int_a^{x_{n-1}} w_n(x_n) dx_n \cdots dx_1 \end{cases}$$

where the functions $w_i(t)$, $i=0,1,\dots,N$, are strictly positive on [a,b] and $w_i(t) \in C^{N-i}$ [a,b], $i=0,1,\dots,N$. The first order differential operators

(0.2)
$$D_i f(t) = \frac{d}{dt} \frac{1}{w_i(t)} f(t), \quad i = 0, 1, \dots, N$$

are closely related to the cones; in fact, if a function f(t) is n+1 times differentiable, then it belongs to $C(u_0, \dots, u_n)$ if, and only if $D_n D_{n-1} \cdots D_0 f(t) \geq 0$, a < t < b.

The cone $C(u_0, \dots, u_n)$, $0 \le n \le N$, taken modulo the linear space spanned by u_0, \dots, u_n , is spanned by a one—parameter family of extreme rays. These are represented by the functions $\phi_n(t; x)$, $a \le x \le b$, where $\phi_n(t; x)$ is identically 0 for $a \le t < x$ and has the form

$$u_n(t) + \sum_{i=0}^{n-1} c_i(x)u_i(t)$$
 for $x \le t \le b$

(see [5], p. 566). The conjugate function $\tilde{\phi}_n(t; x)$ is defined as

$$(-1)^n \left[u_n(t) + \sum_{i=0}^{n-1} c_i(x) u_i(t) \right]$$
 for $a \leq t < x$

and 0 for $x \le t \le b$. By using the integral representation of $\tilde{\phi}_n(t; x)$ (see [3], p. 387) and applying to it the operator $D_{n-1}D_{n-2}\cdots D_0$, it can easily be verified that $(-1)^n\tilde{\phi}_n(t; x) \in C(u_0, \dots, u_{n-1})$.

Let M denote the space of Radon measures on [a,b], i.e., the dual space of the Banach space C[a,b] of continuous functions on [a,b] with the sup norm. For a set K of functions defined on (a,b), let $K^* = \{\mu : \mu \in M, \ \mu(f) \geq 0 \ \forall \ f \in K\} \ (\mu(f) = \infty \ \text{is permitted})$. K^* is clearly a convex cone, called the dual cone of K. We shall denote $[C(u_0, \cdots, u_n)]^*$ by $C^*(u_0, \cdots, u_n)$. The study of the extreme rays of

convexity cones and of their intersections leads to the following characterization of dual cones ([5], p. 572):

Necessary and sufficient conditions for μ to belong to

Another useful characterization can be obtained along the lines described in ([2] and [6]). Define, for a measure $\mu \in M$, the functions

(0.4)
$$\begin{cases} (P_0\mu)(t) = \int_t^b w_0(x)d\mu(x) , \\ (P_j\mu)(t) = \int_t^b w_j(x)P_{j-1}\mu(x)dx , \quad j=1,2,\cdots,N. \end{cases}$$

We then have:

Necessary and sufficient conditions for μ to belong to

are:

(0.5)
$$\begin{cases} P_{j}\mu(a)=0\;, & j=0,1,\cdots,m\;,\ P_{j}\mu(a)\geqq 0\;, & j=m+1,\cdots,n\;,\ P_{n}\mu(x)\geqq 0\;, & a\leqq x\leqq b\;. \end{cases}$$

We shall avail ourselves also of the differential operators D_i^* , $i=0,1,\cdots,N$ defined by

$$\begin{cases} D_{\scriptscriptstyle 0}^*f(t) = \frac{1}{w_{\scriptscriptstyle 0}(t)}\frac{d^Rf(t)}{dt} & \text{(right hand derivative)} \\ D_i^*f(t) = \frac{1}{w_i(t)}\frac{df(t)}{dt} \;, \qquad i=1,2,\cdots,N \;. \end{cases}$$

Note that if $f(b) = f'(b) = \cdots = f^{(j)}(b) = 0$, then $(-1)^{j+1}P_jD_0^*\cdots D_j^*$ $f \equiv f$. We finally recall that a simple example of an ECT-system is furnished by the system 1, t, t^2 , \cdots on [0, 1]. This corresponds to

 $\{w_0 \equiv 1, w_i \equiv i, i = 1, 2, \dots\}$. Convexity with respect to $(1, t, t^2, \dots, t^n)$ is ordinary n + 1-st order convexity. The extreme rays in this case are given by:

$$\phi_n(t;\,x) = egin{cases} 0 &, & 0 \leq t < x \ (t-x)^n &, & x \leq t \leq 1 \end{cases}.$$

1. Sums of generalized convexity cones. Let C=C[a,b] denote the Banach space of real-valued continuous functions on the closed interval [a,b], with the norm $||f||=\max\{|f(x)|; a \leq x \leq b\}$. Let further $C_0=C(a,b)$ denote the Frechet space of continuous functions on the open interval (a,b) with the topology of uniform convergence on compact subsets of (a,b). The corresponding dual spaces are, respectively, the space M of Radon measures μ defined on [a,b] (these are representable as functions of bounded variation on [a,b]) and its subspace M_0 of Radon measures on (a,b) with compact support—the duality being $\mu(f)=\int f d\mu$ (cf. [1]).

THEOREM 1. The sums $C(u_0, \dots, u_n) + C(u_0, \dots, u_m)$, for $m > n \ge 1$, and the differences $C(u_0, \dots, u_n) - C(u_0, \dots, u_m)$, for $m, n \ge 1$, are dense (proper) subsets of C_0 .

Proof. We recall first that, for $n \ge 1$, every function of $C(u_0, \dots, u_n)$ is continuous in (a, b) (cf. [3]). Let $C^{\circ}(u_0, \dots, u_n)$ denote the polar set of $C(u_0, \dots, u_n)$ in M_0 i.e.,

$$C^{\circ}(u_{\scriptscriptstyle 0},\, \cdots,\, u_{\scriptscriptstyle n})=\{\mu:\mu(f)\geqq -1 \quad \text{for all} \quad f\in C(u_{\scriptscriptstyle 0},\, \cdots,\, u_{\scriptscriptstyle n})\}$$
 .

Since $C(u_0, \dots, u_n)$ is a cone, this set coincides with the set $\{\mu : \mu(f) \ge 0 \text{ for all } f \in C(u_0, \dots, u_n)\}$. Thus, we have

$$C^{\circ}(u_0, \dots, u_n) = M_0 \cap C^*(u_0, \dots, u_n)$$
.

Furthermore, since $C(u_0, \dots, u_n)$ and $C(u_0, \dots, u_m)$ are convex cones, their sum is the convex hull of their union, so that

(1.1)
$$\begin{aligned} [C(u_0,\,\cdots,\,u_n)\,+\,C(u_0,\,\cdots,\,u_m)]^\circ \\ &= [C(u_0,\,\cdots,\,u_n)\,\cup\,C(u_0,\,\cdots,\,u_m)]^\circ \\ &= C^\circ(u_0,\,\cdots,\,u_n)\,\cap\,C^\circ(u_0,\,\cdots,\,u_m) \\ &= M_0\,\cap\,C^*(u_0,\,\cdots,\,u_n)\,\cap\,C^*(u_0,\,\cdots,\,u_m) \;. \end{aligned}$$

In [6], Theorem 3, it was proved that, for $m \neq n$,

$$C^*(u_0, \dots, u_n) \cap C^*(u_0, \dots, u_m) = \{0\}$$

Thus, (1.1) implies that $[C(u_0, \dots, u_n) + C(u_0, \dots, u_m)]^\circ = \{0\}$ and

 $[C(u_0, \dots, u_n) + C(u_0, \dots, C_m)]^{\circ \circ} = C_0$. As $C(u_0, \dots, u_n) + C(u_0, \dots, u_m)$ is convex, the left hand side of this last equation is the weak-closure of $C(u_0, \dots, u_n) + C(u_0, \dots, u_m)$, which is also the strong closure by the Hahn-Banach theorem (cf. [1], 2.2.7). This proves that $C(u_0, \dots, u_n) + C(u_0, \dots, u_m)$ is a dense subset of C_0 . It is a proper subset; moreover, its complement is dense as well. This observation follows from the fact that the functions of the convexity cones have one sided limits (possibly ∞) at b, while the functions which do not enjoy this property are obviously dense in C_0 .

The proof of Theorem 3 in [6] shows also that, for every m and n, $C^*(u_0, \dots, u_n) \cap [-C^*(u_0, \dots, u_m)] = \{0\}$, so that the corresponding result for $C(u_0, \dots, u_n) - C(u_0, \dots, u_m)$ follows in an exactly analogous way.

REMARKS. (a) As C_0 is metrizable, Theorem 1 implies that, for every $f \in C_0$ and $m > n \ge 1$, there exist two sequences $(g_k) \subset C(u_0, \dots, u_n)$ and $(h_k) \subset C(u_0, \dots, u_m)$, such that $(g_k + h_k)$ converges to the given f uniformly on each compact subset of (a, b).

- (b) Similar results hold when m or n < 1.
- (c) Analogous results hold when C_0 is replaced by C and $C(u_0, \dots, u_n)$ by $C \cap C(u_0, \dots, u_n)$.
- 2. Sums of dual cones in M. We know that each dual cone $C^*(u_0, \dots, u_n)$ is closed in the weak $\sigma(M, C)$ —topology of M. In this section we show that the sums of 2 or 3 consecutive dual cones are $\sigma(M, C)$ —closed, while the sum of 4 consecutive dual cones need not be $\sigma(M, C)$ —closed.

Theorem 2. For each $n, 0 \le n \le N$, we have

$$C^*(u_0, \dots, u_{n-1}) + C^*(u_0, \dots, u_n) = [C(u_0, \dots, u_{n-1}) \cap C(u_0, \dots, u_n)]^*$$
.

Proof. Since the inclusion relation

$$C^*(u_0, \dots, u_{n-1}) + C^*(u_0, \dots, u_n) \subset [C(u_0, \dots, u_{n-1}) \cap C(u_0, \dots, u_n)]^*$$

is obviously true, we need prove only the converse inclusion.

We start by analyzing the case n=0. Let a measure μ , $\mu \in [C^+ \cap C(u_0)]^*$ be given. By (0.3) it satisfies

$$\int_a^b u_0(t) d\mu(t) \ge 0$$
 ; $\int_a^b \phi_0(t; x) d\mu(t) \ge 0$, $a < x < b$.

Define now the measure μ_1 by

$$\mu_{\scriptscriptstyle 1} = \left[\int_a^b u_{\scriptscriptstyle 0}(t) d\mu(t)
ight]\!\delta_a$$

where δ_a is the Dirac measure with unit mass at a. Then clearly $\mu_1 \geq 0$, i.e., $\mu_1 \in (C^+)^*$. Define now $\mu_2 = \mu - \mu_1$. Then we clearly have

$$\int_a^b u_0(t)d\mu_2(t) = \int_a^b u_0(t)d\mu(t) - \int_a^b u_0(t)d\mu_1(t) = 0$$

and

$$\int_a^b \phi_{\scriptscriptstyle 0}(t;\,x) d\mu_{\scriptscriptstyle 2}(t) = \int_a^b \phi_{\scriptscriptstyle 0}(t;\,x) d\mu(t) \geqq 0$$
 , $a < x < b$.

Hence, $\mu_2 \in C^*(u_0)$, and the decomposition has been accomplished. Assume now that $n \ge 1$. Let a measure μ ,

$$\mu \in [C(u_0, \dots, u_{n-1}) \cap C(u_0, \dots, u_n)]^*$$

be given. By (0.5) it satisfies

(2.1)
$$P_i\mu(a) = 0$$
, $i = 0, 1, \dots, n-1$,

and

$$(2.2) P_n\mu(x) \ge 0 , a \le x \le b .$$

If $P_n\mu(a)=0$, then we already have $\mu\in C^*(u_0,\dots,u_n)$; thus we may assume that $P_n\mu(a)=A>0$. Define the function F(t) by

$$F(t) = A - v(t)$$

where

$$v(t) = \int_a^t w_n(x_n) \int_a^{x_n} w_{n-1}(x_{n-1}) \cdots \int_a^{x_2} w_1(x_1) \cdot 2 |P_0\mu(x_1)| dx_1 \cdots dx_n$$
.

Let $s = \inf \{ \text{support } \mu \}$; then $v(t) \equiv 0$ for $a \leq t \leq s$, and v(t) is strictly increasing for $s \leq t \leq b$. Thus, $F(t) \equiv A$ for $a \leq t \leq s$, and F(t) is a strictly decreasing function for $s \leq t \leq b$. Making use of conditions (2.1), we find

$$P_{j}\mu(t) = -\int_{a}^{t} w_{j}(x)P_{j-1}\mu(x)dx$$
, $i = 0, 1, \dots, n-1$

where $P_{-1}\mu \equiv \mu$. This relation implies that

$$P_n\mu(t) - P_n\mu(a)$$

$$= (-1)^n \int_a^t w_n(x_n) \int_a^{x_n} w_{n-1}(x_{n-1}) \cdots \int_a^{x_2} w_1(x_1) P_0\mu(x_1) dx_1 \cdots dx_n$$

so that

$$P_n\mu(t) - F(t)$$

$$= \int_a^t w_n(x_n) \cdots \int_a^{x_2} w_1(x_1) [2 | P_0\mu(x_1) | + (-1)^n P_0\mu(x_1)] dx_1 \cdots dx_n$$

is a nondecreasing nonnegative function, which is strictly positive and strictly increasing for t > s. Since $P_n\mu(b) = 0$, it follows that F(b) < 0. Since F(t) is a strictly decreasing function for $s \le t \le b$, we may consider the inverse function $F^{-1}(t)$ on [s, b]. Let c, s < c < b be defined by $c = F^{-1}(0)$, and introduce the function $F_+(t) = \max\{F(t), 0\}$. This function coincides with F(t) on [a, c] and is identically zero on [c, b]. Thus, we have

$$P_n\mu(t) \geq F_+(t)$$

with strict inequality holding for a neighbourhood of c. Thus, there exist an r, c-s>r>0, and an $\eta>0$ such that

(2.3)
$$P_n \mu(t) - F_+(t) \ge \eta > 0 \text{ for } c - r \le t \le c + r.$$

We introduce the smoothing kernels $\rho_{\iota}(t)$ defined by

$$ho_{arepsilon}(2.4) \qquad \qquad
ho_{arepsilon}(t) = egin{cases} lpha_{arepsilon} \exp\left[-rac{1}{1-(t/arepsilon)^2}
ight], & |t| < arepsilon \; , \ 0 & , & |t| \geqq arepsilon \; , \end{cases}$$

where α_{ε} is a normalizing factor, chosen so that

$$\int_{-\infty}^{\infty} \rho_{\varepsilon}(t)dt = 1.$$

Define now the function

$$f(v) = egin{cases} A - v \ , & -\infty < v \leq A \ 0 & A \leq v < \infty \end{cases}$$

and set

$$f_{1}(v) = \int_{-\infty}^{\infty} f(t) \rho_{\varepsilon}(v-t) dt$$

where ε is chosen so small that $0<\varepsilon<\eta,\ F(c+r)<-\varepsilon$ and $F(c-r)>\varepsilon.$

It is easily seen that $f_1(v)$ is a monotone decreasing function since f(v) is such. Furthermore, since f(v) is piecewise linear, we have

$$f_1(v) = A - v$$
 for $v \le A - \varepsilon$: $f_1(v) = 0$ for $v \ge A + \varepsilon$.

By the choice of ε and the fact that the application of $\rho_{\varepsilon}(t)$ amounts to an averaging operation, we find that

$$|f(v) - f_1(v)| \le \eta$$
, for all v .

Setting $F_1(t) = f_1(v(t))$, we obtain

$$(2.5) |F_{+}(t) - F_{1}(t)| \leq \eta \text{for all} a \leq t \leq b.$$

Furthermore, $F_1(t) \equiv F(t)$ for $[a, F^{-1}(\varepsilon)]$, and $F_1 \equiv 0$ for $[F^{-1}(-\varepsilon), b]$. By virtue of the choice of ε , and the fact that F(t) is monotone decreasing, we have

$$(2.6) F_{\scriptscriptstyle 1}(t) \equiv F_{\scriptscriptstyle +}(t) \;, \quad \text{for} \quad t \in [a,\,c-r] \cup [c+r,\,b] \;.$$

Note further that $F_1(t)$ is monotone decreasing. Since $f_1(v)$ is infinitely differentiable as a function of v, we deduce that $F_1(t)$ has continuous derivatives up to the n-th order, and an n+1-st right derivative (measure).

Construct the measure μ_1 by

$$\mu_{\scriptscriptstyle 1} = (-1)^{\scriptscriptstyle n+1} D_{\scriptscriptstyle 0}^* \, \cdots \, D_{\scriptscriptstyle n}^* F_{\scriptscriptstyle 1}$$
 .

Using (0.7), we have

$$P_{i}\mu_{1} = (-1)^{n-j}D_{i+1}^{*}\cdots D_{n}^{*}F_{1} \qquad 0 \leq j \leq n$$

where for j = n the right hand side is understood as F_1 . These relations in turn imply that

$$(2.7) P_{j}\mu_{1}(a) = (-1)^{n-j}D_{j+1}^{*}\cdots D_{n}^{*}F(a) = 0, j = 0, 1, \cdots n-1$$

and that

(2.8)
$$P_{n-1}\mu_1(x) = -\frac{1}{w_n(x)} \frac{dF_1}{dx}$$

which is nonnegative for $a \le x \le b$, by virtue of the monotonicity of $F_1(x)$. Relations (2.7) and (2.8) imply, by (0.5), that $\mu_1 \in C^*(u_0, \dots, u_{n-1})$.

Consider now the measure $\mu_2 = \mu - \mu_1$. By virtue of (2.7) we obtain, using the fact that $P_n\mu_1(a) = F_1(a) = A$, that

(2.9)
$$P_{j}\mu_{2}(a)=0\;,\qquad j=0,1,\cdots,n\;.$$

Furthermore, by using (2.3), (2.5) and (2.6), we deduce the nonnegativity, for all $a \le x \le b$, of

$$P_n \mu_{\scriptscriptstyle 2}(x) = P_n \mu(x) - P_n \mu_{\scriptscriptstyle 1}(x) = P_n \mu(x) - F_{\scriptscriptstyle 1}(x)$$
 .

This, taken together with (2.9) and (0.5), shows that $\mu_2 \in C^*(u_0, \dots, u_n)$ and the decomposition has been accomplished.

THEOREM 3. For every $n, 0 \le n \le N-1$, we have

$$\sum_{k=-1}^{1} C^*(u_0,\,\cdots,\,u_{n+k}) = \left[\bigcap_{k=-1}^{1} C(u_0,\,\cdots,\,u_{n+k})\right]^*.$$

Proof. As in the proof of Theorem 2, we need prove only that

$$\sum_{k=-1}^{1} C^*(u_0, \cdots, u_{n+k}) \supset \left[\bigcap_{k=-1}^{1} C(u_0, \cdots, u_{n+k})\right]^*$$

since the other inclusion is obvious. Furthermore, using Theorem 2 we deduce that it suffices to prove that

(2.10)
$$\begin{bmatrix} \bigcap_{k=-1}^{1} C(u_0, \dots, u_{n+k}) \end{bmatrix}^* \\ \subset C^*(u_0, \dots, u_{n-1}) + [C(u_0, \dots, u_n) \cap C(u_0, \dots, u_{n+1})]^* .$$

We start with the case n = 0. Let a measure

$$\mu \in [C^+ \cap C(u_0) \cap C(u_0, u_1)]^*$$

be given. By (0.3), μ satisfies the conditions

$$\int_a^b u_i(t)d\mu(t) \geq 0 , \qquad i = 0, 1 ,$$

and

$$\int_a^b \! \phi_{\scriptscriptstyle 1}(t;\,x) d\mu(t) \geqq 0 \qquad a < x < b$$
 .

Define the measure μ_1 by

$$\mu_{\scriptscriptstyle 1} = \left[\int_a^b u_{\scriptscriptstyle 0}(t) d\mu(t)\right] \!\! \delta_a$$

where δ_a is the Dirac measure with unit mass at a. Then we clearly see that $\mu_1 \in (C^+)^*$ while $\nu = \mu - \mu_1$ satisfies

$$\int_a^b u_{\scriptscriptstyle 0}(t) d
u(t) = 0$$
 ,

and

$$\int_a^b \phi_{\scriptscriptstyle 1}(t;\,x) d
u(t) = \int_a^b \phi_{\scriptscriptstyle 1}(t;\,x) d\mu(t) \geqq 0 \;, \qquad a < x < b$$

so that, by (0.3), $\nu \in [C(u_0) \cap C(u_0, u_1)]^*$ and the decomposition has been accomplished for this case.

Assume now that $n \ge 1$ and let $\mu \in \left[\bigcap\limits_{k=-1}^1 C(u_0,\cdots,u_{n+k})\right]^*$ be given. By (0.3), it satisfies

$$P_{j}\mu(a)=0 \qquad \qquad j=0,1,\,\cdots,\,n-1 \ P_{n}\mu(a)\geqq 0 \quad , \ P_{n+1}\mu(x)\geqq 0 \ , \qquad a\leqq x\leqq b \ .$$

If $P_n\mu(a)=0$, then the conditions (2.11) imply, by (0.3) that we already have $\mu\in [C(u_0,\cdots,u_n)\cap C(u_0,\cdots,u_{n+1})]^*$. Thus, we may assume that $P_n\mu(a)=A>0$. Furthermore, since $P_{n+1}\mu(x)\geq 0$ and

$$\frac{d}{dx} P_{n+1} \mu(a) = -w_n(a) P_n \mu(a) < 0 ,$$

we deduce that $P_{n+1}\mu(a) = B > 0$.

Since $P_{n+1}\mu(x)$ and $w_{n+1}(t)$ are continuous, there exist a c and an $\eta>0$ such that $a< c-\eta< c+\eta< b$ and

$$\left\{egin{aligned} &P_{n+1}\mu(x)\geqrac{1}{2}B\quad ext{for}\quad a\leq x\leq c\,+\,\gamma\ &C=\int_a^cw_{n+1}(t)dt\leq B/4A \;. \end{aligned}
ight.$$

Set

$$v(x) = \int_a^x w_{n+1}(t)dt, \qquad \qquad F(x) = egin{cases} A(C-v(x)) & a \leq x \leq c \ 0 & c \leq x \leq b \end{cases}.$$

Then F(x) has the following properties:

(2.13)
$$P_{n+1}\mu(x) \ge F(x)$$
, $a \le x \le b$,

(2.14)
$$P_{n+1}\mu(x) - F(x) \ge \frac{1}{4}B$$
, $a \le x \le c + \eta$,

$$(2.15) D_i^* \cdots D_{n+1}^* F(a) = 0, i = 0, 1, \cdots, n,$$

$$(2.16) -D_{n+1}^*F(a) = A.$$

Define the function f(v) by

$$f(v) = egin{cases} A(C-v) & -\infty < v \leq C \ 0 & C \leq v < \infty \end{cases}$$

and let

$$f(v) = \int_{-\infty}^{\infty} f(t) \rho_{\epsilon}(v-t) dt$$

where $\rho_{\varepsilon}(t)$ is the function defined in (2.4) and ε is chosen so that it satisfies

$$(2.17) \qquad \varepsilon \leqq \int_{\mathfrak{c}}^{\mathfrak{c}+\eta} w_{\scriptscriptstyle n+1}(t) dt \;, \qquad \varepsilon \leqq \int_{\mathfrak{c}-\eta}^{\mathfrak{c}} w_{\scriptscriptstyle n+1}(t) dt \;, \qquad A\varepsilon < \frac{1}{4} \; B \;.$$

The function $f_1(v)$ is an infinitely differentiable, monotone non-increasing and convex function of v. Moreover, we clearly have:

$$(2.18) \begin{cases} f_1(v) = A(C-v) , & v \leq C-\varepsilon , \\ f_1(v) = 0 , & v \geq C+\varepsilon , \\ |f_1-f| \leq \frac{1}{4}B , & C-\varepsilon \leq v \leq C+\varepsilon . \end{cases}$$

Construct now the function $F_1(x) = f_1(v(x))$. Then, by using (2.17) and (2.18), we find

(2.19)
$$\begin{cases} F_{1}(x) = F(x) &, & a \leq x \leq c - \eta, \\ F_{1}(x) = F(x) = 0 &, & c + \eta \leq x \leq b, \\ |F_{1}(x) - F(x)| \leq \frac{1}{4}B, & a \leq x \leq b. \end{cases}$$

Furthermore, since $f_1(v)$ is a convex function of v, we have

$$(2.20) D_n^* D_{n+1}^* F_1 = D_n^* \left[\frac{df_1}{dv} \right] = \frac{w_{n+1}}{w_n} \frac{d^2 f_1}{dv^2} \ge 0.$$

Construct now the measure μ_1 by: $\mu_1 = (-1)^{n+2}D_0^* \cdots D_{n+1}^*F_1$. We have then $P_j\mu_1 = (-1)^{n-j+1}D_{j+1}^* \cdots D_{n+1}^*F_1$, $j=0,1,\cdots,n$, and $P_{n+1}\mu_1 = F_1$. Thus, by (2.15) and (2.19)

 $P_{j}\mu_{1}(a)=(-1)^{n-j+1}D_{j+1}^{*},\;\cdots,\;D_{n+1}^{*}F_{1}(a)=0,\;j=0,1,\;\cdots,\;n-1$ and, by (2.20)

$$P_{n-1}\mu_{\scriptscriptstyle 1}(x) = D_n^*D_{n+1}^*F_{\scriptscriptstyle 1}(x) \geqq 0$$
 .

These relations imply by (0.5) that $\mu_1 \in C^*(u_0, \dots, u_{n-1})$.

Define now ν by $\nu=\mu-\mu_{\scriptscriptstyle 1}$. Then, using (2.16), (2.14) and (2.19) we have

$$egin{cases} P_j
u(a) &= P_j \mu(a) - P_j \mu_1(a) = 0 \;, \qquad j = 0, 1, \cdots, n-1 \ P_n
u(a) &= P_n \mu(a) - P_n \mu_1(a) = A + D_{n+1}^* F(a) = 0 \;, \ P_{n+1}
u(x) &= P_{n+1} \mu(x) - F_1(x) \geq 0 \;. \end{cases}$$

These relations imply by (0.5) that $\nu \in [C(u_0, \dots, u_n) \cap C(u_0, \dots, u_{n+1})]^*$ so that the decomposition has been accomplished and the theorem is proved.

It is quite surprising, knowing Theorems 2 and 3, that the corresponding statement concerning four consecutive convexity cones is false. This is demonstrated by the following example which shows that

$$\begin{split} [C(1) \cap C(1, x) \cap C(1, x, x^2) \cap C(1, x, x^2, x^3)]^* \\ & \neq C^*(1) + C^*(1, x) + C^*(1, x, x^2) + C^*(1, x, x^2, x^3) \;. \end{split}$$

Example. Let the measure μ be represented by the function $f(t) = -\int_a^t d\mu$, where

$$f(t) = egin{cases} 400t - 40 \ , & 0.1 \leqq t < 0.2 \ , \\ 80 - 200t \ , & 0.4 \leqq t < 0.5 \ , \\ 200t - 120 \ , & 0.5 \leqq t < 0.6 \ , \\ 40 - 50t \ , & 0.6 \leqq t < 0.8 \ , \\ 0 \ , & ext{elsewhere} \ . \end{cases}$$

It is immediately seen that

(2.21)
$$\int_0^1 f(t)dt = 1, \qquad \int_0^1 t f(t)dt = 0$$

and a simple computation yields

(2.22)
$$\int_0^1 t^2 f(t) dt > 0.$$

Consider the function Q(x) defined by

$$Q(x) = \int_{x}^{1} (t - x)^{2} f(t) dt$$
, $0 \le x \le 1$.

Differentiation yields

$$Q'(x) = -2\int_{x}^{1} (t-x)f(t)dt$$
, $Q''(x) = 2\int_{x}^{1} f(t)dt$.

The second derivative Q''(x) has in (0,1) precisely two zeros, as can be directly checked from the graph of f(t). Since Q'(x) vanishes for 0 and 1, it may have at most one zero inside (0,1). Finally, since Q(0) > 0 by (2.22), and Q(1) = 0 while Q(x) is positive near 1, we may deduce that $Q(x) \ge 0$ for all $0 \le x \le 1$. Using the fact that $\{(t-x)_+^2\}$ are the extreme rays for $C(1,x,x^2)$, we deduce by (0.3) that $f(t) \in [C^+ \cap C(1) \cap C(1,x) \cap C(1,x,x^2)]^*$. Since f(1) = 0, this implies that $\mu \in [C(1) \cap C(1,x) \cap C(1,x,x^2) \cap C(1,x,x^2,x^3)]^*$ (cf. [6]).

Suppose now that there exists a decomposition $\mu=\mu_1+\mu_2$ with $\mu_1\in C^*(1),\ \mu_2\in [C(1,x)\cap C(1,x,x^2)\cap C(1,x,x^2,x^3)]^*,$ then there exists a corresponding decomposition $f=f_1+f_2$ where $f_i(t)=-\int_a^t d\mu_i,$ $i=1,2;\ f_1\in (C^+)^*,\ f_2\in [C(1)\cap C(1,x)\cap C(1,x,x^2)]^*.$

By (0.3), these functions have to satisfy

(2.23)
$$\begin{cases} f_1(x) \ge 0 &, \quad 0 \le x \le 1 \\ \int_0^1 f_2(t)dt = 0 &, \quad \int_0^1 t f_2(t)dt \ge 0 \end{cases}.$$

In this case, however, the equalities

$$0 = \int_0^1 t f(t) dt = \int_0^1 t f_1(t) dt + \int_0^1 t f_2(t) dt$$

imply that

$$\int_0^1 t f_1(t) dt = 0.$$

Since $f_1(t)$ is nonnegative and continuous from the right, it follows that $f_1(t) \equiv 0$. On the other hand, we know that, by (2.21) and (2.23),

$$1 = \int_0^1 f(t)dt = \int_0^1 f_1(t)dt.$$

Thus, we have arrived at a contradiction, which shows that the assumption that there exists a decomposition is untenable.

3. Sums of dual cones in M_0 . The existence of a decomposition of $\mu \in M_0 \cap [C(u_0, \dots, u_{n-1}) \cap C(u_0, \dots, u_n)]^*$ into a sum of a measure $\mu_1 \in M_0 \cap C^*(u_0, \dots, u_{n-1})$ and a measure $\mu_2 \in M_0 \cap C^*(u_0, \dots, u_n)$ follows from Theorem 2. For these cones, however, we have the stronger result:

THEOREM 4. Let μ be a measure of $[C(u_0, \dots, u_{n-1}) \cap C(u_0, \dots, u_n)]^*$ such that inf $\{\text{support }(\mu)\} = s > a$. Then there exists a decomposition $\mu = \mu_1 + \mu_2, \ \mu_1 \in C^*(u_0, \dots, u_{n-1}), \ \mu_2 \in C^*(u_0, \dots, u_n) \ \text{where } \mu_1 \text{ is either } 0 \text{ or supported in any } n+1 \text{ prescribed distinct points in } (a, s).$

Proof. We may assume that

$$\int_a^b u_n(t)d\mu(t) = A > 0$$

since otherwise $\mu \in C^*(u_0, \dots, u_n)$ and the decomposition is accomplished by choosing $\mu_1 = 0$.

Let $\{x_i\}_{i=1}^{n+1}$ be an arbitrarily prescribed set of points such that $a < x_1 < \cdots < x_{n+1} < s$. Consider the system of linear equations

(3.1)
$$\begin{cases} \sum\limits_{j=1}^{n+1} a_j u_i(x_j) = 0 &, \qquad i = 0, 1, \, \cdots, \, n-1 \\ \sum\limits_{i=1}^{n+1} a_j u_n(x_i) = A &. \end{cases}$$

Since (u_0, \dots, u_n) is a Tchebycheff system, the corresponding determinant does not vanish, and the system of equations has a unique solution (a_1, \dots, a_{n+1}) .

Define $\mu_1 = \sum_{j=1}^{n+1} a_j \delta_{x_j}$, where δ_{x_j} is the Dirac measure with unit mass at x_j . By virtue of (3.1), we have

(3.2)
$$\int_a^b u_i(t)d\mu_1(t) = 0 , \qquad i = 0, 1, \dots, n-1 .$$

(3.3)
$$\int_{a}^{b} u_{n}(t) d\mu_{1}(t) = A > 0.$$

From [6], Theorem B, we deduce that μ_1 has at least n sign changes. Since it is supported in at most n+1 points, it follows that it has exactly n sign changes. The same theorem allows us to conclude that either μ_1 or $-\mu_1$ belong to $C^*(u_0, \dots, u_{n-1})$. Since $u_n \in C(u_0, \dots, u_{n-1})$, relation (3.3) implies that $\mu_1 \in C^*(u_0, \dots, u_{n-1})$.

It remains to be shown that $\mu_2 = \mu - \mu_1$ belongs to $C^*(u_0, \dots, u_n)$. It is easy to deduce that

(3.4)
$$\int_a^b u_i(t) d\mu_2(t) = 0 , \qquad i = 0, 1, \dots, n .$$

Thus, by (0.3), we have to show only that

Consider first the case $x > x_{n+1}$. We have

$$\int_a^b \phi_n(t; x) d\mu_1(t) = \int_x^b \phi_n(t; x) d\mu_1(t) = 0$$

so that

$$\int_a^b \phi_n(t; x) d\mu_2(t) = \int_a^b \phi_n(t; x) d\mu(t) \ge 0.$$

The inequality following by applying (0.3) to the measure μ . Suppose next that $x \leq x_{n+1}$. Since $x_{n+1} < s$, we have

$$\begin{split} \int_{a}^{b} \phi_{n}(t; x) d\mu(t) &= \int_{x}^{b} \phi_{n}(t; x) d\mu(t) \\ &= \int_{x}^{b} \left[u_{n}(t) + \sum_{i=0}^{n-1} c_{i}(x) u_{i}(t) \right] d\mu(t) \\ &= \int_{x}^{b} u_{n}(t) d\mu(t) + \sum_{i=0}^{n-1} c_{i}(x) \int_{x}^{b} u_{i}(t) d\mu(t) \\ &= \int_{x}^{b} u_{n}(t) d\mu(t) + \sum_{i=0}^{n-1} c_{i}(x) \int_{x}^{b} u_{i}(t) d\mu(t) = A . \end{split}$$

The last equality following from (3.2)-(3.3). Thus, for $x \le x_{n+1}$, (3.5) is equivalent to

(3.6)
$$\int_a^b \phi_n(t; x) d\mu_1(t) \leq A.$$

Since

$$egin{aligned} \int_a^b \left[\phi_n(t;\,x)\,+\,(-1)^n ilde{\phi}_n(t;\,x)
ight]\!d\mu_{\scriptscriptstyle 1}(t) \ &= \int_a^b \!\!\left[u_n(t)\,+\,\sum_{i=0}^{n-1}c_i(x)u_i(t)
ight]\!d\mu_{\scriptscriptstyle 1}(t) = A \;. \end{aligned}$$

We further deduce that (3.6) is equivalent to

(3.7)
$$\int_a^b (-1)^n \widetilde{\phi}_n(t; x) d\mu_1(t) \ge 0$$

which follows from the fact that $(-1)^n \widetilde{\phi}_n(t; x) \in C(u_0, \dots, u_{n-1})$ and $\mu_1 \in C^*(u_0, \dots, u_{n-1})$. This completes the proof of Theorem 4.

4. Application. In this section we derive a simple Riemann-Stieltjes integration scheme which converges monotonely for all convex functions. We start by restating a theorem of Fejer (see [4]):

Given 2 interlaced partitions, $(s_i)_{i=0}^m$, $(t_i)_{i=0}^{m+1}$, of the interval [0, 1]: $0 = t_0 = s_0 < t_1 < s_1 < t_2 < \cdots < s_i < t_{i+1} < s_{i+1} < \cdots < t_m < s_m = t_{m+1} = 1$. Form the Riemann sums:

$$S_m(g) = \sum_{i=1}^m (s_i - s_{i-1})g(s_i)$$

$$S_{m+1}(g) = \sum_{i=1}^{m+1} (t_i - t_{i-1})g(t_i)$$
 .

Then necessary and sufficient conditions for

$$(4.1) S_{m+1}(g) \le S_m(g)$$

to hold for every increasing and convex function g on [0, 1], are:

(4.2)
$$\sum_{i=0}^{k} q_i(p_i - p_{i+1}) \ge 0 \qquad (i = 0, \dots, m-1)$$

where $p_i = s_{m-i} - t_{m-i}$, $q_i = t_{m-i} - s_{m-i-1}$. (To derive this formulation from the theorem as stated in [5], substitute: g(x) = f(1-x), m = n+1, $s_i = 1-x_{m-i}$, $t_i = 1-y_{m+1-i}$). Furthermore, it was shown in [5] that no Riemann scheme of this type converges monotonely for all monotone function or for all convex functions. In order to obtain a scheme converging monotonely for all convex functions we shall modify Fejer's scheme to a Riemann-Stieltjes scheme.

The inequality (4.1) means that, provided (4.2) is satisfied, the measure μ defined by $\mu = \sum_{i=1}^{m} (s_i - s_{i-1}) \delta_{s_i} - \sum_{i=1}^{m+1} (t_i - t_{i-1}) \delta_{t_i}$ belongs to $[C(1) \cap C(1, x]^*$. We apply to μ the decomposition of Theorem 4: Given 2 points u, v satisfying: $0 < u < v < t_1$, we construct the meas-

ure $\mu_1 = A(\delta_v - \delta_u)/(v - u)$, where $A = \int_0^1 t d\mu(t) = \sum_{i=0}^{m-1} q_i(p_i - p_{i+1})$ (cf. [4.2]). Then, we have $\mu - \mu_1 \in C^*(1, x)$. This means that, for every convex function g, we have:

$$S_n(g) - \frac{A}{v-u} g(v) \geq S_{n+1}(g) - \frac{A}{v-u} g(u)$$
.

Suppose now we have a sequence of consecutively interlaced partitions $\Delta^m = (\tau_i^m)_{i=0}^m \ (m=1,2,\cdots)$, such that:

$$egin{aligned} 0 &= au_0^{m+1} = au_0^m < au_1^{m+1} < au_1^m < \cdots < au_i^{m+1} < au_i^m < au_{i+1}^{m+1} < \cdots < au_m^m \ &= au_{m+1}^{m+1} = 1 \qquad (m=1,2,\cdots) \end{aligned}$$

and $\sum_{i=0}^{k} q_i^m(p_i^m - p_{i+1}^m) \ge 0$ $(k = 0, \dots, m-1; m = 1, 2, \dots)$ where $p_i^m = \tau_{m-i}^m - \tau_{m-i}^{m+1}$, $q_i^m = \tau_{m-i}^{m+1} - \tau_{m-i-1}^m$, and suppose also we have a sequence (v_i) satisfying: $0 < v_{m+1} < v_m < \tau_1^{m+1}$ $(m = 0, 1, \dots)$ and

$$A_m/(v_m-v_{m+1}) = \gamma ext{(constant)} \ (m=1,2,\cdots) ext{ where } A_m = \sum_{i=0}^{m-1} q_i^m (p_i^m-p_{i+1}^m)$$
 .

Define:

$$\sum_{m} (g) = \sum_{i=1}^{m} (\tau_i^m - \tau_{i-1}^m) g(\tau_i) - \gamma g(v_m)$$
.

Then the sequence $\sum_{m}(g)$ decreases monotonely for every convex function g, the limit being $\int_{0}^{1}g(t)dt-\gamma g(0)$, provided the partitions \varDelta^{m} tend to zero (in maximal diameter). A simple useful scheme satisfying our requirements is: $\tau_{i}^{m}=i/m(i=0,\cdots,m;m=1,2,\cdots),\,v_{m}=1/2m$. In this scheme $A_{m}=1/2m(m+1)$ and $\gamma=1$, hence for every function g convex on [0,1], the sums $\sum_{i=1}^{m}g(i/m)/m-g(1/2m)$ decrease monotonely to $\int_{0}^{1}g(t)dt-g(0)$.
