WILD ARCS IN THREE-SPACE 2: AN INVARIANT OF NON-ORIENTED LOCAL TYPE

An invariant of the oriented local type of a Fox-Artin arc has already been developed in the previous paper in this sequence. This paper is concerned with finding an invariant of the non-oriented local type of an arc whose only wild point is an endpoint, where the arc has penetration index at least five, and where the penetration index with respect to solid tori is equal to one.

This paper contains most of the results announced in §3 of [5], and forms the first chapter of the author's Ph. D. thesis [4], written under the supervision of Professor N. Smythe.

1. Preliminaries. Rather than work with 3-cells as in [6], our cutting and pasting arguments will be applied to sequences of solid tori, making use of the theorems of H. Schubert ([7], §§16, 17). The notations Bd , Cl , Int , $N(X)$, $\nu(k \cap X)$ are used as in [6].

1. k is an oriented arc in Euclidean 3-space R^3 (the orientation of R^3 is fixed), and k is tame except at the endpoint p .

2. A *handlebody of genus g* (Henkelkörper von Geschlechte g , [8], p. 219) is a tame closed regular neighbourhood of a wedge of g circles. If $g = 1$, such a handlebody is a solid torus (i.e., the topological product of S^1 with a 2-disc, called "Vollring" in [7]), and if $g = 0$ we have a 3-cell.

The *penetration index* $P_g(k, p)$ of k at p , relative to handlebodies of genus g , is the smallest integer n such that there exist arbitrarily small neighbourhoods of p which are handlebodies of genus g , each meeting k on its boundary in n points. When there is no danger of confusion, we write $P_g(k, p) = P_g$. (Note: It is not known whether $P_g(k, p)$ is the same as the penetration index of k relative to *surfaces* of genus g , as defined by B. J. Ball in [1]—cf. question 1 of [5].)

P_1 is called the toral penetration index; P_0 is called the 3-cell penetration index and is the "nice penetration index" defined by Henderson ([3], p. 470).

As in [6], we choose a 3-cell neighbourhood E_0 of p , chosen so that if $E \subset Int E_0$ is any other such neighbourhood, then $Bd E$ meets k in at least as many points as does $Bd E_0$.

Two arcs k_1 and k_2 have the same *non-oriented local type* at points p_1 and p_2 if there exist neighbourhoods U_i of p_i , and a homeomorphism

h of U_1 to U_2 which takes $(U_1 \cap k_1, p_1)$ to $(U_2 \cap k_2, p_2)$.

In these terms, then, the aim of this paper is to find an invariant of the non-oriented local embedding type of k in E_0 , if $P_1(k, p) = 1$ and $P_0(k, p) \geq 5$. In some cases, we may associate an infinite sequence of solid tori with k , and show that the cofinality class of the knot types (q.v., no. 4) of these solid tori is an invariant of the non-oriented local type of k at p . Analogous results have been obtained in [4] for arcs or simple closed curves with $P_1 = 2$ and $P_0 \geq 8$: for convenience, however, we shall restrict ourselves to arcs which are wild at an endpoint.

4. Let V be a solid torus. A *meridian* of $\text{Bd } V$ is a curve which bounds a disc in V but not on $\text{Bd } V$; such a disc will be called a meridian disc of V . A *longitude* of $\text{Bd } V$ is any curve on $\text{Bd } V$ which is nullhomologous in $\text{Cl}(R^3 - V)$ but not on $\text{Bd } V$; a *core* of V is a curve homologous in V to a longitude of $\text{Bd } V$. If λ is a longitude of V , we denote by $\kappa(V)$ the non-oriented knot type of λ , and say that V is knotted with knot type $\kappa(V)$.

Let U and V be solid tori with $U \subset V$. The *order of U in V* , denoted $O(U, V)$, is the minimum number of intersections of a meridian disc of V with a longitude of U (this integer depends on neither the longitude nor the meridian disc chosen). If $T \subset U$ is another solid torus, then

$$O(T, V) = O(T, U) \cdot O(U, V)$$

([7], p. 172 ff).

We write $U \prec V$ iff $O(U, V) = 0$, that is, if and only if U lies in a 3-cell in the interior of V .

The knot κ_1 is a *companion* of the knot κ_2 if a solid torus V_2 , such that $\kappa(V_2) = \kappa_2$, may be embedded with nonzero order in the interior of a solid torus V_1 with $\kappa(V_1) = \kappa_1$. κ_1 is a *factor* of κ_2 if V_2 may be embedded in V_1 with order one.

Two solid tori V_1, V_2 , with $V_2 \subset \text{Int } V_1$, are *concentric* if the closure of $V_1 - V_2$ is homeomorphic to $I \times \text{Bd } V_1$, where I is the unit interval. Theorem 3 of [2] asserts that V_1 and V_2 are concentric iff $\kappa(V_1) = \kappa(V_2)$ and V_2 has order one in V_1 .

5. A *k-torus* is a non-oriented tame closed solid torus $V \subset \text{Int } E_0$, which contains p in its interior, and meets k on its boundary in one point only, at which it is pierced by k .

A *containing sequence* (in E_0) for a k -torus V is a sequence of k -tori

$$V = V_n \prec V_{n-1} \prec \cdots \prec V_0 \subset E_0$$

with the property: if U is any k -torus, $V_i \subset U \subset V_{i-1}$, then either V_i

has nonzero order in U , or U has nonzero order in V_{i-1} . If $V_0 \subset U \subset E_0$, we require that V_0 have nonzero order in U . A containing sequence is of length n if $V = V_n$.

A *constructing sequence for k* (in E_0) is a sequence of k -tori $E_0 \supset V_0 \supset V_1 \supset V_2 \supset \dots$ such that $\bigcap V_i = p$, and for each i ,

$$V_i \prec V_{i-1} \prec \dots \prec V_0 \subset E_0$$

is a containing sequence for V_i .

A *k -sequence* is a constructing sequence with the further property that if V is a k -torus with $V_i \subset V \subset V_{i-1}$, and V has nonzero order in V_{i-1} , then V and V_{i-1} are concentric. V and V_{i-1} are equally knotted, therefore: thus a k -sequence is a constructing sequence in which the k -tori occurring are as "tightly knotted" (stärker verknøtet, [7], p. 211) as possible.

An example may help to highlight the difference between a constructing sequence and a k -sequence. The arc k of Figure 1(a) may

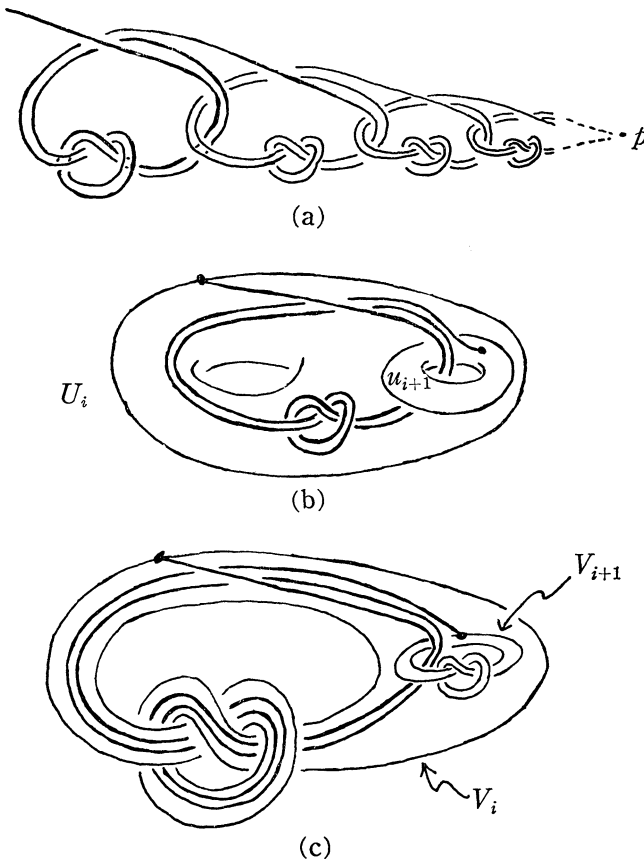

be constructed from solid tori placed in relation to each other and to k as shown in Figure 1(b). But one can replace U_i and U_{i+1} by solid tori V_i and V_{i+1} , as shown in Figure 1(c), to construct the same arc. A sequence of solid tori of the type of U_i, U_{i+1} will suffice to construct the arc, but will not be a k -sequence.

6. Two k -tori U and V are k -similar,¹ if there exists a pair of k -tori A_1 and A_2 , such that $A_2 \subset \text{Int}(U \cap V)$, $\text{Int} A_1 \supset U \cup V$, and A_2 has nonzero order in A_1 . We say that U is k -similar to V via the k -tori A_1 and A_2 .

We note that if U lies in the interior of V with nonzero order, then U and V are k -similar. Similarly, if U and V are k -similar via the k -tori A_1 and A_2 , then any two of U, V, A_1, A_2 are k -similar.

k -similarity is a reflexive and symmetric relation, but unfortunately is not transitive. In Figure 2, T and U are k -similar, U and V are k -similar, but T and V cannot be k -similar.

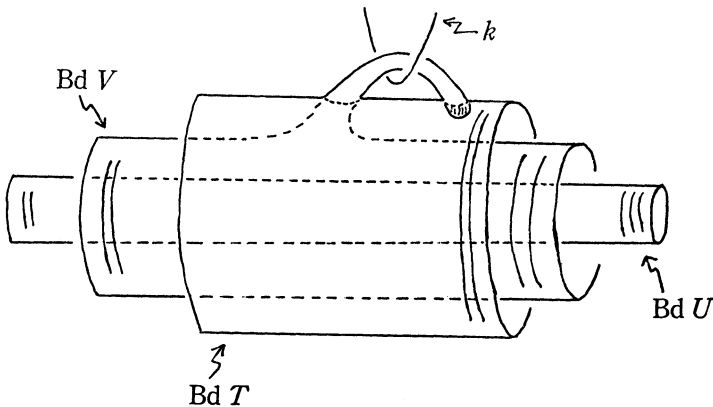

QUESTION (Fox). Is it possible to replace k -similarity by a transitive relation?

7. We come to two simple but important lemmas.

LEMMA 1. *If V is a k -torus, every meridian disc of V meets k in at least two points (we assume that our meridian discs do not contain p). If V is unknotted, every disc bounded by a longitude of $\text{Bd } V$ meets k in at least two points.*

Proof. Let D be a meridian disc of V . Then $V - \{\text{an open regular neighbourhood of } D\}$ is a 3-cell neighbourhood of p which meets k in

its boundary in $P_1 + 2N(k \cap D)$ points. Hence

$$P_1 + 2N(k \cap D) = 1 + 2N(k \cap D) \geq P_0 \geq 5,$$

and the first result follows. The proof of the second result is similar.

LEMMA 2. *Let U, B_1, B_2 be k -tori with $B_2 \subset U \subset B_1$, and let U^* be a k -torus which is k -similar to U via k -tori A_1 and A_2 , with $B_2 \subset A_i \subset B_1$. Then B_2 has nonzero order in U^* iff it has nonzero order in U , and U^* has nonzero order in B_1 iff U has nonzero order in B_1 .*

Proof. The numbers $O(U^*, A_1), O(U, A_1), O(A_2, U^*),$ and $O(A_2, U)$ are all nonzero. The result follows from the relations (cf. no. 4):

$$O(B_2, U^*) \cdot O(U^*, A_1) = O(B_2, A_1) = O(B_2, U) \cdot O(U, A_1)$$

and

$$O(A_2, U^*) \cdot O(U^*, B_1) = O(A_2, B_1) = O(A_2, U) \cdot O(U, B_1).$$

2. Some surgical lemmas. The following lemmas will be useful in our cutting and pasting arguments. In each, U and V are k -tori whose boundaries are in general position. We are also assuming that none of the curves of $\text{Bd } U \cap \text{Bd } V$ contains any points of k —this may be achieved by a small ambient isotopy of E_0 , if necessary.

LEMMA 3. *Let D and D' be discs on the boundaries of U and V respectively, such that $\text{Bd } D = \text{Bd } D'$, and suppose further that the interior of D does not meet the boundary of V . $D \cup D'$ is the boundary of a 3-cell S ; S does not contain p , and the solid torus V' is a k -torus, where*

$$V' = V \cup S \text{ if } D \subset \text{Cl}(E_0 - V)$$

$$V' = \text{Cl}(V - S) \text{ if } D \subset V.$$

Moreover, V and V' are equally knotted.

Proof. To show that S cannot contain p , we show that $N(k \cap \text{Bd } S) < P_0$. Now

$$\begin{aligned} N(k \cap \text{Bd } S) &= N(k \cap D) + N(k \cap D') \\ &\leq N(k \cap \text{Bd } U) + N(k \cap \text{Bd } V) = 1 + 1 < 5 \leq P_0. \end{aligned}$$

So $p \notin S$, and p must therefore lie in V' . If V' is to be a k -torus, we must show that $N(k \cap \text{Bd } V') = P_1 = 1$, and for this it is sufficient to show that $N(k \cap D) = N(k \cap D')$, because $\text{Bd } V' = D \cup (\text{Bd } V - D')$.

V' is a small torus containing p in its interior, so $N(k \cap \text{Bd } V') \leq$

$N(k \cap \text{Bd } V) = P_1(k, p)$; that is, $N(k \cap D) \geq N(k \cap D')$. We have two cases to consider:

$N(k \cap D) = 1$. Since $p \notin S$, $\nu(k \cap \text{Bd } S) = 0$. Now

$$\nu(k \cap \text{Bd } S) = \nu(k \cap D) + \nu(k \cap D') = \nu(k \cap D') \pm 1 = 0,$$

so $\nu(k \cap D') = \mp 1$. D' therefore meets k in an odd number of points; since D' is on the boundary of a torus which meets k in one point only, D' can contain at most one point of k . Hence $N(k \cap D') = 1 = N(k \cap D)$.

$N(k \cap D) = 0$. Then we have

$$\begin{aligned} 1 &\leq N(k \cap \text{Bd } V') = N(k \cap (\text{Bd } V - D')) + N(k \cap D) \\ &= N(k \cap (\text{Bd } V - D')) \leq N(k \cap \text{Bd } V) = 1; \end{aligned}$$

thus $N(k \cap (\text{Bd } V - D')) = 1 = N(k \cap \text{Bd } V)$, so D' contains no points of k . That is, $N(k \cap D') = 0 = N(k \cap D)$.

In both cases above, then, V' is a k -torus. In fact, V' and V are equivalently knotted, for there is an ambient isotopy h_t of E_0 which fixes everything outside an open regular neighbourhood of S , and takes V to V' .

Although $\text{Bd } V$ is in general position with respect to $\text{Bd } U$, $\text{Bd } V'$ is not, for the disc D is one component of $\text{Bd } U \cap \text{Bd } V'$. We may put the surfaces into general position by a small "push" in the appropriate direction: if $D \subset V$, take $V'' = V - \{\text{an open regular neighbourhood of } S\}$, and take $V'' = V \cup \{\text{a closed regular neighbourhood of } S\}$ if $D \subset \text{Cl}(E_0 - V)$. Then $\text{Bd } V''$ is in general position with respect to $\text{Bd } U$, and by requiring our regular neighbourhoods to be sufficiently small, we may ensure that V'' has the properties claimed for V' . It is in this sense that we will be applying Lemma 3.

LEMMA 4. *Let A and A' be annuli on the boundaries of U and V respectively, such that $\text{Bd } A = \text{Bd } A'$, and suppose further that the interior of A does not meet the boundary of V . If $A \cup A'$ is the boundary of a solid torus which contains p in its interior, then this torus V' is a k -torus.*

Proof. We need only show that k meets V' on its boundary in one point. Since $N(k \cap \text{Bd } V)$ is minimal, $N(k \cap \text{Bd } V') \geq N(k \cap \text{Bd } V)$, that is $N(k \cap A) \geq N(k \cap (\text{Bd } V - A'))$ (for, to obtain V' , we replaced the annulus $\text{Bd } V - A'$ on $\text{Bd } V$ by the annulus A). Thus we need only show that $N(k \cap A) = N(k \cap (\text{Bd } V - A'))$ —but this follows as in Lemma 3.

We may put $\text{Bd } V'$ into general position with respect to $\text{Bd } U$, by

taking $V'' = V' - \{\text{an open regular neighbourhood of } A\}$ if $A \subset V$, or by taking $V'' = V' \cup \{\text{a closed regular neighbourhood of } A\}$ if $A \subset \text{Cl}(E_0 - V)$. By requiring our regular neighbourhoods to be sufficiently small, we may ensure that V'' is a k -torus. It is in this sense that we will be applying Lemma 4.

LEMMA 5. *There exists a k -torus V^* with the properties:*

- (i) V^* and V are k -similar,
- (ii) $\text{Bd } V^* \cap \text{Bd } U = \emptyset$, and
- (iii) $\kappa(V)$ is a companion of $\kappa(V^*)$ (cf. §1, no. 4).

Moreover, if B_1 and B_2 are k -tori with $B_2 \subset \text{Int}(U \cap V)$, $\text{Int } B_1 \supset U \cup V$, then we may choose V^* so that $B_2 \subset \text{Int } V^* \subset V^* \subset \text{Int } B_1$.

NOTE. The essence of this lemma is that given two k -tori U and V , we can leave U fixed and cut around the boundary of V to obtain another k -torus V^* whose boundary does not meet $\text{Bd } U$; and all this may be done without moving $\text{Bd } V$ too far.

Proof. Let \mathcal{V} be the class of all k -tori T which are k -similar to V , $B_2 \subset \text{Int } T \subset T \subset \text{Int } B_1$, such that $\kappa(V)$ is a companion of $\kappa(T)$ and such that $\text{Bd } T$ is in general position with respect to $\text{Bd } U$. $V \in \mathcal{V}$, so \mathcal{V} is not empty; therefore there exists a k -torus V^* in \mathcal{V} whose boundary intersects $\text{Bd } U$ in fewer curves than does the boundary of any other $T \in \mathcal{V}$. We intend to show that $\text{Bd } V^* \cap \text{Bd } U = \emptyset$.

(a) Suppose some intersection curve is null-homologous on $\text{Bd } U$. We may choose one such curve, σ say, which bounds a disc D not containing any other intersection curves: $\text{Int } D \cap \text{Bd } V^* = \emptyset$. Either (i) $D \subset V^*$, or (ii) $D \subset \text{Cl}(E_0 - V^*)$.

(i) $D \subset V^*$. D cannot be a meridian disc of V^* , since such discs meet k in at least two points, by Lemma 1, and $N(k \cap D) \leq N(k \cap \text{Bd } U) = 1$. So σ must be null-homologous on $\text{Bd } V^*$.

(ii) $D \subset \text{Cl}(E_0 - V^*)$. If V^* is non-trivially knotted, σ must be null-homologous on $\text{Bd } V^*$, for a curve which is not nullhomologous on $\text{Bd } V^*$ cannot bound a disc in $\text{Cl}(E_0 - V^*)$. If V^* is unknotted, D cannot be a longitude disc, because such discs meet k in at least two points and D meets k in at most one point.

It follows in both cases that σ must also be null-homologous on $\text{Bd } V^*$, bounding a disc D' , say. $D \cup D'$ is the boundary of a 3-cell S , and we may apply Lemma 3 to obtain a k -torus V' with $\kappa(V') = \kappa(V^*)$, and whose boundary is in general position with respect to $\text{Bd } U$; in fact, $\text{Bd } V'$ meets $\text{Bd } U$ in fewer intersection curves than does $\text{Bd } V^*$, since the curve $\sigma = \text{Bd } D$ in particular has been eliminated. Also, we may choose our regular neighbourhoods of S (see the remark after Lemma 3) so that V' lies in the interior of B_1 , and contains B_2

in its interior. V' will be an element of \mathcal{V} if we can prove that V' and V are k -similar—the existence of this k -torus $V' \in \mathcal{V}$ will then contradict the minimality assumption involved in our choice of $V^* \in \mathcal{V}$. With this contradiction, we must conclude that no intersection curve is null-homologous on $\text{Bd } U$.

Suppose that V^* and V are k -similar via the k -tori A_1^* and A_2^* . Then after general positioning, $\text{Bd } V' \cap \text{Bd } A_i^*$ consists of a finite number of simple closed curves $\alpha_1, \dots, \alpha_s$, and we note that each of these curves lies in the interior of D . Thus each of the curves α_j is null-homologous on $\text{Bd } A_i^*$, by Lemma 1.

Note that $\text{Bd } V'$ does not meet $\text{Bd } A_2^*$ if $V' \supset V^* \cup S \supset V^*$, and that $\text{Bd } V'$ does not meet $\text{Bd } A_1^*$ if $V' \subset \text{Cl}(V^* - S) \subset V^*$. Thus we need only “adjust” the appropriate k -torus A_i^* to obtain a k -torus A_i such that V' and V are k -similar via A_1 and A_2^* or via A_1^* and A_2 , whichever is appropriate.

We may choose a curve, α_1 say, which bounds a disc $D(\alpha_1)$ on $\text{Bd } V'$, which contains no other “ α -curves”. Let $D'(\alpha_1)$ be the corresponding disc on the boundary of A_i^* ; then $D(\alpha_1) \cup D'(\alpha_1)$ is the boundary of a 3-cell $S(\alpha_1)$ not containing p . Using Lemma 3, we obtain a k -torus A'_i , which we put into general position with respect to $\text{Bd } V'$, so that

$$\text{Bd } A'_i \cap \text{Bd } V' \subset \text{Bd } A_i^* \cap \text{Bd } V' - \{\alpha_1\} .$$

We may eliminate all our α -curves in this way, and obtain a k -torus A_i . Clearly A_i will meet our requirements: for $i = 1$,

$$\begin{aligned} O(A_2^*, A_1) &= O(A_2^*, A_1^*) \neq 0, \text{ and} \\ A_2^* \subset \text{Int}(V' \cap V) &\subset V' \cup V \subset \text{Int } A_1 , \end{aligned}$$

while for $i = 2$, $O(A_2, A_1^*) = O(A_2^*, A_1^*)$, and

$$A_2 \subset \text{Int}(V' \cap V) \subset V' \cup V \subset \text{Int } A_1^* .$$

V and V' are therefore k -similar, and $V' \in \mathcal{V}$: we conclude that no curve of $\text{Bd } U \cap \text{Bd } V^*$ can be null-homologous on $\text{Bd } U$.

(b) Suppose some curve of $\text{Bd } U \cap \text{Bd } V^*$ bounds a disc on $\text{Bd } V^*$. Then interchanging U and V^* in the arguments a(i) and a(ii), it follows that this intersection curve also bounds a disc on $\text{Bd } U$, which we have shown in (a) to be impossible. Therefore no intersection curve bounds a disc on either surface.

Hence there is an even number of curves of $\text{Bd } U \cap \text{Bd } V^*$, bounding parallel annuli on $\text{Bd } U$ lying alternately inside and outside V^* , with similar annuli on $\text{Bd } V^*$. We may therefore choose two curves σ_1 and σ_2 which bound an annulus $A \subset \text{Bd } U$ which contains no other intersection curves and which lies entirely inside V^* . We will use

the theorems of H. Schubert ([7], §§16, 17).

(i) Suppose σ_1 is not a meridian of $\text{Bd } V^*$. By Satz 1, p. 207, A separates V^* into two solid tori T_1 and T_2 ; T_1 has nonzero order in V^* because it has σ_1 as a core, and T_2 has order 1 in V^* . $\kappa(V^*)$ (and therefore $\kappa(V)$) is a companion of both $\kappa(T_1)$ and $\kappa(T_2)$. We put $\text{Bd } T_1$ and $\text{Bd } T_2$ into general position with respect to $\text{Bd } U$, by taking $T_i^* = T_i - \{\text{an open regular neighbourhood of } A\}$. Then

$$(\text{Bd } T_1^* \cap \text{Bd } U) \cup (\text{Bd } T_2^* \cap \text{Bd } U) = \text{Bd } V^* \cap \text{Bd } U - \{\sigma_1, \sigma_2\} .$$

Now one of the tori, T_r^* say, contains p , and we may use Lemma 4 to show that T_r^* is a k -torus; moreover, we may choose a very small regular neighbourhood of A and so ensure that T_r^* contains B_2 in its interior. (Certainly $T_r^* \subset \text{Int } B_1$.) Also, we may modify the arguments of part (a) to show that V and T_r^* are k -similar, i.e. that $T_r^* \in \mathcal{Z}$.

But since

$$\text{Bd } T_r^* \cap \text{Bd } U \subset \text{Bd } V^* \cap \text{Bd } U - \{\sigma_1, \sigma_2\} ,$$

the existence of this $T_r^* \in \mathcal{Z}$ contradicts the minimality assumption involved in our choice of V^* . The curves of $\text{Bd } U \cap \text{Bd } V^*$ must be meridians of $\text{Bd } V^*$, therefore,

(ii) σ_1 is a meridian of $\text{Bd } V^*$. According to Satz 2, p. 211, A separates V^* into a solid torus $T(A)$ which shares a meridian disc with V^* , and which has order one in V^* (so $\kappa(T(A))$ has $\kappa(V^*)$ as a factor, and hence has $\kappa(V)$ as a companion); and another space which is a solid torus iff $T(A)$ and V^* are equally knotted. If p lies in $T(A)$, we may proceed as in part (i) above to eliminate the curves of $\text{Bd } A$ by putting $\text{Bd } T(A)$ into general position with respect to $\text{Bd } U$ —but then we would obtain a k -torus $T^* \in \mathcal{Z}$ which would contradict our choice of V^* .

We suppose therefore that p lies in $V^* - T(A)$. Let A' be the annulus on $\text{Bd } V^*$, bounded by σ_1 and σ_2 , such that A and A' together bound $\text{Cl}(V^* - T(A))$. Since $A \cup A'$ separates p from $\text{Bd } E_0$, and both annuli meet k in at most one point each, $k \cap (A \cup A')$ cannot be empty and in fact

$$1 \leq N(k \cap (A \cup A')) \leq 2 .$$

There are then three cases to consider:

$N(k \cap A) = 0, N(k \cap A') = 1$. In this case, the torus $T(A)$ does not meet k on its boundary at all, because $k \cap \text{Bd } V^* = k \cap A'$, and $\text{Bd } T(A) = A \cup (\text{Bd } V^* - A')$. But $T(A)$ and V^* share a meridian disc. By Lemma 1, there is therefore a subarc of k inside $T(A)$ which does not meet $\text{Bd } T(A)$ at all—since p is a point of k lying outside

$T(A)$, k must be disconnected. This is impossible, so this combination of intersection numbers cannot occur if p is to lie in $V^* - T(A)$.

$N(k \cap A) = N(k \cap A') = 1$. k is an arc which is wild at one endpoint, so $\nu(k \cap (A \cup A')) = \pm 1$; so k meets $A \cup A'$ in an odd number of points. This is impossible in this case, for $N(k \cap (A \cup A')) = 2$.

$N(k \cap A) = 1, N(k \cap A') = 0$. Let R be any other annulus on $\text{Bd } U$, bounded by intersection curves and whose interior lies in $\text{Int } V^*$, and let the annulus R' be chosen on $\text{Bd } V^*$ so that $R \cup R' = \text{Bd } (V^* - T(R))$, where $T(R)$ is the solid torus given by Satz 2, p. 211. k does not meet R at all, since R lies in the interior of $\text{Bd } U - A$ and $k \cap \text{Bd } U = k \cap A$. k can meet R' in at most one point: if $k \cap R' = \emptyset$, then p cannot lie in $V^* - T(R)$ and we may eliminate the curves of $\text{Bd } R$ by cutting V^* along R . If k meets R' in one point, then we have $N(k \cap R) = 0$ and $N(k \cap R') = 1$, which, we have shown above, implies that p must lie in $T(R)$. So again we may eliminate the curves of $\text{Bd } R$.

$\text{Bd } U \cap \text{Bd } V^*$ must therefore consist of only the two curves σ_1 and σ_2 . We set $A_1^* = \text{Cl } (\text{Bd } V^* - A')$, and $A_2 = \text{Cl } (\text{Bd } U - A)$. Since

$$A_2 \cap \text{Bd } V^* = \text{Bd } A_2 = \text{Bd } A = \{\sigma_1, \sigma_2\},$$

$A_1^* \cup A_2$ is the boundary of a solid torus V' (Satz 3, p. 215) which is easily shown to be a k -torus and k -similar to V . V' lies in the interior of B_1 , and contains B_2 in its interior; V^* has order one in V' . Therefore if V'' is a sufficiently small closed regular neighbourhood of V' , $V'' \in \mathcal{V}$ if we can prove that $\kappa(V)$ is a companion of $\kappa(V'')$ —we then note that $\text{Bd } V''$ does not meet $\text{Bd } U$ at all, so the existence of $V'' \in \mathcal{V}$ will contradict our choice of V^* .

Now σ_1 is not a meridian of $\text{Bd } U$, since it bounds a disc in V^* (the common meridian disc of V^* and $T(A)$, for example) which lies in $\text{Cl } (E_0 - U)$. σ_1 is not null-homologous on $\text{Bd } U$, by (a). Then by Satz 1, p. 207, A' separates U into two solid tori, one of which is $\text{Cl } (V' - V^*)$. By Satz 2, p. 211, therefore V' and V^* are equally knotted, so $\kappa(V'') = \kappa(V^*)$. Thus $\kappa(V)$ is a companion of $\kappa(V'')$ and $V'' \in \mathcal{V}$.

Therefore no intersection curve $\sigma \subset \text{Bd } U \cap \text{Bd } V^*$ can be a meridian of $\text{Bd } V^*$; σ cannot be null-homologous on $\text{Bd } V^*$, by (a), and cannot fail to be a meridian of $\text{Bd } V^*$, by (b)(i). The existence of any intersection curves at all leads to a contradiction, and we conclude that $\text{Bd } V^* \cap \text{Bd } U = \emptyset$ for this choice of $V^* \in \mathcal{V}$. This proves the lemma.

3. Containing sequences. Theorem 1 below will be of use later

in finding invariants of oriented local type for arcs with $P_1 = 1$ and $P_0 \geq 5$, as well as in this paper.

THEOREM 1. *Let V be a k -torus for an arc k in R^3 which is locally tame modulo one endpoint p at which $P_1(k, p) = 1$ and $P_0(k, p) \geq 5$, and let*

$$V = V_n \prec V_{n-1} \prec \dots \prec V_0 \subset E_0$$

and

$$V = U_m \prec U_{m-1} \prec \dots \prec U_0 \subset E_0$$

be two containing sequences for V in E_0 . Then $m = n$, and there exists a containing sequence

$$V = U_m^* \prec U_{m-1}^* \prec \dots \prec U_0^* \subset E_0$$

with the properties

- (i) $Bd U_i^* \cap Bd V_j = \emptyset$ for all $i, j = 0, 1, \dots, n - 1$ and
- (ii) for all i , $\kappa(U_i)$ is a companion of $\kappa(U_i^*)$, and U_i^* and U_i are k -similar.

Proof. The proof involves more complicated cutting and pasting arguments than the proof of Lemma 5, for instead of juggling two k -tori, we are juggling two sequences of k -tori simultaneously.

It is sufficient to prove that the assumption $n < m$ leads to a contradiction, for then a symmetric argument will show that it is impossible for m to be less than n .

Let \mathcal{M} be the class of all containing sequences

$$V = T_m \prec T_{m-1} \prec \dots \prec T_0 \subset E_0$$

of length m in E_0 , such that the surfaces $Bd T_i$ are in general position with respect to the surfaces $Bd V_j$, and for each i , U_i and T_i are k -similar and $\kappa(T_i)$ has $\kappa(U_i)$ as a companion. If δ is the minimum of the distances from $Bd U_i$ to $Bd U_{i+1}$, we may ensure that the sequence

$$V = U_m \prec U_{m-1} \prec \dots \prec U_0 \subset E_0$$

is an element of \mathcal{M} , by an ambient isotopy of E_0 which leaves everything fixed outside an open regular neighbourhood of $Bd U_0 \cup Bd U_1 \cup \dots \cup Bd U_{m-1}$, and moves no point further than $\delta/4$.

\mathcal{M} is not empty, therefore, and we may choose a sequence

$$V = U_m^* \prec U_{m-1}^* \prec \dots \prec U_0^* \subset E_0$$

in \mathcal{M} such that the set $C = \{Bd U_i^* \cap Bd V_j; i = 0, 1, \dots, m - 1 \text{ and } j = 0, 1, \dots, n - 1\}$ consists of a minimal number of intersection

curves. Our aim is to show that C is empty.

(a) Suppose some $\sigma \in C$ bounds a disc on $\text{Bd } U_i^*$, for some i ; then we may choose an innermost intersection curve τ which bounds a disc $D \subset \text{Bd } U_i^*$ containing no other intersection curves. Using Lemma 1 as in part (a) of the proof of Lemma 5, we see that τ also bounds a disc $D(\tau)$ on $\text{Bd } V_j$ if $\tau \subset \text{Bd } U_i^* \cap \text{Bd } V_j$. There exists an index h and a curve $\rho \subset \text{Bd } U_h^* \cap \text{Bd } V_j$ such that ρ bounds a subdisc $D(\rho) \subset D(\tau) \subset \text{Bd } V_j$, and such that $D(\rho)$ contains no other intersection curves in its interior. ρ also bounds a disc on the boundary of U_h^* .

Thus, if there is any curve which bounds a disc on a surface $\text{Bd } U_i^*$ or $\text{Bd } V_j$, there exists an index h and a curve $\rho \subset \text{Bd } U_h^* \cap \text{Bd } V_j$ which bounds a disc $D(\rho)$ on $\text{Bd } V_j$, not containing any other intersection curves, and bounding a disc D^* on $\text{Bd } U_h^*$.

$D(\rho) \cup D^*$ is a 2-sphere bounding a 3-cell S . Applying Lemma 3 (and general positioning), we obtain a k -torus U'_h with $\kappa(U'_h) = \kappa(U_h^*)$. $\kappa(U'_h)$ is therefore a companion of $\kappa(U_h)$, and we may also show, as in Lemma 5, that U'_h and U_h are k -similar. Moreover, for each s , $\text{Bd } U'_h$ meets $\text{Bd } V_s$ in fewer curves than does $\text{Bd } U_h^*$, for $\text{Bd } U'_h \cap \text{Bd } V_s$ consists of those curves of $\text{Bd } U_h^* \cap \text{Bd } V_s$ which do not lie in D^* —in particular, ρ has been eliminated. Thus the sequence

$$(*) \quad V = U_m^* \prec U_{m-1}^* \prec \dots \prec U_{h+1}^* \prec U'_h \prec U_{h-1}^* \prec \dots \prec U_0^* \subset E_0$$

meets $\{\text{Bd } V_j\}$ on its boundary surfaces in fewer curves than our original sequence $\{\text{Bd } U_i^*\}$. This will contradict our choice of the sequence $\{U_i^*\}$ if we can show that the sequence $(*)$ lies in the class \mathcal{M} ; it is only necessary to show that $(*)$ is a containing sequence for V .

Suppose $h = 0$, and let U be any k -torus with $U'_0 \subset U \subset E_0$. If $U'_0 \supset U_0^*$, then U'_0 has nonzero order in U because $\{U_i^*\}$ is a containing sequence in E_0 and $O(U_0^*, U'_0) = 1$. If $U'_0 \subset U_0^*$, there exists a k -torus U' which contains U'_0 , is k -similar to U , and whose boundary does not meet $\text{Bd } U_0^*$, by Lemma 5. By Lemma 2, $O(U'_0, U')$ and $O(U'_0, U)$ are zero or nonzero together: if $U' \subset U_0^*$, then

$$1 = O(U'_0, U_0^*) = O(U'_0, U') \cdot O(U', U_0^*)$$

so U'_0 has nonzero order in U' ; while if $U' \supset U_0^*$, U'_0 has nonzero order in U' because

$$O(U'_0, U') = O(U'_0, U_0^*) \cdot O(U_0^*, U') = O(U_0^*, U')$$

and U_0^* is the first term in a containing sequence in E_0 . In either case, U'_0 has nonzero order in U , and the sequence $(*)$ lies in \mathcal{M} .

Suppose $h > 0$. We need only consider the case $U'_h = U_h^*$ —(an open regular neighbourhood of S), the other case is analogous.

Let U be a k -torus with $U'_h \subset U \subset U_{h-1}^*$. By Lemma 5, there exists a k -torus U' , k -similar to U with $U'_h \subset U' \subset U_{h-1}^*$, and whose boundary does not meet $\text{Bd } U_h^*$. Then, by Lemma 2, $O(U'_h, U)$ and $O(U'_h, U')$ are either zero or nonzero together, and $O(U, U_{h-1}^*)$ and $O(U', U_{h-1}^*)$ are both zero or both nonzero.

If $U' \subset U_h^*$, U'_h has order 1 in U' because $O(U'_h, U_h^*) = 1$. If $U' \supset U_h^*$, then either U_h^* has zero order in U' and U' has nonzero order in U_{h-1}^* (because $\{U_i^*\}$ is a containing sequence), or $O(U_h^*, U') \neq 0$. Thus U either contains U'_h with nonzero order, or is contained in U_{h-1}^* with nonzero order, by Lemma 2. A similar argument shows that if U is any k -torus with $U_{h+1}^* \subset U \subset U'_h$ then either $O(U_{h+1}^*, U) \neq 0$ or $O(U, U'_h) \neq 0$.

It follows that $(*)$ is a containing sequence for V in E_0 , and its existence in \mathcal{M} contradicts the choice of our original sequence $\{U_i^*\}$, so we conclude that no $\rho \in C$ can bound a disc on any of the surfaces $\text{Bd } U_i^*$ or $\text{Bd } V_j$.

(b) For each pair i and j , therefore, there is an even number of intersection curves bounding parallel annuli on $\text{Bd } V_j$ and bounding parallel annuli on $\text{Bd } U_i^*$. We may therefore choose a pair of curves σ_1 and σ_2 which bound an annulus $A \subset \text{Bd } V_j$ which contains no other intersection curves, and such that $\text{Int } A \subset \text{Int } U_h^*$ for some h . Once again we shall use Schubert's theorems.

(i) σ_1 is not a meridian of $\text{Bd } U_h^*$. We apply Satz 1, p. 207: A separates U_h^* into two solid tori T_1 and T_2 . T_1 has nonzero order in U_h^* because it has σ_1 as a core, and T_2 has order 1 in U_h^* ; $\kappa(U_h^*)$ (and therefore $\kappa(U_h)$) is a companion of both $\kappa(T_1)$ and $\kappa(T_2)$. We put $\text{Bd } T_1$ and $\text{Bd } T_2$ into general position with respect to the surfaces $\{\text{Bd } V_s\}$ by setting $T_r^* = T_r - \{\text{an open regular neighbourhood of } A\}$. Then

$$(\text{Bd } T_1^* \cap \text{Bd } V_s) \cup (\text{Bd } T_2^* \cap \text{Bd } V_s) = \text{Bd } U_h^* \cap \text{Bd } V_s,$$

except when $s = j$, when

$$(\text{Bd } T_1^* \cap \text{Bd } V_j) \cup (\text{Bd } T_2^* \cap \text{Bd } V_j) = \text{Bd } U_h^* \cap \text{Bd } V_j - \{\sigma_1, \sigma_2\}.$$

Now one of these tori, say T_h^* , contains U_{h+1}^* in its interior. By Lemma 4, T_h^* is a k -torus and, as in Lemma 5, T_h^* is k -similar to U_h . Further, because T_h^* has nonzero order in U_h^* , $U_{h+1}^* \subset T_h^* \subset U_{h-1}^*$ and we prove, as in (a) above, that the sequence

$$V = U_m^* \prec \dots \prec U_{h+1}^* \prec T_h^* \prec U_{h-1}^* \prec \dots \prec U_0^* \subset E_0$$

in an element of \mathcal{M} . The k -tori in this sequence meet the surfaces $\{\text{Bd } V_j\}$ on their boundaries in fewer curves than do the k -tori in our original sequence $\{U_i^*\}$ (the curves $\{\sigma_1, \sigma_2\} = \text{Bd } A$ have been eliminated),

and this contradicts the minimality assumption involved in our choice of $\{U_i^*\}$.

(ii) Therefore, if the family C of intersection curves is not empty, the curves of $\text{Bd } U_h^* \cap \text{Bd } V_j$ must be meridians of $\text{Bd } U_h^*$. We will show that this is impossible.

We show first that $\text{Bd } V_j$ cannot meet $\text{Bd } U_{h+1}^*$ if it meets $\text{Bd } U_h^*$. For, if $\text{Bd } V_j \cap \text{Bd } U_{h+1}^*$ is not empty, its curves cannot bound discs on $\text{Bd } U_{h+1}^*$, by (a), and cannot fail to be meridians of $\text{Bd } U_{h+1}^*$, by part (i) above. Since the curves of $\text{Bd } V_j \cap (\text{Bd } U_h^* \cup \text{Bd } U_{h+1}^*)$ bound parallel annuli on $\text{Bd } V_j$, we may choose two curves α_h and α_{h+1} of $\text{Bd } V_j \cap \text{Bd } U_h^*$ and $\text{Bd } V_j \cap \text{Bd } U_{h+1}^*$ respectively, so that α_i is a meridian of $\text{Bd } U_i^*$, and so that α_h and α_{h+1} together bound an annulus on $\text{Bd } V_j$ whose interior lies in $\text{Int}(U_h^* - U_{h+1}^*)$. But Lemma 1 of [2] then shows that U_{h+1}^* must have order one in U_h^* , contradicting the assumption that U_{h+1}^* has zero order in U_h^* . This contradiction shows that $\text{Bd } V_j$ cannot meet $\text{Bd } U_{h+1}^*$ if it meets $\text{Bd } U_h^*$.

Nor can $\text{Bd } V_j$ meet $\text{Bd } U_{h-1}^*$ if it meets $\text{Bd } U_h^*$. We may choose two intersection curves α_h , which is a meridian of $\text{Bd } U_h^*$, and α_{h-1} on $\text{Bd } U_{h-1}^*$, which together bound an annulus on $\text{Bd } V_j$ whose interior lies in $\text{Int}(U_{h-1}^* - U_h^*)$. α_h and α_{h-1} are therefore homologous in U_{h-1}^* ; but α_h bounds a disc in U_{h-1}^* , so α_{h-1} is null-homologous in U_{h-1}^* . α_{h-1} is therefore either null-homologous on $\text{Bd } U_{h-1}^*$ or a meridian of $\text{Bd } U_{h-1}^*$ ([7], p. 164). By (a), α_{h-1} cannot bound a disc on $\text{Bd } U_{h-1}^*$, so α_{h-1} is a meridian of $\text{Bd } U_{h-1}^*$; this implies, by Lemma 1 of [2], that U_h^* has order one in U_{h-1}^* , which is impossible. Therefore no such curve α_{h-1} exists, and $\text{Bd } V_j$ cannot meet $\text{Bd } U_{h-1}^*$ if it meets $\text{Bd } U_h^*$.

If $\text{Bd } V_j \cap \text{Bd } U_h^*$ is not empty, it follows that $\text{Bd } V_j \subset \text{Int}(U_{h-1}^* - U_{h+1}^*)$. We may therefore use the same cutting and pasting techniques as were used in the last part of the proof of Lemma 5, to obtain a k -torus U'_h which is k -similar to U_h , such that $\kappa(U_h^*)$ is a factor of $\kappa(U'_h)$, and such that $\text{Bd } U'_h \cap \text{Bd } V_s = \text{Bd } U_h^* \cap \text{Bd } V_s$, except when $s = j$, when

$$\text{Bd } U'_h \cap \text{Bd } V_j = \emptyset .$$

We can also show (as in part (a)), that the sequence

$$(*) \quad V = U_m^* \prec \dots \prec U_{h+1}^* \prec U'_h \prec U_{h-1}^* \prec \dots \prec U_0^* \subset E_0$$

is a containing sequence in \mathcal{M} ; since the k -tori in this sequence meet the surfaces $\{\text{Bd } V_s\}$ in fewer curves on their boundaries than do the surfaces $\{\text{Bd } U_i^*\}$, the existence of this sequence in \mathcal{M} contradicts the minimality assumption involved in our choice of the sequence $\{U_i^*\}$. This contradiction ensures that $\text{Bd } V_j$ does not meet $\text{Bd } U_h^*$ at all.

(c) It follows from the above that the family C of intersection

curves must be empty, that is, that $\text{Bd } U_i^* \cap \text{Bd } V_j = \emptyset$ for all $i = 0, 1, \dots, m - 1$ and $j = 0, 1, \dots, n - 1$. We then have two containing sequences for V in E_0 , viz

$$V = V_n \prec V_{n-1} \prec \dots \prec V_0 \subset E_0$$

and

$$V = U_m^* \prec U_{m-1}^* \prec \dots \prec U_0^* \subset E_0$$

such that for each i and j , either V_j lies in the interior of U_i^* , or contains U_i^* in its interior.

U_m^* and V_n both equal V , so suppose V_{n-1} lies in the interior of U_{m-1}^* . Then

$$U_m^* = V_n \prec V_{n-1} \subset U_{m-1}^*,$$

so V_{n-1} has nonzero order in U_{m-1}^* because the $\{U_i^*\}$ form a containing sequence. On the other hand, if U_{m-1}^* lies in the interior of V_{n-1} , it has non-zero order in V_{n-1} , because the $\{V_j\}$ form a containing sequence. Proceeding in this way, we can show that for each $r = 0, 1, \dots, n$, either V_{n-r} has nonzero order in U_{m-r}^* , or U_{m-r}^* has nonzero order in V_{n-r} (whichever is applicable).

But $m - n \geq 1$ by hypothesis, so $O(V_0, U_{m-n}^*) \neq 0$ implies

$$V_0 \subset U_{m-n}^* \prec U_0^* \subset E_0,$$

which contradicts our choice of V_0 as the first k -torus in a containing sequence for V in E_0 . If U_{m-n}^* has nonzero order in V_0 , on the other hand, then V_0 must lie in the interior of U_{m-n-1}^* , and in fact have zero order in U_{m-n-1}^* —again contradicting our choice of V_0 .

The assumption $n < m$ therefore leads to a contradiction, and $n = m$.

4. Invariance of k -sequences. Theorem 2, p. 24 of [4], asserts that every arc with $P_1 = 1$ and $P_0 \geq 5$ has a k -sequence in some 3-cell E . Unfortunately, there are two errors in the proof of that theorem one the bald assertion that every such arc has a constructing sequence in some 3-cell, and the other a misuse of corollary 3 of [2]². The validity of Theorem 2 is therefore in doubt, and we are led to the following problems, for arcs with $P_1 = 1$ and $P_0 \geq 5$.

PROBLEM 1. Find sufficient conditions for an arc to have a constructing sequence in some 3-cell E . If possible, exhibit an arc which has no constructing sequences at all.

A set of sufficient conditions will be given in a later paper in this series, dealing with "special" arcs (cf. [4], Chapters III and IV).

PROBLEM 2. Does the existence of a constructing sequence imply the existence of a k -sequence?

The author suspects that Theorem 2 on p. 24 of [4] is still true, that is that every arc has a constructing sequence and therefore a k -sequence, but has been unable to turn his hand to a suitable proof.

It is worth noting, however, that if an arc k_1 has a k_1 -sequence $E_0 \supset V_0 \succ V_1 \succ V_2 \succ \dots$, and k_2 has the same nonoriented local type at p_2 as k_1 has at p_1 , then k_2 has a k_2 -sequence. For let h, U_1, U_2 be as in the definition of non-oriented local type (§1, no. 3). Since $\cap V_i = \{p_1\}$, there exists an index N such that $V_N \subset \text{Int } U_1$; let E_N be any 3-cell in the interior of V_N , which contains V_{N+1} in its interior. Then

$$h(E_N) \supset h(V_{N+1}) \succ h(V_{N+2}) \succ \dots$$

is a k_2 -sequence.

We come now to the invariance of k -sequences.

... be k -sequences in E_0 . Then U_i and V_i are equivalently knotted, for all i .

Proof. Given U_0 , there exists an index $s(0) = s$ and a k -torus V_s lying in the interior of U_0 . By Theorem 1, there exist $s - 1$ k -tori T_1, \dots, T_{s-1} such that

$$V_s \prec V_{s-1} \prec \dots \prec V_0 \subset E_0$$

and

$$V_s \prec T_{s-1} \prec \dots \prec T_1 \prec U_0 \subset E_0$$

are containing sequences for V_s in E_0 , and s k -tori $T_1^*, \dots, T_{s-1}^*, U_0^*$ such that

(i) $V_s \prec T_{s-1}^* \prec \dots \prec T_1^* \prec U_0^* \subset E_0$ is a containing sequence for V_s in E_0 ,

(ii) $\text{Bd } U_0^*$ does not meet $\text{Bd } V_j$ for any $j = 0, 1, \dots, s$, and

(iii) U_0^* and U_0 are k -similar, and $\kappa(U_0^*)$ has $\kappa(U_0)$ as a companion.

From (ii), it follows that either U_0^* lies in the interior of V_0 , or that $V_0 \subset \text{Int } U_0^*$. In the latter case, V_0 cannot have zero order in U_0^* , so $\kappa(U_0^*)$ is a companion of $\kappa(V_0)$, hence $\kappa(U_0)$ is a companion of $\kappa(V_0)$. If $U_0^* \subset \text{Int } V_0$, (i) shows that U_0^* has nonzero order in V_0 , so U_0^* and V_0 must be concentric because $\{V_j\}$ is a k -sequence. So $\kappa(U_0^*) = \kappa(V_0)$, by Theorem 3 of [2], and again $\kappa(U_0)$ is a companion of $\kappa(V_0)$.

On the other hand, we may use similar arguments to prove that $\kappa(V_0)$ is a companion of $\kappa(U_0)$.

It follows that $\kappa(U_0) = \kappa(V_0)$. We next observe that for some $s(1)$, $V_{s(1)}$ lies in the interior of U_1 : by exactly the same method, we show that $\kappa(U_1) = \kappa(V_1)$ and, proceeding inductively, that $\kappa(U_i) = \kappa(V_i)$ for all i .

The proof of the following theorem is similar to the proof of the main theorem of [6].

THEOREM 2. *Let k_1 and k_2 be arcs in R^3 , locally tame modulo endpoints p_1 and p_2 respectively, at which $P_1(k_i, p_i) = 1$ and $P_0(k_i, p_i) \geq 5$. If k_1 has a k_1 -sequence $U_0 > U_1 > U_2 > \dots$ in some 3-cell $E_0(1)$, and k_2 a k_2 -sequence $V_0 > V_1 > V_2 > \dots$ in some 3-cell $E_0(2)$, and k_2 has the same non-oriented local type at p_2 as k_1 has at p_1 , then the sequences $\{\kappa(U_0), \kappa(U_1), \dots\}$ and $\{\kappa(V_0), \kappa(V_1), \dots\}$ are cofinal.*

Unfortunately, the k -sequence is too unwieldy an invariant to be of much use in distinguishing nearly polyhedral arcs. A later paper will develop an invariant of oriented local type which is much simpler to apply than the k -sequence invariant, and we will show how these invariants may be used to distinguish wild arcs. Meantime, we merely assert that k -sequences will distinguish the arc of Figure 3 from the arc of Figure 1 (a).

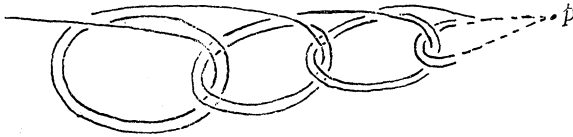

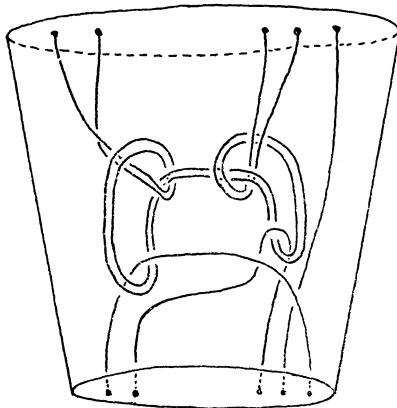

arc constructed in the Fox-Artin manner from cylindrical sections of the type shown in Figure 4, has $P_1 = 3$ but has penetration index 1 with respect to surfaces of genus 1.
